WHO MAY ENTER

Any individual who is a member of a state or federally recognized tribe and residing in North Carolina or a Native American who is a member of one of the following eight (8) state or federally recognized American Indian tribes: Coharie; Eastern Band of Cherokee; Haliwa-Saponi; Lumbee; Meherrin; Occaneechi Band of the Saponi Nation; Sappony; and Waccamaw Siouan, and living outside of North Carolina.

RULES

All quilts entered must be hand quilted (no machine stitched or pressure stitched).

Quilts may be individually pieced patterns, painted patterns or printed patterns.

One quilt per category per person may be entered for a total of three (3) quilts.

A "Quilt Documentation Form" must be completed and attached to each quilt. Please attach with safety pins.

Before the conference, quilts must be delivered to Brenda Moore or Carol Brewington by February 15, 2013.

Or they may be delivered on the morning (no later than noon) of February 28, 2013 at the conference.

Quilts may be picked up by owner or their designee on Friday, March 9, 2012 beginning at 5 pm.

All persons picking up a quilt must sign a form with their name, address, phone number and name of quilt owner.

CATEGORIES

Pieced and Stitched: This category will show quilts in which pieces are cut into individual sections sewn (by hand or machine) to form the squares or sections that form the quilt top.

Printed and Stitched: This category will show quilts in which the materials used for the top are either a pre-printed pattern or a painted pattern.

20 Years or Older: This category will show quilts that are 20 years old or older (no particular format for the design of the top).

AWARDS

One (1) overall "Best of Show" will receive a beaded ribbon.

Three categories (three each): 1st, 2nd, and 3rd place will receive beaded ribbons.

Three (3) Honorable Mention will receive a ribbon.
