

**Richard (Yogi) Crowe** 

The Richard (Yogi) Crowe Memorial Scholarship Fund was established to honor an Eastern Cherokee who struggled hard for his education and to encourage more Cherokee students to pursue graduate degrees.

Richard (Yogi) Crowe, a full-blooded Eastern Cherokee and a Vietnam veteran, attained his Master's Degree in Public Health from the University of Tennessee in Knoxville in 1982. Faced with the responsibility of supporting a family and being a diabetic, it was not an easy task to reach his goal. In 1982, Yogi Crowe became Director of the American Indian Recruiting Program for the School of Public Health at the University of North Carolina at Chapel Hill.

Yogi was killed instantly in an automobile accident on May 25, 1983 at the age of 36. He was the driving force behind many Eastern Cherokees going to graduate school and finishing. His encouragement at many times kept students in school. After Yogi's death, some of his friends wanted to honor him and continue the work he had started with encouraging tribal members to attend graduate and post-graduate school. The idea for the Richard (Yogi) Crowe Memorial Scholarship Fund was born and came into being in 1985. Never in his wildest dreams would Yogi have thought that the scholarship fund named in his honor would grow as it has and enable many tribal members to further their education.

2012 Annual Report To Contributors and Past Recipients

A Note from the 2012 President of Board of Directors By Dr. Reva Ballew

This year I was asked to serve as the President of the Richard (Yogi) Crowe Memorial Scholarship Fund Board of Directors. I was honored to be asked to serve in this position.

I have been involved with the Scholarship Fund since 1991. I began attending the University of Tennessee in the fall of 1991 in the Doctoral program in Clinical Psychology. I received funding from the scholarship throughout my time at UT. At that time 1991-1996 (pre-Harrah's Cherokee Casino), the tribal education department did not provide the amount of funding per student that they are able to provide today.

Since Richard (Yogi) Crowe had received his graduate degree at the University of Tennessee, there has been an agreement between the Scholarship Fund and the University providing a tuition waiver for one student per year from the Eastern Band of Cherokees. I utilized that tuition waiver during my fifth year of doctoral student. This allowed me to complete my full-time doctoral internship and complete my dissertation on time. I will always be grateful to the Scholarship Fund for the financial and emotional support they provided me in my PhD program.

During my time at UT, I became acutely aware of the lack of any other Native American students. This led me to focus and research issues related to Native American students attending college and graduate programs. When I had received my bachelor's degree from Western Carolina University in 1985, I was the first person in my immediate family to receive a college degree. When I received my master's degree in 1987, I was still the only person who had received a college degree.

From my research at UT about Native Americans and education, I became aware of the high dropout

rates for Native students beginning in high school. They were and are the highest for any population in America, almost 50%. I learned about the complex and historically dark history Native Americans have had with the educational system in America beginning with the Hampton Normal and Agricultural Institute in 1878. I wrote extensively about the beginnings of "Indian education" in formal government settings in my dissertation. My own education experiences and the history of other Native Americans with the formal educational settings made me aware of why so few Natives pursue or were successful in education, post high school or graduate schools. It also made me aware of how crucial it was for us as Native Americans to be successful in these settings to allow for choices and opportunities as individuals and as tribes.

When I completed my Doctoral in Clinical Psychology, I worked for the tribe beginning in 1996. I was and am the only Clinical Psychologist the tribe has. I was honored in 1999 to be asked to serve on the Richard (Yogi) Crowe Scholarship Fund of Board of Directors.

During my 14 years with the Scholarship Fund, I have had the opportunity to meet our enrolled members who are pursuing graduate degrees. Since I have been on the Board of Directors, I have seen 64 students funded in the amount of \$133,606. It is fulfilling to be involved in supporting our students. I enjoy meeting the new students and the future leaders of our tribe.

Even during these tough financial times we still have received support for the scholarship fund. I would encourage you to donate in what is an investment for the future of our tribe. No amount is too small, and we accept any type of donation.

#### **2012 Grant Recipients**

Nine students received \$12,175 from the Yogi Crowe Memorial Scholarship Fund, Inc. in 2012. The Scholarship Fund has funded 85 enrolled members of the Eastern Band of Cherokee Indians awarding a total of \$211,294.00 since its inception.

Jessica Crowe, daughter of Rex and Elizabeth Crowe of Candler NC, is in the Masters Program at the University of North Carolina at Charlotte. She is studying Social Work and plans to become a Youth-At-Risk Therapist. Jessica feels this program will be very rewarding, and she is looking forward to helping youth with social issues.

Angie Gunter is in the Masters of Education program at Western Carolina University with the goal of becoming a middle grade teacher. Angie loves working with this age of students and is employed at Swain Middle School as the Native American Counselor/Cherokee Language Teacher. She is the daughter of Patsy and the late "Chief" Henry Lambert and married to Frank Gunter. They have six children and six grandchildren.

Carolyn Luzene Hill is approaching the completion of her Masters in Fine Art degree at Western Carolina University. A sculpture she created was shown at the Museum of Arts and Design in New York City, part of "Changing Hands: Art without Reservation 3." ## Interview with Natalie Welch, Past Grant Recipient

1.) Tell us about your educational and career background.

I graduated from Cherokee High School in 2005 and attended the University of Tennessee (Go Vols!). While at the University of Tennessee, I studied Sport Management and Business while also starting the Native American Student Association on campus and being active with the Athletic programs. I graduated in 2009 and was accepted into the elite DeVos Sport Business Management Program at the University of Central Florida. This is a small cohort program that focuses on diversity, ethics, and leadership and provides a Masters in Business Administration and a Masters in Sports Administration. This program was life-changing for me and set me up to be successful in the sports business world.

After completing my MBA in January 2011, I began an internship at the Disney/ESPN Wide World of Sports working in Event Management to complete the Masters in Sports Administration. After completing that internship, I took an opportunity to work with the N7 Native American Program at Nike at the World Headquarters in Portland, OR.
