SEASONAL WILDLAND FIREFIGHTER - OPEN CONTINUOUS ANNOUNCEMENTS (OCA) Wildland firefighters serve an important role in the Bureau of Indian Affairs to serve and protect forest and range land assets held in trust for Native American Tribes. The Southwest Region is looking for a committed, hard working, and highly skilled workforce to serve on hand crews, engine crews, helitack crews, and Zuni Interagency Hotshot Crew. This OCA allows the acceptance of applications throughout the year. Applicants who are rated as Eligible will be placed on an OCA register and referred to a selecting official for consideration as vacancies occur during the OCA open period. The SECOND cut-off date for receipt/referrals of applicants to be considered for available vacant positions will be 03/31/14 . There will be other subsequent cut-off dates established based upon the date a request for a Certified List of Eligibles is received to fill other vacancies. Applicants with 10-point Veterans' Preference who submit a complete application after a cut-off date but before the Certified List of Eligibles is issued will be considered and referred on the Certified List of Eligibles, if qualified. The applicant period of eligibility will be for six (6) months. The application system Eligibility Begin Date will automatically be populated when your application is rated.
