



Annual Drinking Water Quality Report For 2014 Snowbird Water System

We're very pleased to provide you with this year's Annual Drinking Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is and always has been, to provide to you a safe and dependable supply of drinking water. Our water is pumped up out of the ground by two wells located across the creek from the Cornsilk Community Center. We are pleased to report that our drinking water is safe and meets all federal requirements.

The Snowbird Water System routinely monitors for contaminants in your drinking water according to Federal laws. This table shows the results of our monitoring for the period of January 1, 2014 to December 31, 2014.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Water Conservation: Our water resources are not unlimited – they are affected everyday by precipitation, population growth, economic development and pollution. The most cost effective way to protect our water resources is through conservation. Today, drinking water meets over a hundred different EPA standards for water quality.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can, come from gas stations, urban storm water runoff, and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

General Drinking Water Information:

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Additional Information Regarding Lead: In 1992 EPA created new standards for acceptable levels of lead and copper in drinking water. Elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing.

The Snowbird Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in home plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Immuno-compromised persons:

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. Parts per million (ppm) or Milligrams per liter (mg/L)	One part per million corresponds to one minute in two years or a single penny in \$10,000
Parts per billion (ppb) or Micrograms per liter (ug/L)	One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000
Action level (AL)	The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Maximum Contaminant Level Goal (MCLG)	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
Maximum Contaminant Level (MCL)	The highest level of a contaminant that is allowed in drinking Water. MCLs are set as close to the MCLGs as feasible using the best available
