WHEREAS: The Tribal Council of the Eastern Band of Cherokee Indians has

contributed a total of \$276,963.46 for the construction of Cable-

vision on the Cherokee Indian Reservation, and

WHEREAS: it as agreed upon by the Cherokee Cablevision that each and every

home on the Qualla Boundary would be served and cablevision would be installed in each home wanting to be served on the Qualla Boundary,

and

WHEREAS: several homes on the Qualla Boundary have been denied installation by

the Cherokee Cablevision while homes off the Qualla Boundary are

presently being served by the Cherokee Cablevision.

NOW THEREFORE BE IT RESOLVED by The Eastern Band of Cherokee Indians in Annual Council assembled at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians demand that the Cablevision honor its commitment and begin installing cablevision in homes on the

Reservation.

BE IT FURTHER RESOLVED that the Executive Committee is hereby authorized to carry

out the intent of this Resolution .
