





### **Interior to Develop New Tribal Consultation Policy**

#### **Action follows Obama's Nov. 5 Executive** Memorandum

WASHINGTON - The Department of the Interior has launched a new effort to develop a Department-wide policy on tribal consultation, Interior Secretary Ken Salazar and Assistant Secretary-Indian Affairs Larry Echo Hawk announced on Nov. 24. The new consultation policy will be developed with input from the nation's 564 federally recognized tribes.

"President Obama respects the inherent sovereignty of Indian nations and believes that the federal government must honor its commitments to American Indian and Alaska Native communities," said Secretary of the Interior Ken Salazar. "The President's Executive Order on consultation recognizes that the federal government has a responsibility to uphold not just a government-togovernment relationship with tribes, but a nation-to-nation relationship. That is why we are working to implement a consistent and comprehensive Department-wide tribal consultation policy and process upon which tribes can rely."

The effort announced last week is consistent with the requirements of an executive memorandum issued by President Obama on November 5 that directs all Federal departments and agencies to develop a "plan of actions" to implement the policies and directives of Executive Order 13175, Consultation and Coordination with Indian Tribal Governments, issued by President Clinton on November 6, 2000. President Obama signed the memorandum at the White House Tribal Nations Conference held at the Interior Department's headquarters in D.C.

"On November 5, President Obama issued his executive memorandum supporting tribal consultation

as 'a critical ingredient of a sound and productive Federal-tribal relationship'," Echo Hawk said. "The effort we are undertaking to develop Interior's plan as called for by the President will begin a new and positive chapter in the history of Federal-tribal relations."

President Obama has directed each agency head to submit to the Director of the Office of Management and Budget (OMB) within 90 days of the date of his memorandum a detailed plan of actions the agency will take to implement the policies and directive of Executive Order 13175. The Department is seeking tribal comments via email, regular mail and in real-time meetings by January 15, 2010, on questions asking what the parameters of a comprehensive Interior Department-wide consultation policy should entail.

Also announced on Nov. 24 is the preliminary schedule of Departmental tribal consultation meetings:

Construction on the expansion at Harrah's Cherokee Casino & Hotel is going well. "We currently have about 1,000 construction workers on property each day," said Charles Pringle, public relations with Harrah's Cherokee. "Yates Rentenbach has started working a second shift of workers now that the Events Center is getting enclosed." Pringle related that

Turner Construction is now pouring the 11th floor of the third Hotel Tower and Yates Rentenbach has begun erecting pre-cast on the final 1/3 of the new parking deck which will be eight stories when completed – it is on schedule for a May 2010 opening. "The Casino West Expansion

"The Casino West Expansion, the Motorcoach Lobby, Pavil-

lion conversion gaming space and Entertainment Lounge are all still on schedule for May 2010," said Pringle who also related that Turner Construction has started work on building a second skybridget which will connect the Hotel parking deck to the casino.

Each is employed by SCC's Extension Education Program and teaches at the Lyndon B. Johnson Job Corps Center in Franklin. Additionally, Ashe and Gunter received the Construction-Manager of Environmental, Safety and Health Certificate.

"We are tremendously happy to recognize Frank and Keith, as recipients of the C- MESH certificate," said North Carolina's Commissioner of Labor, Cherie Berry. "This program prepares managers for keeping their worksites safe and healthy, and that preparation improves employee protection and company productivity."

The C-MESH program is designed to increase the professionalism of environmental, safety and health managers of commercial, residential or governmental construction sites in North Carolina through a rigorous series of continuing education programs.

The MESH program strives to recognize environmental managers and raise industry standards and increase the value of these practitioners to their employers and others to whom their services are provided.

"The training received by these three instructors will greatly enhance the training provided to students enrolled in the Facilities Maintenance, Welding, and Cement Construction programs at the LBJ Job Corps," said Susan Mc-Caskill, SCC's vice president of extension education. All three individuals are certified to teach both the 10 and 30 hour Occupational Safety and Health Administration's construction safety courses. Ashe and Gunter are two of only 38 C-MESH certified individuals in North Carolina.




n his *Indian Country Today* perspective piece, "Free Speech: Another side of the

'Redskin' debate," Ron Toya showed much courage in an era and arena where opinions not in line with current cultural- or political-correctness are considered heresy, wherein the heretic is often condemned to having his status as an Indian stripped from him and is forced to wear, ala Hester Prine, the letter A (for "apple," of course). He becomes a colonized Indian; no longer a 'real' Indian.

Toya's statement brings the battle over culturalsensitivity into the arena

where it should have been a long time ago: Indian Country. And he is right that it is probably acceptable among the vast majority of people in Indian communities for a high school, college or professional team to use an Indiantheme in its name and emblem.

A friend of mine in the 1980s, when he would come to Washington on tribal business, always included in his itinerary a certain sporting goods store downtown. There he would buy several maroon baseball caps adorned with the Redskins logo – the profile of a warrior on a shield bedecked with eagle feathers. The caps were for people on

the Standing Rock Sioux reservation who gave him money to buy them.

But a growing number of people consider Native American-themed emblems and mascots demeaning, and insist that they be deemed against official regulations in sports, and perhaps even against the law. To illustrate

the cultural offensiveness of such mascots, one national Indian columnist recently wrote about a little Lakota boy whose mother found him weeping in front of the TV set. When asked why he was crying, he responded that he was hurt by the use of "Indians" by the Cleveland baseball team. The message the writer sent was that the child would be scarred for life because of the insensitivity of professional sports. (No mention was made if the mother told the boy to change channels or, better yet, turn the damn thing off.)

Perhaps we of the older generation are inured by colonization and opiated by Christianity, for we tend not to be bothered by those things.

I agree with Mr. Toya that the issue should not be as big or as time consuming as it is, and perhaps we should just try to understand the weird customs of the colonizers. First of all, we've got to recognize the importance of the name to a team's image, and the psychological effect it is supposed to have on opponents.

For instance, if the name of that famous university were in English instead of French, their famous victory march wouldn't "shake down

Even in the face of high unemployment numbers and a slowly recovering economy, North Carolinians have much to be thankful for this year. Our state is showing signs of recovering from this economic storm, and we will come out ahead. One of the most valuable resources of our state is the beauty and diversity of our natural environment. That's why it is so important that we work in the state government to protect these invaluable natural resources and promote North Carolina's tourism industry.

The following information highlights just some of the legislation and budgetary measures we implemented this year to support tourism in North Carolina.

A new state law creates the North Carolina Sus-

tainable Local Food Advisory Council (SB 1067 - S.L. 2009-530). One of the issues to be considered by the council is an in-depth analysis of the potential impacts that the production of sustainable local food would have on economic development in North Carolina, both the direct impacts for the producers of sustainable local food and the actual and potential indirect impacts, such as encouraging restaurants that feature locally raised agricultural products and promoting food and wine tourism.

The 2009 Studies bill directs the Joint Legislative Transportation Oversight Committee to study whether to require the Division of Motor Vehicles to place the North Carolina tourism Web site, visitnc.com, on the State's registration plates and whether to require all license plates issued by the Division of Motor Vehicles to have a



"First in Flight" background, including all specialized license plates (HB 945 – S.L. 2009-574).

Breweries are authorized to have tastings similar to those offered by wineries to help build the state's burgeoning local brewery industry under a new state law (HB 1591 – S.L. 2009-377).

A new state law creates the state Mountain Resources Commission, in part to protect the natural beauty of Western North Carolina and the associated tourism industry (SB 968 – S.L. 2009-485).

#### Budget

This year's budget included \$360,000 to reorganize Heritage Tourism into three regions (SB 202 – S.L. 2009-451). Each region will have one Heritage Tourism officer, and a Heritage Tourism Director will be located at the Department of Commerce. One additional position will coordinate the Blue Ridge Parkway 75th Anniversary. Three jobs cut.

The Wine and Grape Growers Council of North Carolina was allocated \$828,000 in this year's budget, and was transferred to General Fund support (SB 202 – S.L. 2009-451).

The North Carolina Aquarium Fund was allocated \$657,770 in recurring funds and \$551,436 in non-recurring funds in this year's budget (SB 202 – S.L. 2009-451). The money increases the operating budget for the North Carolina Aquarium Fund to reflect the transfer of the Aquarium's Special Activities and Events funds into this fund.

Because of the economic downturn, we were unable to do as much for North Carolina's tourism industry as we would have liked. There were reductions in spending to the Roanoke Island Commission, the state Maritime Museum, Tryon Palace and other state historic sites, as well as general cuts to the Department of Cultural Resources as a whole. Cultural Resources received a cut of nearly \$5.5 million, a reduction of about 7 percent, less than many other areas of state government. About 17 positions were eliminated. These cuts may result in fewer programs and less maintenance and upkeep at state-run tourist sites. When the economy recovers, we hope to restore some of these cuts and increase funding for state tourism sites across the board.

### **Thoughts on Native American Heritage Day 2009**

Sagoli Swakweku -Greetings from Washington, D.C.! Today, America is officially celebrating Native American Heritage Day 2009. From Indian Country, we thank President Obama, the Senate and the House for establishing this important national commemorative day.

People from all walks of life, native and non-native alike, are beginning to recognize Native American Heritage Day in many different ways. Schools have planned special curricula for children and traditional gatherings are being held throughout the country. Local and national museums, like the Smithsonian's National Museum of American Indians, are hosting special events, exhibits and films. These efforts are designed to emphasize the cultural and historical contributions of Native Americans to the United States. More importantly, Native American Heritage Day as a national holiday is an opportunity to educate the public about the true history and the rich culture, traditions and heritage of the First Americans.

As chairman of the National Indian Gaming Association, and a proud citizen of the Oneida Nation of Wisconsin, I greatly appreciate the efforts made today to better educate the general public on the heritage of tribes and

their communities. More importantly, I am profoundly grateful for the generations of dedicated tribal leaders who fought to maintain, strengthen and, in some cases, rebuild the way of life that was constantly threatened throughout the so-called assimilation process. These brave men and women leaders, representing all of our sovereign governments, along with the perseverance of Indian people throughout their communities, are responsible for keeping our heritage alive and passing it down to each successive generation despite the tremendous challenges and obstacles put before them.

Now that the day is here and being celebrated, what are we observing? We are observing the fact that upon the arrival of the European visitors, Native Americans were already harvesting the crops that today comprise two-thirds of the crops under cultivation worldwide as they greeted the Europeans with good faith, extending aid, peaceable accord and good will that set the table for the Thanksgiving holiday we celebrate every year.

Native Americans have made many contributions to our Nation and the World. The concept of zero in mathematics came from South American Indians. The democratic society we enjoy today was fashioned from the government of the Five Civilized Tribes and the Iroquois Confederacy, just two strong examples of democratic governments among the Native nations in America. Most Americans do not realize that the United States was created in the Native American spirit of independence, strength, adaptability and resilience.

Family values remain a strong asset to Native American people; they are at the core of our determination to survive. Native Americans wear their tribal affiliation like a badge, a symbol of courage, strength and survival. We continue to practice our own traditions, participate in the ceremonies of our ancestors and speak our languages. We go to community churches, serve in state governments and respect our non-Indian neighbors -- all indicia of good citizens. In this respect, it is clear that we are bi-cultural and maintain dual citizenships, which we regard as consistent with our treaties and the U.S. Constitution. The contributions of Natives to the American way of life are numerous, but Native people never sought praise, only respect as this nation's first sovereigns.

Native Americans have always answered the call of duty in the time-honored tradition of protecting this great country. In all of the combat zones across the globe, throughout history, and in every conflict long before they were citizens of the United States, our Native American warriors were fighting at the frontlines, in record numbers, fighting for the sacred ideal of protecting family, home and nation. Even today, these strong warriors of yesteryear continue to be proud veterans and are strong examples of their service at home through community service, education and dedication.

I encourage all to embrace this opportunity to promote the accurate story of the history of Native America and move this great nation away from the stereotypes and misinformation that have long misrepresented the story of a very proud, honorable and patriotic people.

Native Americans today carry the legacy of our ancestors and are taking the next step of teaching the generations of tomorrow about our survival, dedication and our many contributions. It is a credit to our previous generations that we have this opportunity. They sacrificed immensely to give hope for the dream of a better tomorrow. They envisioned self-determination and prosperity of life. We are the realization of that vision, and we must share the success and survival of the Native Americans with the rest of the world. We will continue in this generation and future generations to succeed and flourish.



### **Cherokee Students say NO to Tobacco**

Thursday, Nov. 19 was the Great American Smokeout and students in first grade at Cherokee Elementary, and the Cherokee Youth Center learned what smoking can do to you body and how uncool smoking tobacco is.

Tobacco use in adolescence is associated with many other health risk behaviors, including higher risk sexual behavior and use of alcohol or other drugs. Tobacco is found in cigarettes, cigars, and chewing tobacco. All forms of tobacco contain a dangerous drug called nicotine. Nicotine is very addictive-once you start smoking or chewing tobacco, you get hooked quickly. Smoking one cigarette takes away 11 minutes of your life.

It makes your breathe, hair and clothes stink, your teeth can turn yellow, and it harms your heart and lungs.

Smoking accounts for over 400,000 deaths in the United States each year, and is a major risk factor for the four leading causes of death: heart disease, cancer, stroke, and chronic obstructive pulmonary disease. Native Americans are at great risk of suffering from tobacco-related death and disease because they are the highest prevalence of tobacco use compared to any other population group in the United States.

Our youth thinks it makes them look cool by using tobacco but overtime it does a lot of damage to their bodies. It's important as parents/guardians we teach our children how harmful tobacco is.

He died December 30, 1970 at the age 79.

In his will Mr. Ferebee stated that "one of the great interests of my life has been promoting the cause of higher education in North Carolina and in assisting and encouraging worthy and talented young people to attain college, university, and graduate school educations."

#### **Smoked Trout Hash with Mustard Greens**

If you prefer a milder green, substitute mature spinach or chard. Make it a Meal: Lay a poached egg on top and serve with sliced tomatoes and cracked pepper.

Note: Look for precooked diced potatoes in the refrigerated section of most supermarket produce departments-near other fresh, prepared vegetables.

#### **Ingredients**

• 2 tablespoons extra-virgin olive oil

• 1 pound precooked diced red-skinned potatoes, (about 2 1/2 cups; see Note)

- 2 tablespoons whole-grain mustard
- 2 tablespoons cider vinegar
- 1/8 teaspoon salt, or to taste
- 1/8 teaspoon freshly ground pepper
- 4 ounces smoked trout, skin removed, flaked
- 4 cups thinly sliced mustard greens

#### **Preparation**

1. Heat oil in a large nonstick skillet over medium-high heat. Add potatoes and cook, stirring occasionally, until golden and crispy, adjusting heat if necessary to prevent burning, 8 to 12 minutes. 2. Whisk mustard, vinegar, salt and pepper in a small bowl. Add to the potatoes along with trout and greens. Cook, stirring, until the greens are just wilted, 30 seconds to 1 minute. Remove from heat; stir 1 to 2 tablespoons water into the hash if it seems dry. Serve hot.

1. To make streusel: Stir together brown sugar, 2/3 cup flour and cinnamon in a medium bowl. Sprinkle in apple juice concentrate and oil and blend with a fork or your fingers until crumbly.

2. To make cake: Puree pears in a food processor or blender. Transfer to a wide saucepan and cook over medium-low heat, stirring almost constantly, until reduced to 1/2 cup, 8 to 10 minutes. Transfer to a large bowl and let cool completely.

3. Preheat oven to 350°F. Coat a 9-by-13-inch baking dish with nonstick cooking spray.

4. Melt butter in a small saucepan over medium heat. Cook, swirling the pan, until the butter turns a light nutty brown, about 1 minute. Whisk into the pear puree. Add sugar, egg, egg white, oil and vanilla, whisking until smooth.

5. Sift together 2 1/4 cups flour, baking powder, baking soda and salt; add to the pear mixture alternately with yogurt (or sour cream).

6. Spread half of the batter in the bottom of the prepared pan. Top with cranberries, then the remaining batter. Sprinkle the streusel over the top. Bake until a cake tester inserted in the center comes out clean, 40 to 45 minutes. Serve warm.

#### **Roasted Onion Soup**

Sweet caramelized onions, bolstered by roasted shallots and garlic, combine in a luscious, but not overpowering soup.

#### **Ingredients**

- 3 Spanish onions, cut in half lengthwise and thinly sliced
- 3 large shallots, cut in half lengthwise and thinly sliced
- 1 large head garlic, cloves separated, peeled and cut in half
- 2 teaspoons extra-virgin olive oil
- 4 cups reduced-sodium chicken broth, divided
- 1/4 cup brandy
- 1 tablespoon chopped fresh thyme
- Salt, to taste
- Freshly ground pepper, to taste

• 1/4 cup freshly grated Parmesan cheese, preferably Reggiano **Preparation** 

1. Set oven rack at the lowest level; preheat to 450°F.

2. Combine onions, shallots, garlic and oil in a large shallow roasting pan. Roast, stirring every 5 minutes, until the onions are golden, 20 to 25 minutes. Remove from the oven and pour in 1 cup of the broth; stir, scraping the bottom of the pan to loosen and dissolve any caramelized bits. (The liquid will become quite dark.)

3. Transfer the onion mixture to a soup pot and add brandy, thyme
