Tribal members vote a resounding "no" on alcohol

BCI tribal members went to the polls on Thursday, April 12 and voted a resounding "no" on three referendum questions dealing with the sale of alcoholic beverages on trust lands of the Tribe.

Turnout was relatively low with 2,517 ballots cast out of 6,715 eligible voters for a 37.48 percent voter participation. Painttown Community had the highest voter participation with 44.98 percent and Cherokee County had the lowest at 11.69 percent.

Tribal members voted against having a Tribal ABC Store (1499 to 1005), against alcohol sales in restaurants (1498 to 995) and against alcohol sales in grocery stores (1640 to 851). Question four dealing with allowing individual townships the ability to call for a special referendum to vote out alcohol in their township narrowly passed (1259 to 1220).

"Obviously, we're all glad it's over with," said Principal Chief Michell Hicks. "There was a lot of anticipation and a lot of opinions on the issue. But, what I am most thankful for is that we have a formal process now."

"Whether you agree with it or not, we have a referendum process and obviously it works," he continued. "The people have spoken now. We know what our opportunities are and what our limitations are and we'll move forward based on what we now understand. Obviously, there are positives and negatives to the issue and there always will be. There will be future generations that have to deal with it just like this one did. Again, I'm glad it's over with. The message is very clear, and I just want to thank our public voters for getting out and letting us know how they feel."

All results are unofficial and will remain so until certified by Tribal Council during their May session.

"Obviously, based on the results of the vote, the residents of Cherokee do not wish to have alcohol available here and have felt this way for a long time," said Matthew Pegg, Cherokee Chamber of Commerce executive director. "With that, we need to look at ways to develop our destination to attract and keep tourism dollars here in Chero-

kee."

"Not having alcohol in Cherokee, outside of Harrah's, will not stop us from working hard to attract tourists to visit. Along with the Cherokee Chamber of Commerce, there are many organizations including the EBCI Travel and Tourism Department, Fish and Wildlife Management Team, Greater Cherokee Tourism Council, Sequoyah National Golf Course, and many others that still got up this morning and went to work with intent on bringing visitors to Cherokee."

Bob Blankenship, former TABCC chairperson, related, "The people have had the chance to express their view and that is what we all must abide by."

Debbie Sexton, a member of the Cherokee Church of Christ, related, "There are good arguments for both sides of the issue of how alcohol could help boost the economy, but what I do feel good about is that the people have stood up to voice their stand that they need to stay true to their elder's beliefs that alcohol will ultimately only cause unhappiness."

Memory Care unit opens at Tsali Care

Unit is first of its kind in Indian Country

sali Care Center hosted a historic event on Monday, April 16. The Center held a ribboncutting and official opening of its new Memory Care Unit, the first facility of its kind in all of Indian Country.

The 12-bed facility will be for those patients suffering from Alzheimer's and any kind of dementia. Funding for the renovation work to the facility was provided by a \$650,000 HUD community development grant and \$125,000 from the Eastern Band of Cherokee Indians.

"We are very excited," said Vickie Bradley, EBCI deputy health officer who thanked tribal leadership for their support of the project. "All of you got behind it and pushed it, and it's come to fruition. We have 12 beds and we are full as we open."

"What a wonderful day for our community that we can keep our elders here, and we don't have to send them out anymore," added Bradley who gave accolades to the Tsali Care Center staff. "All of the staff have just done a tremendous job in preparing, training, hiring and getting ready for these patients."

Principal Chief Michell Hicks said the statistics available on Alzheimer's are alarming. "It's something that we all need to be aware of within our families, and I'm glad to see that, through all the turmoil that us, as tribal leaders, sometimes have to deal with there's always a blossom out there, and that's what you work for. I'm just glad to know what we've accomplished. Thank you to all the staff that have been involved and thank you Tribal Council for your leadership."

"We don't always get it right," Chief Hicks said, "but, on days like today, we get it right."

Yellowhill Rep. David Wolfe, who serves as the chairman of the Health Board, commented, "This is an initiative that we've spent a great deal of time on to come up with funding to serve our elders. We'd like to keep them all here, and that's what we strive to do"

for the Alzheimer's Association Western Carolina Chapter office in Cherokee, gave some of the latest facts and figures on Alzheimer's to the crowd. "5.4 million people in the United States have Alzheimer's right now. If we were to take all of the people with Alzheimer's and dementia and their caregivers and put them in one state, it would be the fifth largest state in the United States."

"It's the sixth leading cause of death," she said. "It moved in one year from the seventh to the sixth. It is the only disease on the list that cannot be cured, prevented or stopped. Since 2000, it has rose 66 percent among our population while other types of diseases like cancer and different deadly diseases dropped."

Dotson said she is very excited about the opening of the new facility. "People with Alzheimer's disease need these specific types units. A lot of times it's great for them to be together and interact. So, I'm just really excited about this."

Course

Instructors and Program



Injunction on alcohol referendum denied

EBCI tribal members went to the polls on Thursday, April 12 to vote on the four measures comprising the alcohol referendum. Some felt the referendum was in violation of Tribal law. Peggy Hill-Kerbow, on behalf of herself and 14 other EBCI tribal members, filed a Complaint and Request for Injunctive Relief in Tribal Court on Tuesday, April 10. That injunction was denied in a Memorandum Order issued on Wednesday, April 11 by Associate Judge J. Matthew Martin.

The following were named as defendants in the complaint: Eastern Band of Cherokee Indians, the EBCI Tribal Council Representatives, EBCI Election Board, Tribal Alcoholic Beverage Control Commission (TABCC) and Principal Chief Michell Hicks.

The complaint alleged that "defendants chose to ignore Tribal Law Cherokee Code Chapter 161-9 Referendum/Initiatives and passed the Resolution to hold a referendum vote on April 12, 2012 the same of alcoholic beverages on Tribal Trust Lands."

It also alleged that the TABCC has acted "over and beyond their realm of authority".

The plaintiffs were asking for a complete halt to the referendum as well as the Court to find "the defendants have engaged in conduct that violates Tribal Law".

In his order, Judge Martin wrote, "CC (Cherokee Code) Section 161-16(d) provides the burden of proof: 'Any person filing a protect for election irregularities under Subsection 161-16(c) must establish during a hearing in front of the Board of Elections that the alleged irregularities unfairly and

improperly or illegally affected the actual outcome of the election."

"In this matter, the Plaintiffs allege that the conduct of the election itself will result in an illegal outcome," he wrote.

He said that the plaintiffs may file a protest of irregularities with the Election Board. "In light of this, the Court should not grant an injunction," Judge Martin wrote. "The Court notes that the Plaintiffs did not request a hearing on this issue and that it appears from the file that some of the Defendants have not yet been served with process in this case. The Court has dispensed with oral argument of this issue inasmuch as the result is clear from the Complaint and the relevant law and argument would not aid in the decisional process."

- Norovirus is a highly contagious illness caused by infection with a virus called norovirus.
- It is often called by other names, such as viral gastroenteritis or stomach flu. It is also called food poisoning, although it may not always be related to food. Norovirus is not related to the flu (influenza) which is a respiratory illness caused by the influenza virus.
- Norovirus causes acute gastroenteritis which is an inflammation of the stomach and intestines
- Symptoms of norovirus include diarrhea, vomiting, nausea, and stomach nain
- Anyone can get norovirus, and they can have the illness multiple times during their lifetime.
- Norovirus illness can be serious
- Norovirus can make people feel extremely ill and vomit or have diarrhea many times a day.
- Most people get better within one to two days.
- Norovirus can be very serious among young children, the elderly, and people with other illnesses, and can lead to severe dehydration, hospitalization and even death.
- Norovirus is highly contagious
- Noroviruses spread quickly from

person to person.

- Outbreaks of infection are common in crowded, closed places such as hospitals or long-term care facilities, daycare centers, schools, hotels, and cruise ships.
- People with norovirus are contagious from the moment they begin feeling ill to at least three days and perhaps for as long as two weeks after recovery.

How noroviruses are spread

Noroviruses are found in the stool and vomit of infected people, and on infected surfaces that have been touched by ill people. People can become infected by:

- Eating food or drinking liquids that are contaminated with norovirus.
- Touching surfaces or objects that are contaminated with norovirus, and then touching their own mouth, nose, or eyes.
- Having direct contact with an infected person; for example, by shaking hands, sharing food or eating from the same utensils, or caring for someone who is ill with norovirus infection.

 Not washing their hands before preparing food or eating or after using the bathroom or changing diapers.
 Prevent the spread of norovirus

Wash your hands often and well:
Wash your hands carefully with
soap and water, especially before
preparing or eating food, using
the restroom or changing diapers. Alcohol-based hand sanitizers are not a substitute for
washing with soap and
water.

Precautions in the kitchen

Always wash fruits and vegetables, and cook oysters and other shellfish thoroughly before eating them.

Do not prepare food if you

are sick: People who are infected with norovirus should not prepare food for others while they have symptoms and for three days after they recover from their illness.

Clean and disinfect contaminated surfaces thoroughly: After an episode of illness, such as vomiting or diarrhea, immediately clean and disinfect contaminated surfaces by using a bleachbased household cleaner as directed on the product label or a 1:10 solution

by mixing 1/4 cup of bleach to 2 1/4 cups of water. Bleach is very caustic and emits potentially lethal fumes, so it should never be used full strength; mix in a well-ventilated area and use caution to prevent splashing.

Wash laundry thoroughly: Immediately remove and wash clothing or items that may be contaminated with vomit or fecal matter. Handle soiled items carefully. Wash laundry with detergent for the longest cycle time available and then machine dry.

No specific treatment or vaccine for norovirus infection

- There is no vaccine to prevent infection with norovirus.
- There is no specific drug available to treat people with norovirus illness.
- Antibiotics will not help you if you are sick from the virus. This is because antibiotics fight against bacteria, not viruses
- Rehydration is important for infected people—they must drink plenty
 of liquids to replace fluid lost through
 vomiting and diarrhea. In some cases,
 fluid may need to be given intra-

- 7. Upon proper notice and hearing and a finding based upon the criteria set out in N.C. Gen. Stat. § 7b-1111, terminate the parental rights of the respondent parent.
