


#### Parks as Classrooms



# **Oglala Sioux** named BIA Head

**Echo Hawk names** Michael S. Black to **BIA Director Post**

WASHINGTON, D.C. - Assistant Secretary-Indian Affairs Larry Echo Hawk announced on Monday, April 26 that he has named Michael S. Black as Director of the Bureau of Indian Affairs.

Black, an enrolled member of the Oglala Sioux Tribe in South Dakota, had been serving as the acting BIA Director since March 18, 2010. He takes over from Jerold L. "Jerry" Gidner who is now the

"Mike Black served Indian

Country and the nation as a dedicated public servant for many years," Echo Hawk said. "I will rely on him as part of my senior management team as we move forward on initiatives to improve public safety and employment opportunities in tribal communities, promote tribal self-determination through energy and economic development, and honor the trust responsibility."

"I am pleased with Assistant Secretary Echo Hawk's efforts to strengthen his management team with the selection of Michael Black as BIA Director," Interior Secretary Ken Salazar said. "I am confident that this change will enable Assistant Secretary Echo Hawk to continue moving forward in carrying out our initiatives to improve the lives of the American Indian and Alaska Native people."

Prior to becoming acting BIA director, Black had served since July 20, 2008, as Regional Director of the BIA's Great Plains Regional Office in Aberdeen, S.D., following an eight-month appointment starting in June 2007 as the acting regional director. The office oversees 12 agencies serving 16 federally recognized tribes in Nebraska, North Dakota and South Dakota.

Black began his federal career in 1987 with the BIA's Aberdeen Area Office (now the Great Plains Regional Office) as General Engineer in the Branch of Facilities Management. From 1992 to 2001, he

worked in the BIA's Billings Area Office (now the Rocky Mountain Regional Office) as Regional Facility Manager where he was responsible for facilities construction and operations

> "I am deeply honored to have been offered this opportunity to lead the Bureau of Indian Affairs," Black said. "I want to express my appreciation to Assistant Secretary Echo Hawk for his confidence and to affirm my commitment to strengthening the BIA's mission of service to Indian Country."

> The Director of the Bureau of Indian Affairs is responsible for managing the BIA's day-to-day operations through four offices - Indian Services, Justice Services, Trust Services and Field Operations – which administer or fund tribally based infrastructure, law enforcement, social services, tribal governance, natural and energy resources and trust management programs for 564 federally recognized American Indian and Alaska Native tribes in 33 states through 12 regional offices and 85 agencies.

# IT'S OPEN!

### I-40 officially re-opens after major Rock Slide

**HAYWOOD COUNTY** – It's

open! The portion of Interstate I-40, closed since Oct. 25, 2009 due to a major rock slide, is now open for traffic. The interstate officially re-open on Sunday, April 25 at 6pm, and a ceremony was held to mark the event at the Welcome Center near the North Carolina - Tennessee border in Haywood County on Tuesday, April 27.

NCDOT related the total cost for the project is around \$12.9 million and officials said in a statement that the federal government would "reimburse" the state for almost all of that amount.

"I want to thank everyone who's worked on this project," said Jon Nance, NCDOT chief engineer who called it a "very complex type project."

He went on to say, "This project was extremely challenging given the terrain and the high traffic volumes that depend on this route."

Conrad Burrell, NC Board of Transportation, commented, "I know firsthand the hardship the citizens and businesses of this area have endured as we've worked to reopen this highway. I-40 is a lifeline for this region, and it was greatly impacted during some of the busiest times of the year."

Mary Jane Ferguson, director of EBCI Marketing and Promotion was especially happy to see the interstate reopened.

"We are delighted the section of I-40 that has been closed since October 2009 has now reopened," she said. "It is especially welcomed at the beginning of seasonal visits to Western North Carolina and to Cherokee. Having I-40 West open will allow the leisure travel to choose the closest route to come visit all that Cherokee, NC has to offer. We look forward to those visits to Cherokee. We want our visitors to know they will be greeted with a warm welcome as it has been a long win-

According to the NCDOT, "55,000 cubic yards of rock were removed comprising 7,000 truck loads of material which would cover about 37 football fields in a 1-foot layer of rock."

A total of 540 rock bolts were installed to help stabilize the area.

Trucks hauling wide loads (those over 12 feet wide) are still restricted from the route. According to information from the NCDOT, "Wide loads traveling on I-40 West will continue to use the detour in place since the road was closed: take Exit 53B (I-240 West) in Asheville and follow I-240 West to Exit 4A (I-26 West). Follow I-26 West to I-81 South in Tennessee, back to I-40."

#### LET'S SET THE RECORD STRAIGHT!

It has always been my personal policy not to engage in any negative campaigning. It's important to me to be positive and to run on my record and with integrity. That is still my policy and l won't spend time discussing any other candidates. However, many of my supporters have urged me to respond to some of the allegations that are circulating through the County and have appeared in

- The Jackson County Board of Commissioners asked for, paid for, and received the results for the Mercer Group Study for all County employees. The Commissioners then implemented the recommendations of the Mercer Group for ALL County employees. I do not have the ability or authority to give myself an increase in salary. Salaries in County government are based upon position, responsibilities, education, experience, and years of service. This was a County-wide decision made solely by the Jackson County Board of Commissioners to retain qualified and experienced employees. The County Commissioners are solely responsible for the overall County budget and delegating those funds as they deem appropriate. I will continue to make requests to the Commissioners during the budget process to further expand our resources upon citizens' requests and my own professional
- I did get involved in the Strathmore Who's Who Program and did use \$1283 of taxpayers dollars for the application fees. I realize my mistake and have paid back in full the total amount to the Jackson County Finance Office out of my own pocket two months ago. Confirmation of this action can be found in the Finance Office's records.
- · Unauthorized Substance Taxes are generated by the arrest and conviction of felony drug dealers. 75% comes back to the arresting agency and 25% goes to the State of North Carolina. The General Statutes allow these monies to be used to "deter and investigate drug crimes". I put back into the community what the drug dealers have taken away. All monies are taken from convicted felony drug dealers. Programs that I contributed to were to better the community and support the youth. I have chosen to spend some of this money for youth projects that encourage our young people to take part in healthy activities and for projects in the community, that aren't part of the budget like the Substance Abuse Taskforce, Shop With A Cop Program, Community Watch and Crime Prevention, Life Challenge, Jackson County Little League, Jackson County Youth Sports, Smoky Mountain High School Chorus and Athletics, American Legion Baseball, Blue Ridge School Athletics, Pumpkin Patch, Crime Stoppers, Refuse To Be A Victim, and numerous methamphetamine seminars just to name a few since 2003. These programs have been supported and been successful for the benefit of thousands of citizens in Jackson County. I will continue to support these organizations and others as a preventative and intervention method of law enforcement.
- The money used for carpet was to replace worn and damaged carpet in the entire Sheriff Office which includes offices, roll call rooms, hallways, etc. Using the drug tax money saved the County taxpayers \$20,000. Again, this is drug dealers' money taken from our community and used for the benefit of its citizens. All offices in the Sheriff's Office houses employees who are involved in drug investigations. This facility is also utilized every day by citizens of Jackson County.
- The District Attorney's Office asked the SBI by letter for an independent objective investigation into a County Employee who held the position of a County Department Head to avoid a conflict of interest. The SBI agreed but declined because of the shortage of manpower available in Western North Carolina. The Sheriff's Office did investigate and charged him once and indicted him twice before the Grand Jury after conferring with the District Attorney's Office. After the investigation was completed by the Sheriff's Office and the case turned over to the District Attorney's Office for prosecution, this individual pled guilty in court and was sentenced.
- TAAS (Taxpayers Against Ashe for Sheriff) is a local political action committee who registered through the Jackson County Board of Elections. It consists of 3 contributors - David Finn (Owner of Blue Ridge Public Safety), Gary Ramey (a contractor who operates in Cashiers), and Jeff Scott (a private company police officer who works for David Finn). David Finn is the same person who has sued me and the citizens of Jackson County since October 2007. Depite Finn's contentions, I believe the lawsuit was filed because the sheriffs in all 100 counties of NC opposed the General Assembly's Company Police Modernization Act. This act would have allowed private and for-profit company security companies to enforce motor vehicle laws and run radar on U.S. and State highways. Numerous citizens of Jackson County expressed their opposition to me as well. As a result of this opposition, based upon public outcry in Jackson County and as well as across the state, David Finn filed a lawsuit against me as a retaliatory act and continues to do so with his major role of involvement in this political action committee.
- · A joint investigation between the Jackson County Sheriff's Office and Federal Law Enforcement Agencies of the ATF and DEA was conducted in the southern end of Jackson County approximately 4 years ago. This investigation led to the arrest of an individual in Cashiers for trafficking Crystal Methamphetamine and possessing weapons of mass destruction. The case was adopted by the U.S.Attorney. This individual was convicted and sentenced to 22 years in a Federal Penitentiary in Indiana. Assets through Federal Forfeitures were seized and confiscated; one of which was a 2003 Harley Davidson motorcycle. The Marshall's Service took possession of that motorcycle and it sat in the weather in a federal impoundment lot for 18 months in Fayetteville, North Carolina. It was later turned over to the Jackson County Sheriff's Office as their portion of that forfeiture. \$625.60 was needed to restore the motorcycle to its original condition from when it was first seized after it sat in the elements for 1 ½ years. The motorcycle was used in undercover investigations in Western North Carolina through mutual aid agreements. Numerous drug dealers were arrested and convicted as a result of this multi-agency drug investigation in the 16 Western Counties of North Carolina. After the investigation was completed, I rode this motorcycle in numerous memorial and benefit fundraising events as a representative of the Sheriff's Office to solicit donations for those who had financial and medical needs. This investment was sold on Ebay after less than 15 months of official and legitimate use for a profit of almost \$10,000 which went back in the County's General Fund.

After politically motivated mud slinging, I have continued to stand strong on behalf of the citizens of Jackson County for which I work. I am saddened that my family, officers, friends, and the good citizens of Jackson County have been so overwhelmed by negative campaigns and I won't be discussing any of these issues further. Therefore, I am now setting the record straight and moving forward.

# Cherokee to host **Special Olympics**

"The Qualla Boundary Special Olympics program is excited and honored to be hosting the Far West Spring Games," said Lana Lambert, Qualla Boundary SONC coordinator. "We want to welcome all the athletes, coaches, volunteers, and spectators to our community and to our games. We hope everyone has an enjoyable time. Good luck athletes!"

Lambert said they are expecting around 250 athletes from surrounding counties including: Clay, Cherokee, Graham, Jackson and Macon.

#### Archaeological Program opportunity for EBCI Teachers, Students

A unique program will allow EBCI high school students and teachers a chance to learn about the world of archaeological field work.

A Teacher Workshop, designed for teachers from Cherokee High School or teachers from other schools who are EBCI tribal members, is slated for June 14-16 with a deadline to apply of May 21. The program is sponsored by Parks as Classrooms in conjunction with Great Smoky Mountains National Park and the EBCI Tribal Historic Preservation Office

A High School Archaeological Field School, designed for EBCI high school students entering 9th grade – 12th grade in the 2010-11 school year or those students who graduated in 2010, is set for July 19-30. That program is sponsored by the University of Tennessee and Great Smoky Mountains National Park in conjunction with the EBCI THPO.

"I am especially committed to seeing these programs succeed this year and in years to come so that Tribal students might be inspired by the long and honorable history of their ancestors,' said Melissa Crisp who serves as the Parks as Classrooms Coordinator for the Great Smoky Mountains Association. "There are so few Cherokee tribal members in professions related to history and archaeology that Cherokee history is being left to be discovered and written by those of us who honor the history, but do not have it in our blood."

Crisp, whose husband Josh is an EBCI tribal member, is an historian by profession and previously taught a Cherokee History class at Robbinsville High School. Through her involvement, she came in contact with the EBCI THPO which set the process of the program in motion.

I want to thank Dawn for sending me the info on the "live" feed for the Joint Council held in Tulsa,OK on April 16th.

I watched it from 10:00 til the meeting adjourned at about 2:30 that afternoon!!..it was nearly the same as being there!I kept trying to get to other pressing matters of my own but was drawn to the meeting and its' format and issues. The other fascination included the fact that I knew many people from both the Cherokee Nation and our own representatives from EBCI and was interested in their comments and efforts.

I enjoyed the Cherokee Baptist Choir of Tahlequah as I have a relative(Brenda Sanders) that sings with them! We need to form an official "EBCI Cherokee Choir", they sang beautifully in our Cherokee language and we could do the same as ambassadors of OUR tribe! Our Cherokee Royalty spoke well and were gracious in their attending the Council and activities, we can be proud of their representation.

There were several recognitions and tributes to both Hasting Shade, former Deputy Chief and Wilma Mankiller, former Chief of CN who have recently passed, in honor of their many contrbutions and leadership, I was priveleged to have met both, they were down to earth and sincere people with great love for their native people and will be greatly missed. The introduction of both councils was fun for me, for as many of you know, Dad (Soldier Sanders) was a full-blood enrolled member of CN, or Western Cherokee as we used to call ourselves! And then seeing all my tribal council from EBCI.It is a blessing being from, literally, both ends of the trail!

There were many fascinating presentations and powerpoints including their BELL COMMUNITY (in OK.) and the self-help and self-reliance of putting in 16 miles of pipeline, by the community themselves ,men, women and children to physically get a waterline to an isolated Cherokee community...defines Gadugi and perserverance and what can be accomplished by working together! Taking charge of their own destiny and not waiting for someone to do it for them! A lesson learned and passed around, native independence and fortitude.

There was a very informative and exciting presentation by Renissa Walker on the joint efforts of the respective Immersion Cherokee Language Programs and how we have lept into the 21st century with "live" feeds for the children to communicate over the internet!!Marie Junaluska gave remarks on the Language exchange program of Cherokee speakers and the joint efforts with NorthEastern and WCU, so important in preserving and getting more of our people speaking "our" Cherokee language, both east and west.

The issue of fradualent Cherokee Tribes was brought to light and the fact that state recognition is misleading to the public. We all know the federal criteria for recognition and that only Congress has the right to recognize legitimate tribal entities or nations. We are all too familiar with the pseudo-tribes that are springing up all over the country, there are many "state" recognized "tribes" in the state of Georgia, (I have many sad tales I could relate of how their baby was "blessed" at a "Pow-Wow" in south Ga. by a "real Cherokee Chief"!!???? ) When I tell them they were duped they are defensive and try to convince ME it was genuine...sigh.

We have been an established, recognized federal tribe since the late 1800's and have been an established tribe, I might add ,since before the Egyptians were building their pyramids...we number 14,000 enrolled members today and the NC legislature has recognized the Lumbee, of over 50,000...whats' wrong with THIS picture??? They lobby for a federal ban of state recognition of fradulent tribes,approaching the NCAI of two fake Cherokee groups on its' rolls,enforcement by US Fish and Game of using sacred Eagle feathers and red-tailed hawks by non-Indians,the Arts and Craft Act to exclude state recognized tribes,(there are 8 in neighboring Tenn.) These people are harmful and misrepresent themselves, they are stealing our culture, are not authentic, are not Cherokee citizens by blood or ancestry. Unfortunately when people ask me about helping them track their geneology, it is not for personal knowledge, it is how can we get on the roll to get "free" stuff...go to college free and get free health?...the others want to start a casino...sigh..!!

They recognized the author of the Moravian 1750's Archives that were translated from German to English.It will be in printed in not one but two volumes and the



"This active involvement brought our program to the attention of the Tribal Historic Preservation Office and led to an invitation for our students to participate in an archaeological field school in 2007 and 2008," said Crisp. "We were unable to secure funding for the program in 2009, but we have once again been blessed with generous grants and can not only offer the opportunity to Tribal students, but can also offer a stipend (\$600) to ease the burden of a two-week commitment for those who might otherwise miss this opportunity for need of summer work."

According to Crisp, the teachers will be assisting with work at a site known as Oconaluftee Fields and the students will be at a known Cherokee site at Smoke-

Crisp said the Teachers Workshop is funded by a grant from Parks as Classrooms along with monetary support from Toyota, the Friends of the Smokies, and the Great Smoky Mountains Association. She related the High School Program is funded by a Federal Challenge grant with matching funds from the Great Smoky Mountains National Park and in-kind donations from the University of Tennessee.

first has been published, a very insightful look at early Cherokee contact that has not to date been brought to light. (funded by the CN)

There were many joint resolutions passed supporting Women's Abuse Prevention, Diabetes, Education, as well as the Remembrance-Removal tour, and support for the Sequoyah birthplace in Vanore, Tn.

There was a motion to include the United Keetowah Band of Cherokee in future Joint Councils of the EBCI and CN, as it is the remaining of the three fedrally recognized Bands of the Cherokee...we are after all...Cherokee by blood. They are already involved in many of our joint efforts including support of our threatened Kituwah viewshed. Which, there was an update on this issue by our tribal preservation officer, their are talks in the works for a viable solution with Duke Power, we have the support of Swain County and their commissioners and many neighboring families as well as Cherokee of all 3 affiliates across the nation. We shall perservere!

I am SURE our council and Chief are ALL active in preserving its' sanctity, please stay in touch with your respective council representatives to ensure its' preservation.

Well, the joint council adjourned after many thanks for the gracious hospitality..and emphasis on FOOD..if they all look heavier this week, we know why! I was a bit dismayed that the room was amost empty, a bit of disrespect I found, even some of the council members of both nations. I realize travel was scheduled for many but at the forfeit of attendence? Perhaps the joint meeting should be held in the middle of the week with functions before and after the council itself so that attendence is evident, for the entire council. I only noted it as a bit disrespectful, to end an important and significant meeting to an empty room...maybe its' just me.

I encourage a live feed through our tribal website, for all of us enrolled members who live off the rez, of our tribal council meetings. We DO have the technology today. I did note that the CN has representatives (2) on their council representing those CN members who do not live in their 14 county constituancy..something council might consider since only 1/3 of our enrolled members actually LIVE on the reservation, but our numbers are included for federal funding, etc. Two more council members representing those scattered across the country, could have some informative, outside-the- box input! They could, conceivably, "attend" all meetings through a "live" feed..this technology has sparked some food for thought!

At 2:36 the 2010 Joint Council held in Tulsa Okl.at the CN Hard Rock Casino facility was adjourned...

thats' all folks...wado..sgi..

# Baked Chicken with Onions & Leeks

Baking pieces of chicken is one of the easiest ways to put a meal on the table for your family. This mustard-glazed chicken is roasted on a bed of sliced onions, leeks and garlic that you can serve alongside it. When using a combination of thighs, drumsticks and breasts, cut each breast in half crosswise to make pieces about the size of an average chicken thigh. And if you buy whole legs, separate the drumsticks and thighs. When all the pieces are about the same size, they'll all cook at the same rate. A nonreactive bowl or pan—stainless-steel, enamel-coated or glass—is necessary when cooking with acidic foods, such as lemon, to prevent the food from reacting with the pan. Reactive pans, such as aluminum and cast-iron, can impart an off color and/or off flavor. Serves 6

#### **Ingredients**

- 2 cups thinly sliced onions
- 1 cup thinly sliced and washed leek, white and light green part only
- 4 cloves garlic, thinly sliced
- 3 tablespoons extra-virgin olive oil, divided
- 2 teaspoons fresh thyme leaves
- 1/4 teaspoon salt
- 2 1/2-3 pounds bone-in chicken pieces (thighs, drumsticks and/or breasts), skin removed, trimmed (see Tip)
- 1/4 cup Dijon mustard
- 2 teaspoons minced shallot
- 1 1/2 teaspoons chopped fresh rosemary
- 1 teaspoon reduced-sodium soy sauce
- 3/4 teaspoon freshly ground pepper

#### **Preparation**

- 1. Preheat oven to 400°F.
- 2. Toss onions, leek, garlic, 2 tablespoons oil, thyme and salt in a large bowl until the vegetables are well coated. Spread the mixture in a nonreactive 9-by-13-inch baking dish (see Tip). Place the chicken pieces on the vegetables. Bake for 10 minutes.
- 3. Whisk mustard, shallot, rosemary, soy

# Wear a Helmet!

The single most effective safety device available to reduce head injury and death from bicycle crashes is a helmet.

 Make it a rule: every time you and your child ride a bike, wear a bicycle helmet that meets the safety standards developed by the U.S. Consumer Product Safety Commission.

• If your child is reluctant to wear a helmet, try letting him or her choose his own.

#### Helmet fit is important.

• Make sure the helmet fits and your child knows how to put it on correctly. A helmet should sit on top of the head in a level position, and should not rock forward, backward or side to side. The helmet straps must always be buckled but not too tightly.

#### Try the Eyes, Ears and Mouth Test:

- EYES check: Position the helmet on your head. Look up and you should see the bottom rim of the helmet. The rim should be one to two finger-widths above the eyebrows.
- EARS check: Make sure the straps of the helmet form a "V" under your ears when buckled. The strap should be snug but comfortable.
- MOUTH check: Open your mouth as wide as you can.
   Do you feel the helmet hug your head? If not, tighten those straps and make sure the buckle is flat against your skin.

#### Use different helmets for different activities.

• Children should always wear a helmet for all wheeled sports activities. A properly-fitted bike helmet is just as

effective when riding a scooter, roller skating or inline skating. However, when skateboarding andlong boarding, make sure your child wears a skateboarding helmet.

### Proper equipment fit and maintenance are also important for safety.

- Ensure proper bike fit by bringing the child along when shopping for a bike. Buy a bicycle that is the right size for the child, not one he will grow into. When sitting on the seat, the child's feet should be able to touch the ground.
- Make sure the reflectors are secure, brakes work properly, gears shift smoothly and tires are tightly secured and properly inflated.

### Always model and teach proper behavior. Learn the rules of the road, and obey all traffic laws.

- Ride on the right side of the road, with traffic, not against. Stay as far to the right as possible.
- Use appropriate hand signals.
- Respect traffic signals, stopping at all stop signs and stop lights.
- Stop and look left, right and left again before entering a street or crossing an intersection. Look back and yield to traffic coming from behind before turning left.

Adult supervision of child cyclists is essential until you are sure a child has good traffic skills and judgment.

- Cycling should be restricted to off-roads (e.g. sidewalks and paths) until age 10.
- Children should be able to demonstrate riding compet



ence and knowledge of the rules of the road before cycling with traffic.

#### Children should not ride a bicycle when it's dark, in the fog or in other low-visibility conditions.

- If riding at dusk, dawn or in the evening is unavoidable, use a light on the bike and make sure it has reflectors as well
- Wear clothes and accessories that have retro reflective materials to improve biker visibility to motorists.

# Sexual Assault: Know the Facts

Rape and sexual assault are traumatic experiences that may interrupt your life at home, at work, and at school, affecting your relationships with friends, family, and coworkers. You have survived, and now you can begin to recover. Although this process is often slow and confusing, with understanding and persistence you can accomplish a great deal. You have control over how you recover.

The first step in recovery is to know the facts. "Sexual assault" is a general term that includes: rape, incest, child molestation, marital rape, date rape, sexual harassment, sodomy, sexual abuse, voyeurism, and indecent exposure. Sexual assault is a violent act committed primarily by a perpetrator who needs to feel powerful and in control by forcing someone else to participate in unwanted sexual activity. Often, the victim fears for his or her life or physical well-being and feels that there is no choice but to do what the attacker wants. Submission does not equal consent. If you submit, it does not mean that you agreed to or accepted the situation. A victim is never responsible for being sexually assaulted. The responsibility for the assault lies with the attacker.

Sexual assault can cause significant trauma and disrupt your physical and emotional health. Your recovery path will take many stages, but the important thing is to take care of yourself. Many rape survivors find that receiving medical attention helps them to regain a sense of control over their bodies. Many rape survivors feel isolated in the aftermath of the assault. In order to reduce those feelings, reach out for support to those who are close to you: call family members, friends, or a program such as the EBCI DV/SA Program who has victim advocates available. It might help you feel better to have someone to talk to, and you might want people around you so that you feel safe. Consider professional support or counseling. Having someone to talk to about how you are feeling may help you to deal with the emotions you are experiencing. Additionally, a counselor can help you express your needs to others and learn how to get those needs met.

Your response to an assault may cover a wide range of physical and emotional symptoms, even some that may not seem to result directly from the attack. Learning to recognize these responses

will help you gain control of them. You may experience these symptoms immediately or later in your life, or you may never experience any of them. Every survivor responds differently. Some symptoms include: flashbacks, nightmares, fatigue, shortness of breath, involuntary shaking, fear, grief, depression, suicidal thoughts, feeling dirty, anxiety, irritability, shame, and anger. In addition, these symptoms, among others, could be signs of Post-Traumatic Stress Disorder (PTSD). PTSD can occur when people experience terrifying situations that they cannot control. These symptoms can intrude into your daily life and prevent you from working, maintaining relationships, or completing everyday tasks.

Sexual assault can change your feelings about yourself and those around you. You may not feel the way you did before the assault—physically, emotionally, socially, or sexually. Counseling can help you deal with these issues and aid you in your recovery. Individual counsel-

ing sessions with a supportive counselor can help you identify issues you would like to resolve surrounding the assault. Together, you will develop appropriate and attainable goals for yourself. Group counseling will give you the opportunity to share your feelings with other survivors, and although each person recovers at a different pace, group counseling provides an environment in which survivors can share their experiences along with their techniques for recovery. Many group members find inspiration and motivation in the stories of other victims and get a unique kind of support that helps them return to the lives they led before







# Mushroom & Leek Galette

Tote this savory tart to potlucks and holiday gatherings. It makes perfect party food because it is easy to eat while you are balancing a glass and grazing at a buffet. Serve as an appetizer or as a vegetarian main dish. To clean leeks: Trim off fuzzy root and dark green stems. With a sharp knife, cut several incisions in the leek's stem end to open it up like a fan. Soak in water for several minutes, then swish to dislodge dirt. Repeat until no grit remains.

#### **Ingredients**

#### Crust

- 3/4 cup whole-wheat pastry flour
- 3/4 cup all-purpose flour
- 1 1/2 teaspoons baking powder
- 1/4 teaspoon salt
- 1/2 cup 1% cottage cheese
- 1/4 cup canola oil
- 1/4 cup 1% milk
- 1 1/2 teaspoons sugar
- 1 egg mixed with 1 tablespoon water, for glaze

#### Filling

- 1 tablespoon extra-virgin olive oil
- 2 cups sliced leeks, (about 2 large) (see Tip)
- 12 ounces cremini, or baby bella mush-rooms, wiped clean and sliced (6 cups)
- 1 large egg

- 1/3 cup reduced-fat sour cream
- 1/2 teaspoon salt, or to taste
- Freshly ground pepper, to taste
- 1/2 cup scallions, chopped
- 1/4 cup chopped fresh parsley

#### **Preparation**

- 1. To prepare crust: Whisk whole-wheat flour, all-purpose flour, baking powder and salt in a medium bowl. Puree cottage cheese in a food processor. Add oil, milk and sugar; process until smooth. Add the dry ingredients and pulse 4 to 5 times, just until the dough clumps together. Turn out onto a lightly floured surface and knead several times, but do not overwork. Press the dough into a disk, dust with flour and wrap in plastic wrap. Refrigerate for at least 20 minutes.
- 2. Meanwhile, prepare filling: Heat oil in a large nonstick skillet over medium-low heat. Add leeks and cook, stirring often, until tender, 3 to 5 minutes. (Add water, if necessary, to prevent scorching.) Add mushrooms and increase heat to mediumhigh; cook, stirring occasionally, until the mushrooms are tender and the liquid has evaporated, 3 to 4 minutes. Let cool.
- 3. Whisk egg, sour cream, salt and pepper in a large bowl. Add scallions, parsley and the mushroom mixture; toss to coat.
- 4. To assemble & Dake galette: Preheat oven to 400°F. Coat a baking sheet with cooking spray.
- 5. On a lightly floured surface, roll dough into a rough 15-inch circle about 1/4 inch thick. Roll it back over the rolling pin and transfer to the prepared baking sheet. Spread the filling over the dough, leaving a 2-inch border all around. Fold the border up and over the filling to form a rim, pleating as necessary. Brush egg glaze over the
- 6. Bake the galette until the crust is golden, 25 to 35 minutes. Let cool on the baking sheet on a wire rack for 5 minutes. Slide onto a serving platter and serve hot or at room temperature.

**Tribal Member** advances in Bellator MMA Tournament

UNCASVILLE, Conn. Dan "The Handler" Hornbuckle, an EBCI tribal member, advanced to the semifinals of the Bellator XV mixed martial arts tournament by submitting Tyler Stinson in a quarterfinal match on Thursday, April 22. Hornbuckle (20-2) defeated Stinson (16-6) with a triangle choke at the 2:03 mark in the first round.

The welterweight fight was one of several on the card of the tournament being held at the Mohegan Sun.

"Lyman Good was in my place last year, so hopefully he knows that I'm on the path to get him," Hornbuckle said after the fight as Good, the reigning Bellator welterweight champion, looked on from cage-side seats. "I want that title ... I'm coming to get him.'

Thursday's submission was more in tune with Hornbuckle's jiu-jitsu style although he can also strike and actually received recognition for a head kick knockout of Akihiro Gono last year which was named Fighting Stances' 2009 Knockout of the Year.

He is scheduled to face Steve Carl in the semifinals of the Bellator XV tournament in Dallas, TX on May 20.

Of that fight, Hornbuckle told fightmagazine.com, "He's (Carl) very relentless. And I'm excited about facing a relentless fighter. It's going to be an interesting training camp. Everything's gotta be big in Texas right?" Hornbuckle says. "Well, so are the match-ups. It's gonna be awesome. I can't wait."

Hornbuckle trains at McVickers Martial Arts Academy and resides in Mahomet, IL with his wife Melody and three daughters.

Notice that the line itself follows the English language alphabet – ha, he, hi, ho, hu, hv. The syllables of the line are presented in the order of the six vowels in the English alphabet – a, e, i, o, u, v (although v is not a vowel in English). Samuel A. # **Tabled Ordinances**

#### Tabled Ordinance No. 160 (2010)

SUBMITTED By OFFICE of FINANCE and BUDGET and the OFFICE of the ATTORNEY GENERAL

WHEREAS, Section 106-50 to govern the regulation of Business Background Checks on Tribal Land; and WHEREAS, Tribal Council amended Cherokee Code Section 106-50 on July 9, 2009 when it passed Ordinance No. 801 (2009).

WHEREAS, in order to facilitate business transactions on Tribal Land, 106-50 needs to be further amended so that Business Background checks should only be performed when required by Business Committee.

NOW THEREFORE BE IT ORDAINED by the Annual Tribal Council of the Eastern Band of Cherokee Indians assembled, at which a quorum is present, that Cherokee Code Section 106-50 is amended to read as follows:

Sec. 106-50. Business background checks.

(a) This section applies regardless of whether the person or entity is for-proit or not-for-profit, and regardless of their legal formation or lack thereof. If a new corporation, the principals thereof are subject to the background check. If the corporation is not new, that is, it has existed for more than two years in its current corporate formation, the corporation is subject to the background check.

(b) Business background checks shall be performed by the respective Tribal Entity and in the manner identified by the Business Committee.

(c) The person or entity subject to the background check must pay for the background check.

(d) The Business Committee may require that a background check be performed and a favorable report be received before the contract or lease is approved, or may allow receipt within 30 days after approval of the contract or lease, or may waive the requirement if the applicant has:

(1) An established record or successful business operation on the Tribe's trust land, including consistent and timely payments of Tribal levy, rent, wages and other assessments; and

Has not committed any criminal activity.

(2)

(e) This section is effective upon approval in 2010. (Ord. No. 622, 3-30-2005), (Ord. No. 801, 7-09-2009)

[Subsections (b), (c), (d), (e) remain unchanged]

BE IT FURTHER ORDAINED that this amendment shall be effective upon ratification by the Principal Chief, and all prior ordinances and resolutions that are inconsistent with this ordinance are rescinded.

WHEREAS, in furtherance of the protection of the Tribe's membership it would be advantageous to require all applicants for Tribal membership to submit DNA results proving eligibility for membership as part of the application process.

NOW, THEREFORE, BE IT ORDAINED by the Tribal Council of the Eastern Band of Cherokee Indians, in Council assembled, at which a quorum is present, that the Cherokee Code Section 49-5 is amended to read as follows:

#### **Tabled Ord. 278 (2010)**

SUBMITTED By BIG COVE REP. TERESA MCCOY

WHEREAS, Individual elected Council Members are asked by members of their respective communities to occasionally investigate actions of the Tribe; and

WHEREAS, the Big Cove Council Member Teresa McCoy has discovered that obtaining certain information is difficult and sometimes it takes weeks to obtain; not to mention the confusion caused because of political interference and lack of written policies and procedures; and WHEREAS, the Tribe has a public records release law that is occasionally cumbersome, however it is the only mechanism available in which a Tribal member can get Tribal information.

NOW, THERFORE, BE IT RESOLVED that a section be added to Tribal Code 117-blank that simply states;

"Any Tribal information requested by an elected Council Representative upon written request be made available to the requestor within ten working days of said request, provided the requestor sign a standard prepared form provided by the legal department. The information requested will be provided in its entirety and will be used at the discretion of the Council Member. This information will be the responsibility of the Council Member and will handled responsibly unless a question of criminal activity is discovered upon then and only then will it be remanded to the appropriate Tribal, state, federal law enforcement agency."

FINALLY, BE IT RESOLVED the intent of this legislation will be carried out by the Chairman of Tribal Council and the Tribal Legal Department.
