# Gardening outside of the lines

**T**his year's Cherokee Youth Garden at Kituwah is not only outside of the box; it's outside of the lines. The outside rows of the garden are laid out in various traditional Cherokee patterns as opposed to straight rows.

"We're trying to go from the straight row method to something more meaningful, more interesting," said Karrie Joseph, one of the coordinators of the Healthy Roots grant which is helping facilitate this year's garden.

She said the 10 youth gardeners all put in 12 hours a week at the 1/3 acre garden for which they are paid. "They are learning about the plants. They are learning about the bugs...how you interact with your environment matters and that's one thing we're trying to teach them."

Some of the things being grown in this year's garden includes: watermelons, three types of corn, pumpkins, candy roasters, October beans, eggplant, tomatoes, sunflowers and more.

"We want to increase access and availability of traditional foods," said Joseph.

The installation of the patterns were designed

and laid out by NativeScapes which is owned by EBCI tribal member Pat Oocumma.

"This is the Mother Town," she said. "This is where we started. We wanted to make a garden that was culturally relevant."

The patterns are worked in using organic straw and biodegradable burlap. "We put nothing in here that was anything other than organic."

Ty Oocumma, Pat's son, is a member of the Warriors of Anikituwah and works with his mother at NativeScapes. He related that his thoughts on the designs came from thinking about water's role in Cherokee culture as well as thinking about circles and traditional dances. Some of the patterns include a snake, rivers, and a traditional corn sifter.

"I came down and talked to the kids a couple of weeks ago and gave them background on the geometric shapes," noted Ty who said he helped design the outsides of the garden and the youth were given the middle portion to design. "We're just trying to show the kids that traditional, linear rows don't have to always be that way."

"There is meaning behind this, and we're just trying to show the kids that they can still do this. They don't have to go to a grocery store to get

their produce."

Avery Guy, 14, one of the youth gardeners, commented, "It was a good idea so we can learn gardening and learn how people lived a long time ago."

The Cherokee Youth Gardeners sell their produce every Thursday from 11am – 1pm in the back parking lot of the Cherokee Indian Hospital. All of the proceeds go back into the program.



# CYC hosts First Annual Rod Cooper Bike Fest

The 4H/Cherokee Youth Center Bike Club hosted the First Annual Rod Cooper Bike Fest at the Youth Center on Tuesday, July 23. The event featured bike safety information, an obstacle course, helmet fittings, games and more.

"We have a mentoring grant working with North Carolina A&T and 4-H, and we're trying to come up with activities for our kids, get them active and out interacting with families and kids," said Matt Hollifield, CYC manager. "We had the idea for a bike rodeo, and when we had the idea the first name that popped into our minds was Rod Cooper. He used to do these all the time."

"We started out this year with the Youth Center kids, and next year we hope to have a community-wide Bike Fest and grow it from there and see what we can turn it into. We're very excited about it."

Booths were set up for the kids by various organizations including: North Carolina A&T, Cherokee Indian Police Department, Bryson City Bicycles, and the Remember the Removal Riders.

"It's great to have a chance to give back to the community since they gave so much by sponsoring us on the ride, encouraging on the ride and welcoming us back," said Hugh Lambert, an EBCI tribal member who participated in the 2012 Remember the Removal ride. "It's just a chance to give back and encourage people to experience some of the wonderful things we have come to love and enjoy."

Music for the event was provided by the Cherokee Youth in Media Program at the Cherokee Youth Center.

# Cherokee Elem. putting emphasis on reading

From 8:10 – 8:30am each morning, Cherokee Elementary School (CES) will be quiet. Students and staff will be participating in a new reading program during that time slot.

The Read Bravely program is aimed at increasing student's vocabulary development and knowledge and use of phonics.

"So many teachers said we need to refocus on reading," said CES principal Paula Coker. "It is a valuable part of what we will be doing here."

Jonnie Walkingstick, a teacher in the Horizon Program for gifted students in Pre-K through fifth grade, commented, "This is self-selective, reading of their choice, so they get to develop a love of reading."

Last year, CES implemented Letter Land, a phonic-based program, in Kindergarten. This year, that program will be implemented in Pre-K through first grade as well as a new program to help with vocabulary development for grades 1-5 called Words Their Way.

"Your testing data drives everything you do," said Principal Coker. "So, we looked at what we could do to improve reading. We're getting there, but we still have a ways to go."

For the 2011-12 school year, Reading EOG (end-of-grade) scores for CES were as follows: third grade (53 percent), fourth grade (54 percent), and fifth grade (56 percent). The statewide scores for those grades were: third grade (62.9 percent), fourth grade (66.1 percent), and fifth grade (65.6 percent). The

statewide score for American Indian students in grades 3-8 was 51.3 percent.

"Test scores are so important," Principal Coker related. "That's what we are judged by, but the ultimate goal is for students to be able to read. I think if we do our job with teaching and learning, the kids are going to do what they need to do on the tests."

Students will choose their books for the Read Bravely program from selections in the Accelerated Reader Program in which the school already participates. The twenty minute reading sessions will be in addition to the daily reading instruction.

CES is also beginning to work with Agelink and the Dora Reed Childcare Center to make the transition from pre-school to elementary school smoother.

Principal Coker commented, "The ability to read defines a person's life."

Walkingstick added, "Reading is so fundamentally important. It opens up many opportunities...we want them to be lifelong readers."

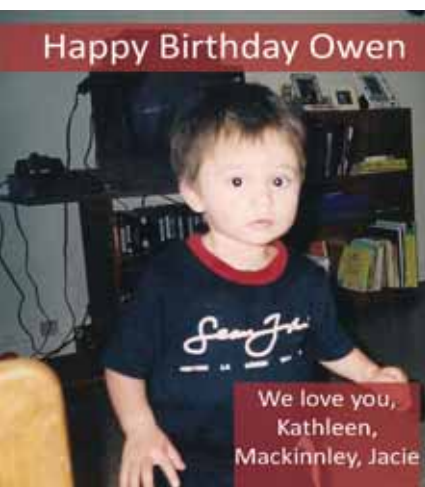
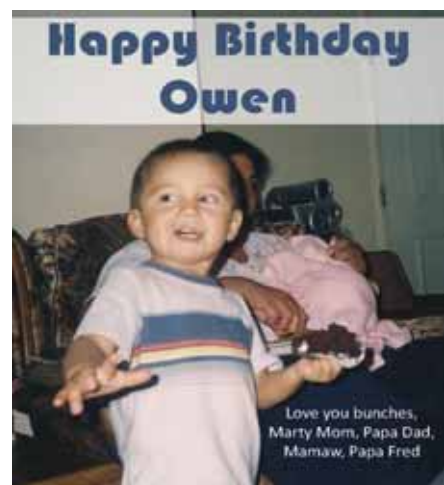

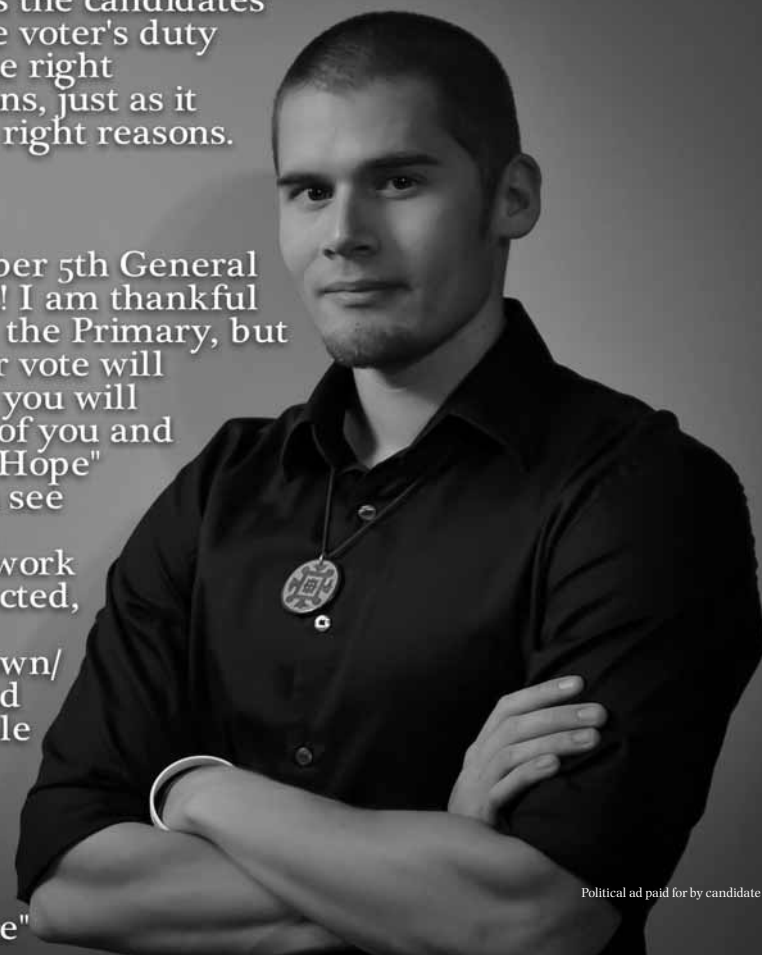

# Area teachers, students become Park Rangers

Great Smoky Mountains Park officials have announced the completion of two unique summer programs engaging selected high school students and teachers as park rangers. The Teacher-Ranger-Teacher and the High School Student Intern programs are six-week paid work experiences where participants learn a great deal about the Park through on-site training exercises that enable them to perform ranger duties. Participants will complete the programs just in time for the new school year allowing them to return to the classroom with a wealth of knowledge and experience gained from a summer working with rangers in the Park.

"These programs are mutually beneficial," said the Park's education specialist Karen Ballentine. "The students and teachers get an in-depth study of resource education techniques, scientific methods, and field research to enhance their skills and

talents, and, in turn, the Park creates advocates through better understanding of and appreciation for the Smokies. Teachers will bring the knowledge into their classrooms and the interns will share their education and experience with the local community through their friends and family."

During their time in the Park, teachers work alongside Park rangers in the field assisting with resource management activities and education programs. When not in the field, teachers are working with Resource Educators to develop elementary, middle, and high school curriculum for the popular Parks as Classrooms program.

Student interns, from different local high schools within the surrounding counties and communities, assist scientists and Park staff with field research and education programs while exploring possible career opportunities. They get exposed


to and gain knowledge about a variety of areas while working in the Park, including wildlife biology, fisheries science, botany, forest and stream ecology, geology, Cherokee history and culture, Appalachian history, and Park management.

The two successful programs were expanded this summer, thanks to a variety of public and private funding sources. Grants were received from the Verizon Foundation, the National Park Foundation's Park Stewards program, and Glaxo-SmithKline Foundation's Ribbon of Hope fund through Friends of the Smokies and the federally-funded Youth Partnership Program (YPP). These funds supported six teachers and 23 high school students from Tennessee and North Carolina school systems. Additionally, the YPP grant supported four intern positions based out of Great Smoky Mountains Institute at Tremont who assisted with summer camp and re-

search projects.

The following North Carolina high school students were selected for the program: Blair Allman, Swain High School (NC State, Fall 2013); Junior Keener, Robbinsville High School; Joi Owle, Cherokee High School; Luke Dillard, Pisgah High School (NC State, Fall 2013); Allie Dinwiddie, Tuscola High School; Kinana McDaniel, Asheville High School (University of San Diego, Fall 2013), Ben Ogletree, Smoky Mountain High School; Orion Holmberg, Cherokee High School; Levon Joines, Job Corps; Rowan Stuart, Jackson County Early College; Luke Aldridge, Robbinsville High School; Colton Millsaps, Robbinsville High School.

## Coulter Regional Leadership Program accepting Applications

The new Coulter Regional Leadership Program, with the support of the Cherokee Preservation Foundation, will begin a pilot program in October 2013. This program will give people in the region new opportunities to learn and work together

across cultures, governments, systems and counties to identify, understand and address region-wide challenges and opportunities. The Program will bring together adults from Cherokee, Clay, Graham, Haywood, Jackson, Macon and Swain Counties and the Qualla Boundary to learn about leadership and practice leadership through group projects to benefit the region.

Applications to participate in the pilot year program will be accepted until Aug. 15. Participants will be chosen by Sept. 1.

Planning for the program began with listening sessions in the fall of 2012. More than 100 people in six counties and the Qualla Boundary participated and discussed the needs for leadership and effective approaches to leadership learning. Four themes emerged as desired key elements for the Coulter Program. These include expanding individual leadership competencies, including public speaking project management skills, developing hands-on experiential learning and group service projects, creating opportunities for mentoring, and adopting a regional approach to solve problems and take advantage of opportunities.

Named for Dr. Myron Coulter, the Program honors Dr. Coulter's lifelong work in leadership and his interest in the western North Carolina region. Chancellor at Western Carolina University for a decade, Dr. Coulter was a founding member of the Board of Directors of the Cherokee Preservation Foundation and was an active and effective leader in the region.

The Coulter Program builds on recent leadership initiatives of the Cherokee Preservation Foundation. Since 2005, the Foundation has established the Costa Rica Cultural Exchange Program, the Jones-Bowman Leadership Award Program, the Cherokee Youth Council and youth councils in the seven far west counties, and the Right Path Program for EBCI tribal members.

## Dartmouth Native Fly-In Program

The race is on! It's that exciting time when seniors in high school all across the country are beginning the process of narrowing in on the colleges and universities to which they will soon be applying. Although it's not always easy, or even possible, visiting prospective schools on your "short list" can be the defining factor in determining the school best suited for you. Some schools are going the extra mile (or air mile) in enticing Native students to consider their campus. Today's article will high-

light such a program, The Dartmouth Native Student Fly-In Program.

Dartmouth's historical commitment to Indian education dates back to the very beginning of the College itself. In 1769, founders of Dartmouth College established a charter which directed that Dartmouth College exist, "for the education and instruction of youth of the Indian tribes in this land... English Youth, and any others." When other institutions of their time were doing all they could to resist students other than those of European heritage, Dartmouth reached out to the Native American student. In 1970, during a difficult phase of time where Native communities sought fair and just treatment within white dominated society, John G. Kemeny, Dartmouth's 13th president, pledged to redress the historical lack of opportunities for Native Americans in higher education during his inaugural address to the students, faculty, trustees and alumni. "The Recommitment," as it is often referred to, not

only held Dartmouth to a higher standard than its peers, but also established the Native American Program, laid the groundwork for the Native American Studies department, and directed the Admissions Office to begin actively recruiting Native students for the first time since the founding. In the 40 years since President Kemeny's historical address, Dartmouth's commitment to Indian education has remained strong. Dartmouth, more than all Ivy League school combined, has graduated more than 700 of the country's most outstanding Native students. This accomplishment is aided by the college's innovative Fly-in program which introduces students to its historic campus.

Selected high school seniors from all over the country who have a demonstrated interest in Native community and/or Native American Studies are flown to Dartmouth and are greeted by members of the admissions staff and current Dartmouth students (some of whom are past Fly-In participants) who will offer their perspectives on Dartmouth and advice about navigating the college search and admissions process. Tours include an orientation of the Dartmouth campus and facilities, as well as specific areas of interest, including the Thayer School of Engineering. The gathering also provides to students the Native Students' Experience Forum which is an

opportunity for program participants to get an unedited view of life at the College from the perspective of Native students. Additionally, the Native Americans at Dartmouth (NAD) community dinner, held at the Native American House, provides an opportunity for the entire Native community (students, faculty and staff) to come together over a meal, introduce themselves, welcome prospective students, and informally share their experiences. Students also are provided admissions advising and a chance to review real applicants to the College as part of a mock admissions committee exercise. Further, students participate in the First-Year Experience which provides insight into the transition to College and an overview of some of the programs and resources available to students at Dartmouth.

Again, selecting a college should be a careful process of making certain your "first choice" school is one that meets your needs as both a student and a community. On campus visits provide you with a hands on, close up view of an institution that best suits your individual needs and goals that a brochure or catalog cannot duplicate. ## Safe fruits and veggies



Keep your family healthy and safe

1. Choose fruits and vegetables that are not bruised or damaged.
2. Wash hands with warm water and soap before and after preparing fresh produce.
3. Cut off any damaged or bruised areas on fruits and vegetables before cooking or eating.
4. Gently rub fruits and vegetables under running water.
5. Wash fruits and vegetables before peeling them.
6. Use a clean vegetable brush when scrubbing fruits and vegetables.
7. Dry fruits and vegetables with a clean cloth or paper towel.
8. Throw away the outer leaves on a head of lettuce or cabbage.
9. Keep most fruits and vegetables in the refrigerator at 40 degrees or below.
