and fight back against the disease," said Debbie Buchanan, American Cancer Society senior manager for Relay For Life. "The Cherokee event is very special as we wish to collaborate with the Eastern Band of Cherokee Indians to be successful in the fight against cancer. Many of the participants in Relay For Life events are cancer survivors, which serves as a reminder that the Cherokee community is not immune to this disease and that by participating in Relay, participants are joining with the American

## BASKETBALL Lady Braves lose first of season at Hayesville

AYESVILLE – The Cherokee Lady Braves (17-1) lost their first of the season in a hard fought game at Hayesville on Friday, Jan. 30 as the Lady Yellow Jackets won 73-53. Kendall Toineeta, Lady Braves senior point guard, led Cherokee with 21 points followed by LeLe Lossiah, Lady Braves senior forward, with 12.

"We made too many mistakes," said Lady Braves head coach Chris Mintz who remained positive despite the loss, "You just have to build from it. You have to learn from every game. Whether you win or lose, you have to learn from it."

Things started slowly in this game with both teams playing nice defense. Cherokee led 4-2 at the 4:57 mark in the first period. It was back-and-forth for most of the first, and Cherokee took a 19-18 lead into the second period.

Cherokee was able to build a lead in the second extending it to 31-19 midway through. By halftime, it was Cherokee 37 Hayesville 30.

The third period was all Hayesville though as they outscored Cherokee 24-10 to take a seven-point (54-47) lead into the final eight.

AYESVILLE – The Cherokee Braves (18-1) lost their first game of the season at Hayesville on Friday, Jan. 30 as the Yellow Jackets took the win 84-52. Dustin Johnson, Braves senior point guard, led Cherokee with 16 points, four rebounds and two steals.

"We got beat every way you can get beat," said Braves head coach Willis Tullos after the game. "They (Hayesville) shot the ball extremely well. They just played a great basketball game."

On the night, Hayesville shot 69 percent (18/26), 41 percent from three-point range (11/27)and 63 percent from the free throw line (15/24). Cherokee shot 41 percent (11/27) from the floor, 33 percent (9/27) from threepoint range and 50 percent (3/6) from the free throw line.

Cherokee fell behind early trailing 11-2 at the 6:03 mark in the first period. They climbed back into it behind three threepoint shots by Jason McMillan who ended the game with 14 points. By the end of the first, Cherokee had chipped away at the lead and only trailed 25-17.

It dawned on me at that point that this wasn't even an away game for Cherokee. It was a home game. The Cherokee fans had absolutely packed the Murphy gym. Braves supporters filled all of the "away" side and at least one-third of the home side if not a little more. And, it got loud!

I firmly believe that the more a team is supported by its fans, the better the morale of that team is. Most of the teams who travel to Cherokee do not bring even a percentage of the amount of fans that Cherokee brings to their venues.

In 1996, the Chicago Bulls won the NBA Championship and finished the season with an amazing 72-10 record including an almost hard-to-believe 39-2 record at home. Granted, that might be an isolated example, but, you see, teams aren't supposed to lose at home.

## How Snowbird got its name

#### **TJ HOLLAND** JUNALUSKA MUSEUM

ccording to tradition, there was a time when there were giant animals. These are the ancestors of the animals that are with us today. The giant, or Great, animals had their homes throughout the Cherokee lands. The Snowbird Community is named, in a way, after one such site.

The Great Snowbird built her house on top a mountain deep in Graham County. The Snowbird Mountains are named after her, as well as Snowbird Peak, where the nest was built. Two creeks begin on this mountain and are called Little and Big Snowbird Creeks. Cherokee have lived along these creeks for thousands of years. Junaluska Museum has artifacts from Little Snowbird including spear points and a stone pestle that was used to grind corn.

The Snowbird Community is located along the banks of these creeks. This area was part of Buffalo Town in the 1800s, and didn't become known as Snowbird until the 20th century.

## **EBCI Extension hosting Shiitake Mushroom Farming Workshop**

#### SARAH MCCLELLAN-WELCH EBCI COOPERATIVE EXTENSION CTR.

BCI Cooperative Extension will be hosting Specialists from the NC A&T Mushroom Program to teach a workshop on how to grow shiitake mushrooms. The workshop will be held on Monday, Feb. 23 from 1-4pm at the EBCI Cooperative Extension Center and will include an indoor classroom session and a hands-on inoculation outside, so dress for the weather.

Shiitake mushrooms are popular because of their delicious, smoky flavor and their versatility in recipes. They are high in iron and B vitamins which help boost our immune system. Shiitake mushrooms are also recognized as a health promoting food because compounds found in shiitake mushrooms may help prevent cardiovascular disease. The type of mushroom farming taught in this workshop involves inoculating mushroom spawn into sweet gum or oak logs. To participate, bring 2-4 freshly cut oak or sweet gum logs. It is important that the logs be from live, dormant trees. Any type of oak or sweet gum is acceptable. Logs must be freshly cut within two weeks of workshop. Logs cut between the dates of Feb. 7-23 will be the best for this workshop. Dead trees are already infested with wild fungi and will not be successful.

The logs should be 4-8 inches in diameter, four feet long and in good condition with the bark intact. One log will be donated to NC A&T's Mushroom Program. Participants will keep the rest of their logs after inoculating them. Farmers interested in raising 200 shiitake logs or more, could be eligible for free spawn by participating in this workshop and enrolling in NC A& T's Mushroom Program. The workshop is free, but registration is required. Everyone is welcome.

#### Medicare Info for EBCI Tribal Members

What is Medicare Part A & B? Medicare is a federal health insurance program for people 65 and older

Medicare is:

• Hospital Insurance (Part A) This part helps pay for inpatient care in hospital or skilled nursing facility (following a hospital stay), some home health care and hospice care. Certain conditions must be met. Most people pay for Part A through their payroll taxes when they are working.

• Medical Insurance (Part B) This part pays for doctors' services and many other medical services and supplies that are not covered by hospital insurance, only when they are medically necessary. Most people pay a monthy premium for Part B.

## Who is eligible to receive Medicare?

Most people age 65 or older, people who have been entitled to Social Security disability benefits for 24 months, people with Endstage Renal Disorder (permanent kidney failure requiring maintenance dialysis or a kidney transplant) or Amyotrophic Lateral Sclerosis (Lou Gehrig's Disease) may also qualify for the program. **What is the cost for this insurance?** 

Most people do not have to pay a monthly premium for Part A. This is because they or their spouse paid Medicare taxes while they were working.

In 2015 the Medicare Part B premium is \$104.90 per month. This amount may change January 1, 2016. In some cases, your premium will be higher if you didn't sign up for Part B when you first became eligible. You will have to pay this penalty for as long as you have Part B.

#### How can I sign up?

If you are already getting Social Security retirement or disability benefits, you will be contacted a few months before you become eligible for Medicare and sent the information you need. You will be enrolled in Medicare Parts A and B automatically. However, because you must pay a premium for Part B coverage, you have the option of turning it down.

If you are not already getting retirement benefits you should contact the Social Security Administration three months before you 65th birthday to sign up for Medicare. **Notification of Benefits to EBCI tribal members** 

If you are age 65 and over or

on Social Security Disability and you have or are eligible to receive Medicare, please contact the EBCI Supplemental Health Insurance Program Office. They may be able to reimburse you \$104.90 that comes out of your Social Security check each month.

The guidelines for reimbursement are:

### Park seeks North Carolina volunteers interested in <mark>Citizen Science</mark>

reat Smoky Mountains National Park rangers are seeking volunteers to help with an important research project. In an effort to do a better job of tracking nature's calendar, or phenology, park rangers are recruiting volunteers who are willing to adopt a tree monitoring plot in areas throughout the North Carolina side of the park. A tree phenology monitoring training will be held on Saturday March 7 from 9:30am – 12:30pm at the Oconaluftee administration building in Cherokee.

After training, volun-

teers will be assigned to a phenology plot for which they will collect data multiple times throughout the growing season. Plots up for "adoption" are located near parking areas in the Deep Creek, Fontana, Oconaluftee, Purchase Knob, Cataloochee, Clingmans Dome, Newfound Gap and Davenport Gap regions of the park.

Information collected by volunteers will go into a national database that helps answer questions such as "was spring early this year?" or "when will the fall colors peak?" Monitoring phenology will help park rangers to understand how earlier springs and cold snaps impact our mountain forests.



## Reader supports Little Shell recognition efforts

he case of the Little Shell Tribe of Chippewa Cree of Montana does stand out as unique. All seven of the federally acknowledged tribes in Montana wanted the Little Shell to be federally acknowledged, and as far as I know, they still do. The Little Shell were big time buffalo hunters. Their language, Michif, is virtually perfect Cree as to the verb, but the nouns are French. Except for a Cree family line or two, their descent is altogether Chippewa.

In the Federal Register, the Little Shell got a proposed finding to acknowledge which was reversed in the final determination. But, the text of the final determination not to federally recognize the Tribe, listed several pathways by which Congress could recognize the Tribe, should Congress desire to do so.

fishing. Baitfish will usually be found there, and of course, bass are going to be there too.

A great way to eliminate water is to run a windy bank using your graph or depthfinder to see whether baitfish are congregated there. If so, you can expect to duplicate that pattern on similar areas the rest of the day. You also should use a surface temperature gauge to find the warmest available water.

Try slow trolling a spinnerbait or use a crankbait with a tight wobble to locate the bass. After you catch a few, you can switch to a jig 'n' pig and fish more slowly.






