## **Tribe considering overhaul to Tax Code**

n ordinance, submitted by Principal Chief Michell Hicks. would overhaul the Tax Code of the Eastern Band of Cherokee Indians if passed. Ordinance No. 556 (2015) would replace Chapter 105 of the Cherokee Code with a new "reformed and expanded" Cherokee Tax Code.

"The intent behind the Tax Code is mainly from a business and economic development perspective," said Cory Blankenship, EBCI Office of Budget & Finance director. "There is a lot of gray area when it comes to taxation and where the

state has the authority to tax versus where the Tribe has the authority to tax."

"In the Tax Code, there are no proposed taxes on individual tribal members," Blankenship explained. "There are no proposed property taxes, income taxes, or anything that should impact an individual tribal member negatively. If that tribal member owns a business, then the taxes associated with running that business could change."

Ord. No. 556 was tabled during the regular Budget Council session on Tuesday, July 7. It was decided that a work session would be held on the legislation, but it has not been scheduled as of press time.

According to information provided by the EBCI Office of Budget & Finance, some of the new taxes that will be added include:

 Ad Valorem Tax for non-members who place or reside a recreation vehicle, camper trailer or mobile home requiring those persons to register the property with the Tribe and pay Ad Valorem Tax based on the assessed value of the property to EBCL. This is a new tax that replaces a tax currently assessed by North Carolina counties on tribal lands.

• Telecommunications Services Tax on the gross proceeds of producing, providing or furnishing telecommunications services to consumers

on tribal lands. This is a tax on providers, not consumers.

• Utilities Tax of 6 percent of gross receipts for those in the business of producing, providing, or furnishing utility services including electricity, gas, or water. This is a tax on providers, not consumers.

• Advertising Tax of 6 percent of gross receipts for those advertising on tribal lands by billboards, direct mail, radio, television, and any other means.

• Parking, Garaging and Storing tax of 6 percent of gross receipts from the business of parking, garaging or storing automobiles on tribal lands for a period of less than seven days.

• Business Tangible Personal Property Tax, sometimes known as a Fixtures Tax, on all personal property used in business on tribal lands including such things as furniture, fixtures, tools and machinery, computers, signs, farm equipment, etc. This is a new tax that replaces one currently assessed by North Carolina counties.

The current code only has levy, privilege, and lease taxes. The new one would establish a Cherokee Tax Commission to oversee taxes for the Tribe as well as adding several new taxes for non-EBCI persons and businesses operating on EBCI tribal lands. The Tax Commission would be comprised of three commissioners including at least two EBCI tribal members who live on tribal land. Each commissioner would serve two-year staggered terms, although, in the beginning, one commissioner would serve a two-year term and the other two would serve one-year terms to create the staggered system.

"Our position has been that our Tribe is providing all of the governmental services for businesses on the Reservation; however, because some of those businesses are owned by non-Indians, the state can still reach in and tax those businesses," said Blankenship.

There is currently legislation before the North Carolina General Assembly (House Bill 912) that, if passed, would help to clear up some of the gray areas. "The State recognizes the exclusive authority of the Eastern Band of Cherokee Indians to levy taxes within its jurisdiction, comprised of the Qualla Boundary and any other land held in trust by the United States for the benefit of the Eastern Band of Cherokee Indians," the bill states.

The bill was introduced on April 16 and passed its First Reading and was referred to the Committee on Finance on April 20.

"Our position is that we do not need the State's permission to tax," said Blankenship. "It is within our sovereign authority to do that."

He said, however, that there is a chance for dual taxation. "The Tribe taxing does not necessarily circumvent state taxation so you have an opportunity where a business could be charged a state tax and a tribal tax, and that makes it less appealing for businesses to actually locate on the Boundary."

Blankenship did say that the Tribe is currently taking a hands-off approach on state income tax. "The state still has the authority to access an income tax on non-Indians on the Boundary...the Tribe is not interested in being involved in that income tax business at this point."

He stressed the need for the Tribe to adopt a comprehensive Tax Code "because it will let businesses know exactly what they can expect."

Blankenship said the Tax Code outlined in Ord. No. 556 "is not an attempt to raise revenues" for the Tribe.

"There is a concern in the community that this is an attempt at revenue diversification, and it's not. The tax revenues that we expect to receive from this operation are fairly minimal. There is about \$100,000 each year that is flowing out to counties that should be flowing into the Tribe, and we expect to realize those revenues, but it is really just leveling the playing field for more business and commerce-type activities to occur on the Boundary."

## **Committee appointed to establish EBCI Code of Ethics**

committee has been established to develop a Code of Ethics for the Eastern Band of Cherokee Indians. A total of 11 people, with one seat currently vacant, were appointed and approved by Tribal Council on Thursday, July 9 to serve on the Committee.

The following EBCI tribal members were selected to serve on the Committee: Bernice Bottchenbaugh, Big Cove; Lisa Frady, Big Cove; Jody Taylor, Birdtown; Jason Lambert, Birdtown; Trista Welch, Painttown; Jennifer Jackson, Painttown; T.J. Holland, Cherokee County – Snowbird; Kevin Jackson, Wolfetown; Donald Long, Wolfetown; Doris Johnson, Yellowhill; and Johnnie Sue Myers, Yellowhill. The second community member from the Cherokee County – Snowbird township will be added at the August Tribal Council session.

"This is a big step for the accountability that individuals have been asking for the past 12 years," said Taylor. "The committee should work together to produce a detailed document that is equal and impartial to all involved – a document that individuals can rely on when the need arises. My appointment to this committee is appreciated for I feel I can contribute a lot to this Ethics Committee along with the other members."

Welch commented, "I am very pleased to be given the opportunity to serve on the Ethics Committee. Good ethics should be sustained by those who choose to dedicate themselves to public service, and it should be reflected in every decision made and every action taken by that person or government. I hope this committee will be able to set standards for integrity, responsibility, accountability, and fairness, and help make ethical conduct a top priority in our community."

The idea for the Code of Ethics began with Ordinance No. 558 (2015), submitted by Wolfetown Rep. Bo Crowe. That legislation read in part, "The adoption of a code of ethics will help build an ethical culture of doing 'the right thing', it will also reduce risk and repercussion and it will establish a commitment to integrity and professional conduct."

Rep. Crowe submitted his draft of a Code of Ethics with Ord. No. 558, but it was discussed that the Code of Ethics needed further discussion and the idea of forming a Committee to work on a document was brought forth.

Res. No. 613 (2015) was submitted by Rep. Crowe in June and called for the formation of the Committee. "An effective and comprehensive Code of Ethics should be thoroughly explored, studied and researched and with time given for input from tribal leadership and the community."

At the time, it was decided that 10 community members, representing the 10 community clubs of the Tribe, would comprise the Committee. A floor amendment was offered and passed on July 9 that changed the composition of the Committee to two members of each of the six voting townships.

# GAME OVER!

Illegal gaming operations shut down in Swain County

**B RYSON CITY** – Two illegal gaming operations in Whittier and one in Bryson City were shut down as Swain County law enforcement officers conducted raids on Wednesday, July 15. According to Swain County Sherriff Curtis Cochran, 90 gambling machines and "several thousands of dollars" were seized in the raids on the three establishments which remain closed.

As of press time, no one has been charged in this matter Sheriff Cochran related. The three businesses involved are The Wizard's Guild and Teddy Bear Lounge in Whittier and the 777 Arcade in Bryson City.

"We had an undercover operation going on with surveillance within each one of these businesses since March," Sheriff Cochran said. "We sent our undercovers in at least three times, maybe four times, and we captured on video where they (businesses) were paying out in cash."

He said the gambling machines seized included such games as video poker, video blackjack, Keno and others. "All of these were very old machines."

Sheriff Cochran said they will turn over their evidence to the District Attorney's Office. "We've had the District Attorney's Office involved in this, and they're on board

with it."

He said the Swain County Sheriff's Office partnered with other law enforcement in this operation. "We used undercover agents from another county for the first couple of surveillances, and then we used our own for at least one."

Sheriff Cochran declined to name the other agency involved at this time, but would say it was "a neighboring county".

North Carolina officially banned such gambling operations when the N.C. Supreme Court unanimously upheld a state law banning video sweepstakes in a decision issued Dec. 14, 2012. That decision reversed a State Court of Appeals decision earlier that ruled the ban unconstitutional.

#### House Natural **Resources Chairman calls** Native American artifacts "bull crap"

SHINGTON - House Natural Resources Committee Chairman Rob Bishop (R-Utah) on Friday, July 10 dismissed the historical value of Native American artifacts as a basis for establishing national monuments, as first reported by Greenwire in a story about President Obama's designation of three national monuments.

"There is nothing that Obama did today that had anything to do with an antiquity," Congressman Bishop said. "There are criteria for using the act. There is nothing Obama announced that had anything to do with the criteria."

When asked about the Native American artifacts at the Basin and Range National Monument site in Nevada, including cave paintings, he said, "Ah, bull crap. That's not an antiquity."

Ranking Member Raul M. Grijalva (D-Ariz.) released the following statement in response, "The natural and cultural resources protected by these designations are, in fact, antiques; species and trees and rocks and cave paintings and beautiful landscapes are all quite old. We want them to remain antique. House Republicans want them to become extinct."

Congressman Grijalva thanked and congratulated Obama earlier in the day for his designations of Berryesse Snow Mountain National Monument in California. Waco Mammoth National Monument in Texas and Basin and Range National Monument in Nevada.

He has a compression fracture of the third vertebrae of his spine. He's in a lot of pain. Please continue to remember him in your thoughts and prayers as he heals. All praise, honor and glory to God because things could be so much worse." Cameron Cooper, who visited the Principal Chief at Mission on Friday, stated that there was also a "bruised ankle" as a result of the fall. According to Cooper, Principal Chief Hicks was released from the hospital Friday evening.

## FOOTBALL Braves team prepares for the upcoming season

he bleachers inside of the Ray Kinsland Stadium stand barren in the hot summer heat, but only a few yards away inside the Braves Fieldhouse, a special group of young men have put in a summer's worth of workouts to help build the team and prepare for a very promising upcoming season.

"This year, we're going to be more competitive," said second year Head Coach Kent Briggs. "We can go win every game we have on our schedule, if we play well. At the same time, if we don't play well, everybody we have on our schedule can beat us. We're at that stage in our program where there are no automatic wins and no automatic losses."

The Braves are in the midst of an exciting rebuilding phase with a promising crop of young talent moving up through the ranks. Although the team finished with a 3-8 record in 2014, the record didn't accurately portray the strides the team had made from previous seasons.

"Realistically, we're going to be a talented team but a young team," Coach Briggs said. "Anytime you

have young players, even though their talent level is very competitive, you're also going against great teams with football experience in this league (Smoky Mountain Conference). At the same time, we have some great senior leadership that can help make this season exciting. This young group will get more experience, and I see us being very competitive over the next several years."

While the Braves will field a young team with half the players on both sides of the ball consisting of sophomores or freshmen, the team is filled with exciting prospects with high potential. Sophomore quarterback Tye Mintz, who stepped into the starting role late in the 2014 season and passed for four touchdowns, will reunite with freshman tailback Isaiah Evans as the electric duo look to build on the foundation they laid in the JV program only a short year ago. Returning playmaker Jason McMillan (WR/Kick returner) and Darius Blanton can be very productive in the passing game.

Junior Jay Swimmer, who has put in extra hours in the weight room over the summer, looks to help clear the running lanes along with fellow returning starters' sophomores Byron Locust, Will Davis, and senior Malakai Ramirez.

While the team will field some talented youngsters, it would be impossible to discount the contributions from returning senior linebackers Keenan Panther and Logan Teesateskie. The tackling duo of Panther and Teesateskie led Western North Carolina in tackles in 2014 as the tenacious tandem has flourished in a leadership role on the team along with Dawson Wilnoty.

"Our linebacker corps is the strongest part of our defense," explained Coach Briggs. "The defensive front will also be improved. Last year, we played several freshmen up front and they are coming back bigger and stronger this year. Our secondary will be very inexperienced with four new starters coming from a group of talented young men."

The Cherokee Braves will begin practice on Saturday, Aug. 1 and hold their first live practice with pads on Friday, Aug. 7. The Braves will scrimmage Tuscola on Tuesday, Aug. 11 and Andrews and Robbinsville on Friday, Aug. 14. The first game of the season is on Friday, Aug. 21 against Trinity Academy at home.

## **ON THE SIDELINES** End gender pay disparities now

everal weeks ago, I wrote about the need to respect women's sports. This week, it seems like I'll be parroting that column.

It bugs me to no end to see pay disparities between men and women no matter if it is in the business world or the world of professional sports. This past week, we got to witness one of the best World Cup finals ever – men or women, it was purely awesome! Carli's Lloyd's hat-trick combined with that beyond-belief goal that was past the half line was enough to

make even those soccer-haters out there stand up and applaud.

That said – the United States women's soccer team who won the World Cup was collectively paid \$2 million. In comparison, the German men's soccer team who won the World Cup last year was paid a whopping \$35 million. That disparity is just insane especially when vou take into account that the 2014 United States men's team. who lost in the Round of 16, were paid \$8 million.

I'm not alone in my feeling of disdain for this system. Congresswoman Carolyn B. Maloney (D-NY) wrote a letter to FIFA President Joseph S. Blatter in which she said,

That career could be very rewarding and the fulfillment of a lifetime goal, but it would put a mere piddling in their pockets compared to their NBA counterparts.

Forbes.com reported earlier this year that the average salary for NBA players in the 2013-14 season was \$4.9 million. ESPN.com has reported that All-Star Kobe Bryant is set to make \$25 million alone in the 2015-16 season.

According to blackenterprise.com, the average WNBA salary in 2012 was \$72,000. The Examiner reported that, due to a collective bargaining agreement, the maximum salary, repeat the maximum salary, for a WNBA player in 2013 was \$107,000 if they had been in the league at least six years and \$105,000 if they had been in less than that time.

At that rate of pay, a woman would have to play 46 seasons in the WNBA to earn as much as a man playing one season in the NBA.

These disparities have got to change.

### CHEROKEE HISTORY Traditional Smack Talk

he last few articles have been about serious things, so I thought this would be a good time to talk about a lighter subject. Everyone probably knows that there are no curse words in the Cherokee language, but that doesn't mean that there were never terms or words used to be mean to someone. Here are a few terms used in the historic record.

**Katani**-Know it all. This term comes in reference to the Ani katani. Ani Watsini-Virginian. Dragging Canoe and his followers broke ties with the Overhill (Tennessee) headmen around 1775, becoming known as the Chickamauga Cherokee. In reference to those older leaders who did not want to fight, Dragging Canoe called them ani watsini, no longer Cherokee.

Uyotsv tsulasgi -Broken Pot. There is a story recorded by James Mooney about a place along the Tuckasegee River near present-day Webster that was called the Broken Pot Place. After a game of stickball, the captain of the losing team told his men that they were are all "as useless as a broken pot".

Currently do not have a home or that they live in substandard housing;

Have a home site that passes inspection and is approved for the house at issue by the Housing Infrastructure Program. In summary, an eligible applicant must have a possessory holding in their name and must possess necessary right-of-ways. A fundamental requirement is that home sites must have one (1) acre of land if a city water and sewer hook-up is not available and a septic system will be used, or one-half (1/2) acre of land if a city water and sewer hook-up is available and will be used.
