

#### Area Asthma Educator receives Champion Award

he coordinator of the Mission Health System asthma program, who served 290 EBCI children at the Dora Reed Childcare Center, the Cherokee School System and the Kituwah Academy, has been named the 2011 state recipient of the Asthma Champion Award at the North Carolina Asthma Summit held recently in Raleigh.

She is Melinda Shuler, principal investigator and regional clinical coordinator for the Mission Health System Regional Asthma Disease Management program.

"Asthma is a serious, and sometimes life threatening disease," Shuler said. "Unfortunately, too many young patients and their families do not know how to effectively manage the illness and use their medications. Working with them as we do can make a tremendous difference in the quality of their life, and sometimes in saving their lives. I am very thankful to have the opportunity to work with the asthmatic children and their families throughout the Western Region. It has been a very humbling and rewarding experience."

As principal investigator and coordinator for Mission's asthma program, Shuler works with asthmatics and their families throughout Western North Carolina, from Cherokee to Burke County, case managing more than 80 children in 40 schools. In 2010, she impacted some 3200 children and 270 parents and guardians. Her work includes asthma disease

management, grant administration, asthma educational initiatives, environmental assessments in school and child care sites in 12 counties in partnership with the North Carolina Department of Public Health, and providing physician inservice education throughout the region.

Asthma is one of the most common chronic disease in school-aged children and is the leading cause of school absenteeism. In North Carolina 314,700 children have been diagnosed with asthma and one child in 10 is affected by it.

#### **Smokies Resource Educator Settles in to New Position**

Elizabeth K. Dupree was selected as the new Chief of Resource Education at Great Smoky Mountains National Park and has been in her new post since April. Dupree replaces Cathleen Cook who took a new position as Superintendent of Chickamauga/Chat-

tanooga Military Park in Chattanooga, Tenn

Dupree, 55, came from Jean Lafitte National Historical Park and Preserve in New Orleans, La., as Chief of Resource Education, overseeing six separate locations and educating the public on the cultural and natural resources of the Mississippi delta region. A significant achievement at Jean Lafitte was the opening of a new visitor center at Chalmette Battlefield where Dupree played a major role in both the design and construction of the facility, as well as the planning, fabrication, and installation of the exhibits and interactive computer programs.

Dupree has a wealth of knowledge and experience in park interpretive operations, having worked in key leadership roles in a number of national park units over a 30-year career with the National Park Service. "This experience will be an asset to the Smokies in providing interpretive and educational activities to the millions of visitors who come to the Park, a primary function and important responsibility for protecting and pre-

erving

the flora, fauna, and cultural resources," said Park Superintendent Dale

Ditmanson

A majority of the Park's Resource Education Division's operation is providing direct contact with the public through: three popular year round visitor centers inside the Park hosting about 2 million visits annually; weekly ranger-led walks, talks, and tours; environmental educational programs such as Parks as Classrooms and Parks in Classroom, reaching thousands of students annually; and the Appalachian Highlands Science Learning Center, bridging educational opportunities with real science research.

Dupree's diverse work experience included other assignments throughout the country at San Antonio Missions National Historical Park, Texas; Lake Mead National Recreation Area, Nev.; Big Cypress National Preserve, Canaveral National Seashore, and Gulf Islands National Seashore, Fla; Herbert Hoover National Historical Park, Iowa; Cape Hatteras National

Seashore, and Wright Brothers National Memorial, N.C.; and Cumberland Island National Seashore, Ga.

Two of her earliest field assignments were at Great Smoky Mountains National Park where she worked in the Oconaluftee and Cades Cove Districts as a Park Aid and Park Technician. Prior to entering into the interpretation field, Dupree performed a variety of duties in law enforcement operations and resource management activities.

"Being back in the Smokies is like coming home and I look forward to continuing the great community connections the park has with local schools

and partners who help us educate the public about this beautiful and unique place," said Dupree.

Dupree is a native of North Carolina and a graduate of East Carolina University with a Bachelor of Science degree in Parks, Recreation and Conservation. She enjoys hiking and photography among her hobbies.

# EBCI Tribal Member Attends LEAD Summer Business Institute at Duke University

Hana Bushyhead, a senior at Simley High School in Inver Grove Heights, MN, has been chosen by the Native American Finance Officers Association (NAFOA) as the recipient of a scholarship to attend the LEAD Summer Business Institute (SBI) at Duke University. According to LEAD, it received it largest pool of applicants ever this year. The LEAD program is open to high achieving Native American, African American, Hispanic American, and Asian American students who are in their junior year of high school.

SBI took place at Duke this summer from June 18 to July 8, and provided 30 high-achieving students with first-hand exposure to the business world through a three-week residential experience at Duke's Fuqua Business School and college campus. The curriculum is designed to familiarize participants with various business disciplines through classroom study, group projects, guest speakers and hands-on projects. Cultural and recreational activities are also included.

A highlight of Hana's participation was the opportunity to introduce Cory M. Blankenship, Tribal Treasurer of the Eastern Band of Cherokee Indians.

The program at Duke covered core business topics including accounting, economics, ethics, social entrepreneurship, marketing and management taught by the school's faculty. During corporate visits, participants heard from CEO's of America's leading business enterprises, Google, Goldman-Sachs, Burt Bees, John Deere, and asset management firm, Smith Breeden. Keeping with tradition, students participated in a full day of outdoor weekend activities such as the ropes team building training course, volunteering with Habitat for Humanity, a Durham Bulls baseball game, Palace Pointe amusement park, cookouts and on campus recreation. Besides Duke University, other institutions that have participated in the LEAD program include Stanford University, Dartmouth University, Northwestern University, the University of Illinois, the University of Michigan and the University of Pennsylvania.
