## **Bridge dedicated to Shawn Blanton**

he Eastern Band of Cherokee Indians held a special memorial and dedication ceremony on Wednesday, June 17 when the #24 bridge in downtown Cherokee was dedicated to the late Trooper David Shawn Blanton (G540). Trooper Blanton served as the first EBCI enrolled North Carolina State Highway Patrolman in Troop "G", District 5 in Waynesville.

"As a father, I'm proud and humbled that my son would be honored in such a way," said David Blanton, Shawn's father. "His life is a testament to (the saying), 'it's not the amount of years you have on this earth; it is what you do with those years.""

Principal Chief Michell Hicks and Vice Chief Larry Blythe spoke about the impact Shawn had on the Cherokee community during the ceremony. Colleagues and superiors from the North Carolina State Highway Patrol who worked closely with Shawn also spoke about their time with Trooper Blanton. They commended the work of Blanton's family to help other fami-

lies in the community while preserving the memory and legacy of Shawn.

"This bridge will serve as a reminder to all who see it, that Trooper Blanton was a courageous hero that made the ultimate sacrifice so that we can all have hope," said Billy Clayton, Deputy Commander for the North Carolina State Highway Patrol.

Mollie Grant explained, "Every time he would get off a shift, he would drive down Soco Mountain and go across this bridge on his way home. With it being the seventh anniversary of his death and that number being sacred to the Cherokee, that was a reason why we wanted to name this bridge after him (today)."

At the conclusion of the ceremony, Mary Lambert, John Henry Maney, and Nikki Nations unveiled the sign that will be displayed on the newly named bridge.

Trooper Blanton valiantly served his community until he was fatally wounded during a routine traffic stop on I-40 near Canton

seven years ago.

"He was an overall great friend, and I miss him tremendously," said NC State Highway Patrol Officer Joe Henderson. "If you were having a bad day, you could hang out around him and he would brighten your day up. Even if he was in a bad mood, his laugh was just contagious."

## **Tribe asserts DV jurisdiction over non-Indians**

he U.S. Department of Justice has reported that American Indian women "are more than 2.5 more likely to be raped or sexually assaulted than women in the USA in general". The DOJ also reports, per its Bureau of Justice Statistics, that at least 70 percent of the "violent victimizations experienced by American Indians are committed by persons not of the same race."

Until recently, tribal courts throughout Indian Country did not have jurisdiction to prosecute non-Indians for these crimes. With the passage of the Violence Against Women Reauthorization Act (VAWA) of 2013, that changed.

On Monday, June 15, Principal Chief Michell Hicks signed Ord. No. 526 (2015) into law which amended various parts of the Cherokee Code to put it into line with the provisions of the Special Domestic Violence Criminal Jurisdiction outlined in VAWA.

"This is an incredibly historic day for the Eastern Band of Cherokees," said Chairperson Terri Henry who also serves as co-chair of the National Congress of American Indians Task Force on Violence Against

Women. "We have fought for many years for this particular piece of legislation."

She went on to say, "This provides limited jurisdiction to the Tribe, but it is an important first step in obtaining jurisdiction over non-Indians in Indian Country, and it's incredibly important across Indian Country. I am so proud of this Tribe."

"With the signing of this law, we will be able to fulfill our obligations and responsibilities to our people to keep this community safe from non-Natives perpetrators of domestic violence against our Native women."

Chief Hicks commented, "It's been a void in our system, and there's been a lot of hard work put into it (legislation)...our goal today was to get this Ordinance in place which outlines the law of the Tribe and the processes that we will follow."

He added, "I'm looking forward to seeing this thing in action, and I'm looking forward to addressing this issue which, unfortunately, has become a major issue on our lands and in Indian Country as a whole."

One part of Ord. No. 526 deals with changes to the jury selection process. "VAWA required tribes exercising this authority to provide defendants with a right to a tribal by an impartial jury that is drawn from sources that 'reflect a fair cross section of the community, and do not systematically exclude any distinctive group in the community, including non-Indians", the Ordinance states.

The Ordinance amends Cherokee Code Sec. 1-31, in part, to read, "Notwithstanding any other law of the Eastern Band of Cherokee Indians, or any of the tribe's agencies, eligible jurors shall be chosen from all individuals residing within the boundaries of the Eastern Band of Cherokee Indians trust lands regardless of race or tribal citizenship or tribal affiliation and not excluding any distinctive group in the community, including non-Indians."

Tribal Prosecutor Jason Smith called the legislation "a tremendous advancement". "We are hoping it will ultimately lead towards total sovereignty of tribal courts to prosecute all individuals committing crimes within tribal lands. It's going to make our job much, much easier in terms of streamlining the process because the federal system is not designed to handle domestic violence."

Smith said the federal system wasn't built to handle everyday domestic violence cases. "The tribal system is designed to handle our everyday criminal acts, such as things that happen at three in the morning, and it handles those cases much more efficiently. So, now that we'll have the ability to handle all of our domestic violence cases in the tribal system, I expect swifter justice and better justice for the people."

Powell will join the fifth charter of the CSRIC, which provides guidance, expertise and recommendations to the FCC to ensure optimal security and reliability of the nation's communications systems.

"It is an honor to receive this nomination and to have the opportunity to serve as a voice for rural and tribal communities while influencing advancements in our nation's communications systems," said Powell. "My focus is providing the best services to all citizens, continuing to bridge interoperability gaps and ensuring rural and tribal land is a consideration when making recommendations to the FCC."

The council addresses the availability of communications during natural disasters, terrorist attacks and other events that result in exceptional strain on the communications infrastructure, as well as the rapid restoration of communications services in the event of widespread or major disruptions.

"Mr. Powell is a valuable asset at CNI, leading teams in the areas of market strategy and research, partnership development, sales planning and business development," said Chris Moody, president of Cherokee Nation Industries. "As a leader within a tribally owned business, he provides a unique and valuable insight to the CSRIC that will be crucial for the future of communications in tribal entities and Indian Country."

Members of the CSRIC are appointed by the chairman of the FCC and selected from public safety agencies, consumer or community organizations or other nonprofit entities, and the private sector to balance various expertise and viewpoints.

The council's first meeting is set for Wednesday, June 24 in Washington, D.C.

## on the sidelines Let's hear it for the southpaws

hat do Larry Bird, Ty Cobb and a kangaroo all have in common? And, no, this isn't a joke. They are all left-handed, southpaws to some. A study published last week in Current Biology states that a research team from Saint Petersburg

search team from Saint Petersburg University in Russia has determined that all wild kangaroos "show a natural preference for their left hands when performing particular actions." Reading that study made me think of all of the great athletes who are or have been southpaws.

I have never had a left-handed bass so I just play a "regular" bass right-handed. One person there realized when watching me that I was playing righthanded and was just in utter amazement. To me, it was just an adjustment, one of many, which I've had to make to a truly righthanded world. Don't even get me started on scissors.

I've always thought that lefthanded athletes have an advantage. Righties don't know what we're going to do next, and they aren't used to how games are played from a left-handed perspective. Being a leftie volleyball player helped me out tremendously over the years. I was able to hit around blockers many times simply because they couldn't adjust to where the ball was coming from.

Some of the top athletes of all time have been left-handed including: Babe Ruth, Lou Gehrig, Wayne Gretzky, Bill Russell, Pele' and others. When you play against 90 percent right-handed people all of your life, it must be odd to suddenly be playing against someone who is playing completely opposite.

In 2007, scientists at the Australian National University published a study in the scientific journal Neuropsychology that looked at the reaction time in both right-handed and left-handed people. The study showed that lefties processed information 43 milliseconds faster than righties. That might seem miniscule, and it probably is, but every millisecond counts when you're trying to hit a 100 mph fastball.

I think the legendary W.C. Fields summed us lefties up best when he said, "If the left side of your brain controls the right side of your body, and the right side of your brain controls the left side of your body, then left-handed people must be the only ones in their right minds."

## Warriors raise money for Children's Home, in <mark>traditional</mark> way

he Warriors of Anikituwah saw a need within the community, and they're trying to do their part to help. During the recent Cherokee Voices Festival at the Museum of the Cherokee Indian, the Warriors raised \$511 that they will donate to help with the construction of the new Cherokee Children's Home.

Bo Taylor, a member of the Warriors of Anikituwah, said the group brought back a tradition that hasn't been done in nearly two centuries.

"What they would do when returning from a war party is lay a skin out. The warriors would come and throw some of their loot from their exploits, the spoils of war. They would tell about what they did and they would dance. All of the things that were collected were given to the widows and the children left behind of the warriors that didn't make it home."

He added, "It's kind of a way of taking care of them. It is right at about two hundred years since it's been done, but we did that so we could honor our Children's Home which is being

built. We knew that they were raising money, and the Warriors felt like we needed to give. We danced for them, and we raised \$511."

The new Cherokee Children's Home is being built on 28 acres located on Goose Creek Road in the Birdtown Community. When completed, the new Home will consist of two cottages, each with nine beds and other amenities.

"The Cherokee Boys Club and Cherokee Children's Home are extremely grateful to the Warriors of Anikituwah for their work and donation on our behalf," said Cris Weatherford. Cherokee Children's Home director. "We currently have two grants that require matching funds. One of these grants is with the RTCAR Program through the Agricultural Extension Office and the **Cherokee Preservation** Foundation. This grant is for an edible landscape for the new Children's Home facility. The new landscape will include as many varieties of edible fruits, nuts, berries and greens as we can grow. This will provide us with cultural learning opportunities for the children to learn how to cultivate, pick, prepare and eat food that can be grown locally."

Weatherford reiterated the importance of the donations. "These wonderful donations will be used at their maximum capacity to benefit this program. It is nice to know we have these guys fighting on our side!"

The Warriors of Anikituwah are also planning to raise funds for the Children's Home at the Cherokee July 4th Pow Wow during a Cherokee Warriors dance special they are sponsoring.

"We're going to do the same thing there and lay a skin out there and all money raised will be given to the Children's Home." said Taylor. "We're encouraging people to give and to help the Children's Home. It's our civic responsibility to try to take care of our young ones."

Taylor said the Warriors performing the dance have to pay to be able to be out there. "They have to give as well. They can't just go out and say, 'hey, it's a blanket dance'. They have to give in order to go out there and do it."

Taylor concluded, "From our Tribe that has so much, our kids need to be taken care of."

To date, the Cherokee Children's Home project has received funding from various sources including grants from the Cherokee Preservation Foundation and the HUD Indian Community Development Block Grant, a \$400,000 donation (\$80,000 a year for)five years) from the Eastern Band of Cherokee Indians. a \$100,000 donation from the Tribal Alcohol Beverage Control Commission, and the \$20,000 grant from RTCAR.

## Fair Committee Report – June 15 meeting

he third Cherokee Indian Fair committee meeting was held on Monday, June 15. Those in attendance were Chris Watty, Mariah Mahan, Frieda Huskey, Lisa Frady, Angela Hull, Angela Hernandez, Josie Long, Warren Dupree and Joletta Crowe. Discussion focused on coordination of labor for the event. With a limited pool of temporary workers, Events and Fairgrounds Supervisor Frieda Huskey stated that coordination of workers will be necessary to ensure that the event location job duties are prioritized first, then the remaining staff should organize the "temp workers" for day organizer

needs. She also advised the day organizers to provide names and contact information for anyone who might be interested in working at this year's Fair.

Huskey also communicated some deadlines for tentative day schedules and "proformas" (profit and loss documents detailing income and expenditures) for each day organizer. She also indicated that she needs prize money breakdowns for the games and other activities planned by the organizers. All monetary transactions between tribal personnel will be documented on a "chain of custody" form. All participants in competitions and activities at the fair will sign a liability release form. All winner of any monetary prizes will also fill out an IRS Form W-9.

Planning continues on Pretty Legs and Cherokee Idol. Chris Watty, the organizer for these activities, commented that materials and sign up forms will be available for Cherokee Idol within a few weeks.

Josie Long, parade day organizer, discussed preparation for grand marshals and continuing to work with the EBCI Agricultural Extension Office to identify artists and crafters to represent a collective body of Cherokee artisans on the grand marshal float.

Huskey advised that she is continuing to work on meetings with key participants, like the Miss Cherokee Pageant Committee and representatives from the stickball players. She stated that it is important to get their input as the schedules are firming up for the event. A stickball meeting, scheduled for after the Fair meeting, had to be postponed in observance of the passing of one of the players.

The Cherokee Indian Fair Committee invites anyone interested in helping with the planning process to attend their monthly meetings. The next scheduled meeting is Monday, July 20 at 5:30 pm.

The Cherokee Indian Fair will be held Oct. 6-10 at the Cherokee Indian Fairgrounds. The theme for this year's fair is "Weaving Dreams and Traditions Into Our Future".

#### CHEROKEE HISTORY A brief history of Cowee

####

here is a story recorded by James Mooney about a Shawnee who, at one time, was held as a prisoner by the Cherokees and later escaped. Years later, after a peace was made between the Cherokee and Shawnee, he returned to Cherokee country on a hunting trip. When he ran across some Cherokee men on a hunting trip, he asked: "Do you still have Cowee?" They replied; "Yes; we own it yet." He said back to them; "Well, it's the best town of the Cherokee. It's a good country, hold on to it."

Cowee was one of the most important Cherokee towns. The root word of the name is believed to come from "kawi yi" or "deer clan place". This would mark Cowee as a center of diplomacy, where leaders from the various Cherokee towns would meet to settle issues, and possibly prevent a situation that had to be settled by a ballgame, where men could potentially be killed.

Located at the mouth of Cowee Creek on the Little Tennesse River, Cowee was a large town with a mound built at the base of a ridge, giving the council house that was there a commanding view of the entire valley.

Cowee was destroyed on the Rutherford Expedition in 1776. At that time, there were about 100 homes that made up the town. Cowee was rebuilt and remained a

Under provisions in the Treaties of 1817 and 1819, about 21 Cherokees including Oochella (or Euchella) attempted take square mile reservations to protect Cowee and neighboring town Joree. Like most who took those reservations, they were driven off of their land in 1820 by white citizens who purchased the properties at an auction authorized by the state of North Carolina.

In 2006, the EBCI partnered with the Land Trust for the Little Tennessee (LTLT) to purchase around 70 acres that includes the Cowee mound. There is still more to share about Cowee in upcoming articles, so stay tuned!

## **Business Spotlight: The Little People**

lle Bradley is capital-izing on a major opportunity presented to the Cherokee youth of today by investing the money she received from the Minor's Fund distribution into the startup of her own business, The Little People. After meticulously researching the market and weighing the options at hand, she elected to open the children's boutique a fill a void currently missing in the surrounding marketplace.

"Owning a business didn't really enter my mind until about a year and a half ago," said Bradley. "My mom influenced me the most because she's very business minded. She teaches business and has a MBA from Western (Carolina University). She really inspired me to do this because she always talked about how great it could be to own your own business."

Bradley is a 20-yearold entrepreneur from the Wolfetown Community. She graduated from Cherokee High School and is currently a rising second semester junior at Western Carolina University where she is majoring in psychology with a minor in business administration. She was recently awarded the Robert Lee Madison Schol-

arship at WCU for accomplishments in the classroom and community.

Bradley's business, The Little People, is a children's boutique which specializes in children's clothing not typically found in regular retail department stores. The boutique specializes in high-end formal wear a child would normally wear to weddings or church, but also contains casual styles to fit everyday children's fashion. While the business is in its infancy, Bradley plans to expand their current product offering but for now, offers a wedding and baby shower gift registry where customers can sign up.

Bradley began the process of starting her own business in early 2014 after receiving her Minor's Fund distribution. Along with the mandatory online course the youth receive before receiving the distribution, Bradley borrowed from her mother's business experience and took advantage of the programs available to EBCI tribal members, such as the Sequoyah Fund, to open her shop in the bustling area of downtown Cherokee. However, along with the risk of starting up a business, Bradley has put a lot of hard work into seeing the project come into fruition.

"There was a lot of labor work that needed to be done, such as painting the walls and making the store look very child-like before we opened," explained Bradley. We also took some time to find vendors to get our clothes so we had a good inventory by the time we opened."

"It's a learning thing, I just learned as I went and had help from other people and business owners. It's a lot different than going to work for somebody else because right now, I'm my own boss. I set the hours, I decide what we sell. and who, as a business, we interact with in terms of other business'. I think it's a really great opportunity for me, whether it's a success or not, to be a good learning experience. "

When asked about what advice she would like to pass along to other people who may be receiving their Minor's Fund distribution, Bradley said, "Plan wisely. It's a lot (of money) at the time but you will probably never come into that large sum of money at one time again in your life. Talk to people who know what to do with money and how you can invest it, how you can make it grow. It's not going to last forever and it's really easy to have \$90,000 one day and have \$60,000 the next. Even if you get the money, I would advise you to get a job anyway because if you keep spending it and not putting it back, you're just losing it."

### Wilnoty makes appearance at Exhibit Opening



SUMMARY: The Eastern Band of Cherokee Indians (Tribe) has requested that the Bureau of Indian Affairs (BIA) transfer approximately 345.19 acres into federal trust for the benefit of the Tribe. The property proposed for trust status is located adjacent to the Tribe's Reservation (Qualla Boundary) on Coopers Creek Road to the west of the Ela Community in Swain County, North Carolina. The Tribe has identified the need for additional safe and sanitary housing for tribal members and will potentially be using this property in the future for housing needs. Due to the need for federal approvals, this project was reviewed in accordance with the National Environmental Policy Act (NEPA) and the National Historic Preservation Act.

The BIA has reviewed and adopted the Environmental Assessment (EA), dated July 2014, prepared Analytical Environmental Services entitled "Coopers Creek Housing Project" to determine the environmental impacts that may result from the project. Although there would be no environmental impacts associated with the BIA's administrative approval of the Tribe's application, the housing project was considered a "connected action" as defined by 40CFR 1508.25. All environmental impacts associated with the entire project were evaluated and considered throughout the EA. The EA is well written and considers all potential impacts to the human environment that may be associated with the project.

Based on review of the EA and supporting documentation, the BIA has made a Finding of No Significant Impact (FONSI) for the proposed action of transferring the property into federal trust.
