# Tribal Member charged with Murder in Fatal Stabbing

**R**obert Benjamin Smith, 24, of Cherokee, has been charged in a federal criminal complaint with murder in connection with a fatal stabbing which allegedly took place on the Cherokee Indian Reservation on Oct. 22. The announcement of the charges was made on Monday, Nov. 1 by U.S. Attorney Anne M. Tompkins of the Western District of North Carolina, Owen D. Harris, Special Agent in Charge of the FBI, Charlotte Division, and Ben Reed, Chief of the Cherokee Indian Police Department.

According to information contained in official court documents filed Oct. 29, Smith, an EBCI tribal member, faces a maximum statutory penalty of imprisonment for life if convicted. Smith remains in custody in Cherokee on Tribal warrants, which were issued on Oct. 26,

and will make his initial appearance in federal court in Asheville at a later date.

Under the Federal Rules of Criminal Procedure, a defendant arrested on a federal criminal complaint is entitled to a probable cause hearing within ten (10) days of his/her arrest, unless indicted or unless a criminal information against the defendant is filed in U.S. District Court before the passage of ten days.

The case is being investigated by the FBI and the Cherokee Indian Police Department, and being handled for the government by Assistant U.S. Attorney Don Gast of the U.S. Attorney's Office in Asheville.

The public is reminded that a criminal complaint contains mere allegations and that a defendant is presumed innocent unless and until proven guilty in a court of law.

# Bat Creek Stone Research Presented to Tribe

## Wolter examines Mysterious Stone

Scott Wolter, forensic geologist, presented his findings on the Bat Creek Stone in Tribal Council Chambers on Wednesday, Oct. 27. This artifact was excavated from a Cherokee mound in 1889, and is inscribed with writing, that according to Wolter's forensic examination, is older than its date of excavation in 1890, and may in fact be thousands of years old.

"If this artifact shows European contact with the Cherokees two thousand years ago, then this is a significant part of Cherokee history," said EBCI tribal member Don Rose, who commented after Wolter's presentation.

Wolter conducted microscopic examination of the artifact at the University of Tennessee in May of 2010, and then used their Scanning Electron Microscope to conduct a more in-depth study. He concluded that the most modern marks on the stone were made after 1890.

Another mark that he examined

was made by a metal probe when the stone was excavated in 1889. He found that the inscription was carved much earlier, be-

cause the grooves in the letters were weathered much more than the other marks. The other items found with the

stone in the mound were dated to about 100 AD.

"The best research shows that the inscription is in Paleo-Hebrew," Wolter said, citing the work of Hugh McCullough.

Other scholars have claimed that the text is Phoenician, ancient Cherokee, or a hoax. Wolter has written several books and produced several documentaries for the History Channel about European contact in America before Columbus, including "Who Really Discovered America" aired this year.

The Bat Creek Stone is currently on display at the McClung Museum at the University of Tennessee. It is on loan from the Smithsonian, who financed the original excavations of the Bat Creek Mounds, a few miles west of present-day Vonore, Tennessee. The Smithsonian's purpose was to determine who the Moundbuilders were, and Cyrus Thomas concluded that they were the ancestors of the present-day Cherokees.

# Jury Convicts Fake Lawyer

**LAREDO, TX**—A 28-year-old Dallas area resident who falsely represented himself to the U.S. District Court in Laredo to be a lawyer licensed to practice law has been convicted by a federal jury of two counts of obstructing the due administration of justice and filing a motion with the court containing false representations, United States Attorney José Angel Moreno announced today. The jury returned its verdict late on Wednesday, Oct. 20.

Dale Allen Richardson Jr., 28, of Plano, Texas, was convicted of obstructing the due administration of justice in each of two court appearances before United States Magistrate Judge J. Scott Hacker and of making false statements in the pro hac vice motion filed with the court. Richardson has been ordered detained without bond pending his sentencing hearing Jan. 13, 2011, before U.S. District Judge Micaela Alvarez.

All three counts of conviction arose from Richardson's unlawful representation of a defendant in a criminal case pending before U.S. Magistrate Judge J. Scott Hacker.

During the course of the two-day trial before U.S. District

Judge Micaela Alvarez, testimony, including that of Judge Hacker, proved that on June 4, 2010, Richardson appeared before Judge Hacker in the Southern District of Texas (SDTX) District Court, Laredo Division, representing himself as the attorney for an alien defendant charged in cause No. 5:10-po-3410. The defendant in that case had been arrested by the United States Border Patrol and charged with the misdemeanor offense of illegally entering the country.

Richardson, who had been hired by the defendant's family, appeared in court as an out-of-town attorney. On that date, Richardson claimed the defendant had a meritorious immigration appeal pending and attempted to negotiate with a federal prosecutor for the dismissal of the criminal case. Based upon Richardson's representations, Judge Hacker reset the case for June 29, 2010, to allow Richardson time to continue plea discussions.

On June 29, 2010,

Richardson again appeared in federal court before Judge Hacker. Both the government and Richardson asked the court to dismiss alien defendant's case based upon Richardson's statement as an attorney and officer of the court regarding the status of the defendant's immigration appeal.

That same day, Richardson filed a pro hac vice motion requesting the court's permission to temporarily appear in the SDTX court to represent the defendant. In his motion, Richardson identified himself as the "Law Office of Dale Richardson, P.C.," and claimed to be licensed by the Massachusetts Bar Association and the Cherokee Nation Bar Association.

However, the U.S. District Court Clerk's Office could not verify a license in the Commonwealth of Massachusetts for Richardson. In response to a request from the clerk's office to confirm the information provided and request for additional documentation, Richardson re-submit-

ted the same information, which included a copy of a badge emblazoned with the words "Attorney," "Officer of the Court," and "Cherokee Nation."

The FBI conducted an investigation of the matter. Through that investigation it was learned from Richardson's business cards and a web page for his "law firm" that Richardson advertised himself as a "US Immigration Attorney" and a "federal defense attorney" with an office in Farmers Branch, Texas.

In 2009, Richardson had sought to be admitted as a licensed attorney in federal court in the Eastern District of Oklahoma and in 2010 had represented at least two clients, including Reyes, in immigration court in Dallas, Texas.

However, the FBI's investigation found that despite his representations, Richardson was not licensed by the Supreme Court of the Commonwealth of Massachusetts. His membership in the bar association, a non-profit voluntary organization

serving the public and the legal profession, did not authorize Richardson to practice law.

The FBI also determined that while Richardson had gained admission to the bar of the Supreme Court of the Cherokee Nation in Oklahoma in 2009, he did so by stealing the bar number of an attorney with a similar sounding name who is licensed in California.

During trial, a clerk for the Cherokee Nation Supreme Court testified that Richardson was disbarred on Oct. 4, 2010, and that she had never seen a badge like Richardson's "Attorney" badge because the court does not issue them to its licensed attorneys. The mother of the alien defendant testified that although Richardson claimed he was not going to charge her for helping her son in the criminal case, she was going to help grow his law practice by referring clients.

Assistant United States Attorney Diana Song prosecuted the case.

# Wreath-laying Ceremony planned for Junaluska Gravesite

**J**unaluska Memorial Site and Museum will host the annual Junaluska Wreath Laying Ceremony on Friday, Nov. 12 at 10:00. This year is a special celebration that marks the 100th anniversary of the commemoration of the Junaluska gravesite monument.

Junaluska gained fame for his participation in the Battle of Horseshoe Bend. It was there that the Cherokee Nation assisted Andrew Jackson's Tennessee forces in the defeat of the Creek Nation in 1814. Junaluska is credited for recruiting 100 Cherokee warriors from North Carolina for the American cause.

Upon returning from Alabama, Junaluska returned to his home in Sugertown, today the town of Franklin. He lived there until being forced off of his land due to the state of North Carolina's zeal to acquire land ceded under the

Treaty of 1817.

Junaluska moved with his wife and children to Valleytown, in present day Andrews, NC, sometime around 1822. They were joined by his family, including brother's Wachacha and Scoya. Also moving from Sugertown were Junaluska's sister Rebecca and her white husband, Gideon Morris, as well as family friend John Welch.

During the removal of 1838, Junaluska departed with a detachment led by the Reverend Jesse Bushyhead on September 3, on the infamous Trail of Tears. Several weeks later Junaluska and Wachacha led a group of 50 others who deserted their detachment and attempted to return to their homes. Junaluska led a group of 25 older people while his little brother led a younger group of 25. Junaluska's group was captured just north of Knoxville, Tennessee and forced to re-

move to Indian Territory.

A couple years later, Junaluska made his way back to North Carolina, and returned to his home place along Valley River. Because of his heroic status, the state of North Carolina granted Junaluska 337 acres of land in 1847. A large portion of his land is now a part of the present day town of Robbinsville.

Junaluska passed away on November 20, 1858. He was buried on the land granted to him, along with his third wife Nicie. In 1910 the General Joseph Winston Chapter of the Daughters of the American Revolution placed a monument at his gravesite. This property was donated to the EBCI in 1998, when the Friends of Junaluska assumed responsibility for the memorial site and museum. In 2001, the EBCI Cultural Resources Office (Kituwah Preservation and Education Program) began managing the site.

The centennial event will begin at 10 a.m. Parking for this year's event will be at the Robbinsville football field. Shuttles buses will begin at 9:15 to transport you to the museum. For those unable to walk to the monument, assistance will be provided. Lunch will be provided after the event.

Those who are assisting with this year's event include the Kituwah Education and Education Program, Junaluska Youth Leadership Council, Graham County Indian Education, the American Legion Post 143, the EBCI Office of the Principal Chief, Robbinsville High School, Swain County High Schools, and the Snowbird Community.

## Manage Your EBCI Money program to start in '11

In June, the *One Feather* reported on an exciting educational resource recently produced for the Eastern Band, the Manage Your EBCI Money online financial education program. Created as a response to the pressing need to provide personal finance skills to Cherokee youth, the web-based curriculum was successfully piloted earlier this year with student groups who found its subject matter convenient to use, practical to apply, and relevant to their own lives.

So relevant in fact that on Sept. 9, the EBCI Tribal Council voted unanimously to approve a resolution from the Junaluska Youth Leadership Council which will make completion of the Manage Your EBCI Money curriculum a requirement for recipients of the Minors' Trust Fund.

EBCI Financial Skills Educator, Keith Sneed, has been the inspiration behind Manage Your EBCI Money since its

inception last year and believes an online program is the best model to present money management training to tribal youth.

"The Eastern Band has been blessed with a financial windfall from Harrah's Casino and its other business ventures, while growing per capita payments to tribal members help to highlight these accomplishments," Sneed stated during an interview from his office at the EBCI Cooperative Extension Center.

"Unfortunately many of our children and their parents lack the skills necessary to effectively manage such large sums of money, sadly causing some families to suffer dire consequences. Manage Your EBCI Money will fill that void by giving our youth access to the quality financial education they deserve."

Created by First Nations Development Institute, a Longmont Colorado based non-profit that specializes in personal finance training for Native communities, Manage Your EBCI Money is

designed to take students about three hours to complete and includes lessons on managing a bank account, using credit responsibly, car buying and insurance, basic investing, avoiding scams, and understanding taxes. The website requires a username and pass code for security purposes and is accessible from any internet ready computer while those without web access are welcome to use computers in Sneed's office to utilize the program. All customized lesson content which includes financial calculators, downloadable budgeting worksheets, and informational videos are specifically designed for the EBCI community and funded by a generous grant from the Administration for Native Americans.

Feedback from students who have already completed the program has been overwhelmingly positive. Cherokee High School junior, Brittany Arch (Big Cove/Wolftown), enjoyed piloting Manage Your EBCI Money and found the information valuable.

"I liked the website a lot," Arch commented. "It taught me ways to manage my money after I graduate, such as how to make a spending plan and how to invest for my future."

In closing Sneed explained that seniors graduating in the spring of 2011 who are applying for the Minors' Trust Fund will be the first class subject to the financial education requirement. He also stated that letters will be mailed to applicants' households later this year with detailed instructions on how to complete the online course. In the meantime he is available to answer questions regarding the website and the new policy, and invites any enrolled member interested in checking out the site to stop by his office for a tour.

## Native Artist Fellowships available from IARC

The Indian Arts Research Center (IARC) at the School for Advanced Research (SAR) offers four artist-in-residence fellowships annually to advance the work of mature and emerging Native artists. Each fellowship includes a \$3,000 monthly stipend, housing, studio space, supplies allowance, and travel reimbursement to and from SAR. These fellowships provide time for artists to explore new avenues of creativity, to grapple with new ideas to further advance their work, and to strengthen existing talents.

The fellowships support diverse creative disciplines such as sculpture, performance, basketry, painting, printmaking, digital art, mixed media, photography, pottery, writing, and film making. Artist fellows must live on the SAR campus, complete a project resulting in the creation of one or more works, and make a public presentation at the end of their fellowship. While in residence, artists can access the IARC collection of Native

arts for research and study. Additionally, SAR would like to see the fellow's work represented in the object, archives, or photo collection; therefore, IARC requests the donation of a single piece created while working at SAR. If selected for the fellowship, artists must agree to participate in interviews, photo sessions, video recordings, and exit interviews to document the fellow's process and progress. This information will be entered into the IARC archives to serve as a permanent public record.

Submit the following materials by the Jan. 15, 2011 application deadline:

- Completed application form
- Current résumé (include education, relevant training, awards/honors, exhibitions, performances)
- Artist statement, no more than two pages in length
- Examples of your current work (will not be returned) as described below:

Visual Art: Submit 8 slides, print images, or CD of images (in jpeg or tiff

format) of recent work. Each slide/image should indicate your name and a number corresponding to numbers on an accompanying sheet listing all slides/images submitted, along with the title of the piece, medium, size, and year of completion. Do not send portfolios or original work.

Writing: Writing samples should be photocopies of published work or clean, double-spaced, numbered manuscript pages in a common font so it is easy to read. Samples should not exceed 20 pages. Your name and the date of completion should appear on the sample. Do not send books or bound manuscripts.

Documentation of a stage or film production on VHS or DVD may also be included if applicable. Writers are encouraged to apply for the Lannan Fellowship.

Film/Video: Submit VHS videotape or DVD. Film/video scriptwriters should also send a script. Label each sample with your name, title, duration,

and date of work. If your project is focused more on writing, please consider applying for the Lannan Fellowship.

Dance/Performance Art: Submit VHS videotape or DVD. Label sample with your name, title, duration, and date of work.

Composers: Submit a CD, DVD, or cassette containing up to three works (labeled with title, your name, date completed, duration of composition), and, if available, the corresponding scores for the work. Total audio sample should not exceed 30 minutes and may be composed of entire pieces or excerpts.

Other Artists: If your project does not fall clearly within one of the above disciplines, please contact the IARC to discuss an appropriate work sample.

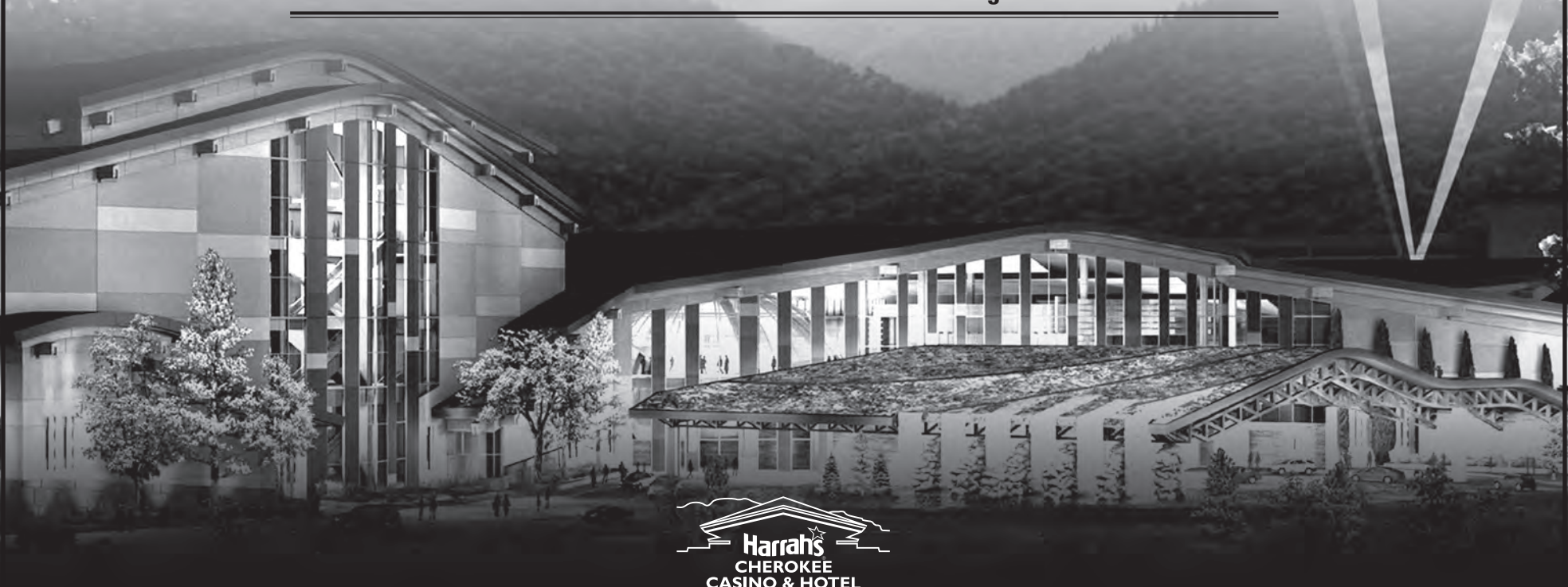

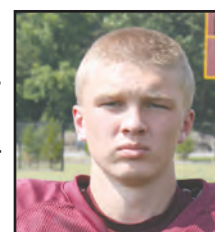

FRANKLIN — The Cherokee Mites capped off their season by defeating the Murphy Bulldogs 12-6 to win the 2010 Cracker Bowl on Saturday, Oct. 30. Cherokee DB Isaiah Evans picked off a Murphy pass with less than a minute left in the game to seal the victory for the Braves.

Cherokee got the ball first to start the contest, but were unable to move it and turned it over on downs. Murphy took over 1st and 10 at the Cherokee 49-yard line.

On second down, Cherokee's Isaiah Bradley intercepted a ball and returned it 20 yards to the house for the first score of the game. The two-point conversion failed and Cherokee led 6-0 at the 2:48 mark in the first quarter.

Murphy started their next drive at the Cherokee 40-yard line. Following an off-sides penalty on the Braves and a subsequent holding penalty by the Bulldogs, Murphy's Kadrian McCray ran the ball on first down to the 7-yard line.

Cherokee's defense held tight on the first two downs, but McCray ran it in for a score from six yards out on third down. The two-point conversion failed and Murphy tied the game at 6-6 with 2.6 seconds left in the quarter.

The Braves started the second quarter at their own 48-yard line. Evans got the call on the next two plays and carried the ball to the 23-yard line on rushes of 16 yards and 9 yards.

On the next play, Braves QB Ty Mintz bolted 23 yards for a touchdown to put Cherokee up again. The two-point conversion failed and Cherokee led 12-6 with just over seven minutes left before the half.

The Bulldogs started their next drive at their own 39-yard line, but it was short lived as they put the ball on the ground on third down. It was recovered by the Braves who set up shop at the Bulldogs 45-yard line.

Low Income Energy Assistance Program

The Low Income Energy Assistance Program gives families a one-time cash payment to help pay their heating bills. This program is open to all residents of Jackson County. Applications will be accepted at Jackson County Department of Social Services located at The Bureau of Indian Affairs, November 1, 2010 through November 12, 2010. The office will be closed Thursday, November 11th in observance of Veteran’s Day. Applications may be made Monday through Friday between the hours of 7:30 a.m. and 4:00 p.m. Applications will not be accepted before November 1st or after November 12th. The office will have extended hours on November 4th from 7:30 a.m. until 8:00 p.m. All eligible households will receive a payment around the first of February 2011.

Food and Nutrition Service households that meet Low Income Energy guidelines will automatically receive a payment for heating costs. These households received a notice in mid October. If your household has not received a notice, or if you received a Notice of Denial, you may apply in person, at the Jackson County Department of Social Services, between November 1 and November 12, 2010.

**Families must meet the following guidelines to be eligible:**

- 1.The household’s total income must be equal to or below 110% of the federal poverty level.
- 2.The household must be responsible for it’s heating bills.
- 3.The household cannot have assets over \$2,200.00, excluding primary home and automobiles.
- 4.The household must include a U.S. citizen or an eligible alien.

The applicant should bring proof of October gross income, information about any household bank accounts, stocks, bonds, property and other assets, and social security numbers for all household members.

**Once all applications are processed, payment amounts are based on:**

- 1.The total number of eligible households to be served by the program.
- 2.The total income for each household.
- 3.The number of household members.
- 4.The type of heat the household uses.
- 5.The region of the state where the family lives.

## Q&A on the New Manage Your EBCI Moeny Program

**Are you an enrolled EBCI member who will graduate from high school in 2011?**

If so, a new requirement passed by Tribal Council, Ordinance No. 401 (effective April 1, 2011), states: "Any minor member, applying for their minors trust fund, will be required to complete the on-line Manage Your EBCI Money Course (manageyourebcimoney.org) and include his/her Certificate of Completion to be entitled to receive any monies."

**So what does this mean for me?**

What it means is that before you can get your trust fund money, you are going to have to complete a short online financial education course, called Manage Your EBCI Money, in addition to complet-

ing your high school education or GED. **What is the Manage Your EBCI Money course?**

An exciting new website specially designed just for you, EBCI youth, and dedicated to the fascinating world of personal finance. The site is loaded with valuable information such as a financial calculator that will show you how long it will take to become a millionaire if you start investing your money when you're young (hint: before you are 40 if you play your cards right!), fun car buying factoids to help you make an informed decision regarding your next auto purchase, and even music videos geared towards a host of relevant financial topics such as identity theft, understanding credit cards, and managing your bank account; all for the purpose of assisting you with making the most of your EBCI money!

**So how do I access the website?**

Type manageyourebcimoney.org into the browser window of any web accessible computer and press enter. You will see a log-in screen with directions that you can take from there. You will need a valid email address as well.

**Is the website complicated or difficult to understand?**

The program is divided into 8 different learning modules and will take about three hours to complete. Each module contains a short quiz and you will have to answer 4 out of 5 questions correctly to move on to the next module. There is no time limit and you can retake the quizzes as many times as you need until you pass.

**What if I do not have a computer or access to the internet?**

You can stop by the Qualla Financial Freedom office located inside the

EBCI Cooperative Extension Center at 876 Acquoni Rd to use a computer there. And more satellite computer stations will be coming soon.

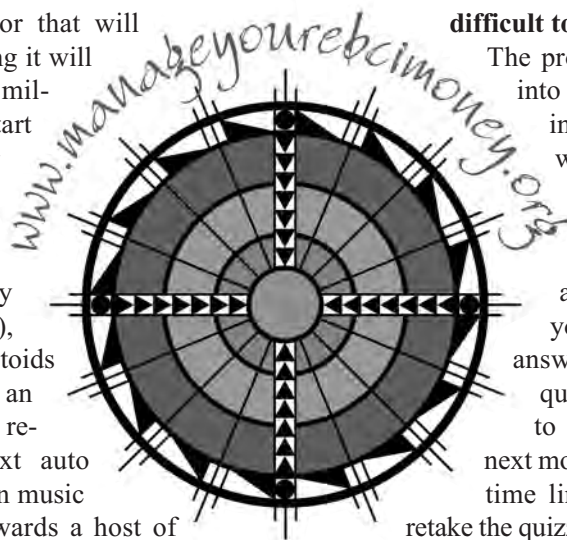
**Why am I being required to take an on-line course and why was this not started sooner?**

## Tabled EBCI Legislation

**Tabled Ordinance No. 503 (2010)  
Submitted by Angela Wolfe**

WHEREAS, the Eastern Band of Cherokee Indians has the sovereign authority to create laws that protect the health and welfare of its children; and

WHEREAS, the Eastern Band of Cherokee Indians recognize and honor the special status of children in its culture; and

WHEREAS, it is the right of all children to have the sanctity, innocence and purity of childhood protected by tribal law; and

WHEREAS, sexual abuse against a child is currently and historically intolerable in our Cherokee culture and society; and

WHEREAS, it is the duty of the Eastern Band of Cherokee Indians to allow a parent or custodian of a child to protect that child from the risks of harm inherent to it if the accused child abuser has unfettered rights of access to that child during the investigation of the child abuse.

NOW, THEREFORE BE IT ORDAINED by the Tribal Council of the Eastern Band of Cherokee Indians in annual council assembled, at which a quorum is present, that Chapter 50, Article II, Section 50-12 of the Cherokee Code shall be amended to read as follows:

Sec. 50-12. Other family law issues.

(E) It shall be grounds for denial of custody and/or visitation to a party in a custody action if such party to the action has been convicted of, entered a plea of guilty or no contest to a crime of a sexual nature against a child, as codified under tribal law or the law of the jurisdiction in which the person was charged,

regardless of where the crime took place or the sentence issued.

(F) A party to a custody action accused of a sexual act against a child, and such allegation is contained in any legal pleading before the court or a criminal charge in any jurisdiction, shall be grounds for requiring supervised custody and/or visitation until the merits of the allegation have been fully adjudicated, tried or finally resolved.

BE IT FURTHER ORDAINED that this ordinance shall be effective upon ratification by the Principal Chief and that all prior ordinances and resolutions that are inconsistent with this ordinance are rescinded.
