# Braves blast Andrews 40-16, finish 2nd in Conference

**A**NDREWS – The Cherokee fans who braved the driving rain on the drive down to Andrews to watch the JV Braves (5-1) take on the Andrews JV Wildcats on Thursday, Oct. 9 were treated to clear skies, a rainbow and a pot of gold at the end. Cherokee won the game 40-16 and took second place overall in the Smoky Mountain Conference.

“It’s been a fun year with these guys,” Chris Mintz, JV Braves head coach, said after the game. “These guys have been really exciting to watch. It’s been fun to watch them grow, and to come from being 0-6 last year and to turn it around and play with confidence has been fun to watch.”

Tye Mintz, JV Braves quarterback, had a nice night as he ran for one touchdown, threw for two, returned a punt for a touchdown and returned an interception for a touchdown. Isaiah Evans, JV Braves running back, ran for one touchdown and caught a 93-yard bomb

from Tye Mintz for another score.

Cherokee got the ball first in the game, but had to punt following a three-and-out. Andrews started the exact same, and was forced

to punt facing a 4th and 12 deep in their own territory.

Evans received the punt for Cherokee at the Andrews 40-yard line and returned it to the 15-yard line. On first down, Tye

Mintz ran it in from 15 yards for the first score of the game. Evans ran for the two-point conversion and Cherokee led 8-0 midway through the first quarter.

The Wildcats started their next possession at their own 43-yard line and Cherokee’s defense held tight again. Following a sack on third down by Cherokee’s Damian Blanton, the Wildcats were forced to punt again.

Tye Mintz received the ball at his own 30-yard line and returned it 70 yards for a touchdown. The two-point conversion failed and Cherokee led 14-0 with four minutes left in the first quarter.

Andrews was unable to move the ball again and were forced to punt following another three-and-out. Cherokee was flagged for a personal foul on the punt return and started deep in their own territory on their own 7-yard line.

That didn’t phase them one bit though. On first down, Tye Mintz connected with Evans on a 93-yard bomb for the third score of the quarter. The two-point failed and Cherokee led 20-0 with 1:31 left in the first.

Andrews started their next possession at their own 35-yard line and put together a seven play drive that culminated in an 8-yard touchdown pass. The two-point was good and



Cherokee led 20-8 at the 8:17 mark of the second quarter.

Cherokee threw an interception on their next possession, but the Wildcats would only have the ball for one play as Holden Straughan, JV Braves cornerback, intercepted the ball at the Cherokee 34-yard line.

The Braves were unable to move the ball though and had to punt. Andrews turned the ball over on downs on their next possession, and Cherokee took over at their own 46-yard line with just under two minutes left in the half.

On first down, Evans cut through the Wildcats defense and took it 54 yards to the house. The two-point play failed and Cherokee took a 26-8 lead into halftime.

Andrews got the ball first in the second half, but turned it over on downs at their own 49-yard line. On first down, Tye Mintz connected with Straughan on a pass to the Andrews 36-yard line. Several plays later, the Braves found themselves with a 1st and 10 at the Andrews 15.

Tye Mintz ran for what seemed to be a touchdown on first down, but a holding penalty said otherwise. Several plays later, Cherokee would find the end zone though as Tye Mintz threw to a wide-open Wesley Wildcatt for a 9-yard touchdown. Wildcatt also

caught the two-point conversion to make it 34-8 midway through the third quarter.

Cherokee would get back into the end zone very quickly. Andrews started their next possession at their own 43-yard line, and Tye Mintz would intercept a pass at the 45 and run it all the way back for a touchdown. The two-point failed and Cherokee led 40-8 with 4:41 left in the third.

Andrews would add a score late to make it 40-16, but it was too late as Cherokee took the win.

She will serve as a resource to the Chief Medical Officer and other Indian Health Service staff at Headquarters.

Dr. Winchester stated, "My primary focus has always been to help provide the very best quality healthcare for elders in this community. I am so happy to be able to stay here and do clinical work, but also use resources and collaborate to accomplish these goals on a larger scale for both geriatrics and palliative care within the Indian Health Service. This is an exciting endeavor."

In accepting this position, Dr. Winchester will help IHS achieve its mission by raising the health

of American Indians and Alaska Native people to the highest possible level.

# Cherokee Museum to present Cherokee Pottery talk on International Archaeology Day

The Museum of the Cherokee Indian will present "Cherokee Pottery: Three Thousand Years of Cherokee Science" on Friday, Oct. 17 at 2 pm. This talk is part of International Archaeology Day, sponsored by the Archaeological Institute of America. It is open to the public free of charge, and is suitable for all ages.

"We are glad to be participating in International Archaeology Day this year," said Bo Taylor, Museum executive director. The talk will include examples of Cherokee pottery beginning with fiber tempered pottery through the work of contemporary Cherokee potters who have revitalized old techniques.

Barbara R. Duncan, Ph.D., Museum education director, will talk about the art

and science involved in Cherokee pottery, providing examples of reproduction

pots which participants can examine hands-on. The talk will cover the fab-

ric-impressed Swannanoa pots of 900 B.C., the shell-tempered pots of the Cherokee Overhill Towns, Mississippian effigy pots and fire pots, and Qualla pottery 1300 A.D. through today. Beginning in 2003, potters from the Eastern Band began bringing back old styles and techniques, and their work will be discussed as well.

# Jeremy Hyatt joins SCC board of trustees

**S**YLVIA - A few years have passed, but Jeremy Hyatt, an EBCI tribal member, vividly and fondly recalls the faculty and staff members who helped him start his higher education at Southwestern Community College shortly after he graduated from Swain High School.

Those experiences are a major reason he now wants to give back to SCC as a member of its board of trustees. Appointed by Gov. Pat McCrory to represent the Qualla Boundary, Hyatt was sworn in as a trustee on Wednesday, Oct. 8, at Southwestern's Jackson Campus.

"I don't believe everybody is ready for a larger university when they first graduate from high school," Hyatt said. "This institution helps prepare you for that. Southwestern allows a young person to get started in college, and it allows you to figure out where you want to go in life. SCC certainly did that for me."

"It allowed a small-town boy like me to adjust to college life with the smaller classes," Hyatt added. "And the faculty and staff, I could go on and on forever about them and the fine job they did in preparing me."

After his time at Southwestern, Hyatt went on to complete his bachelor's degree in anthropology from Western Carolina University in 2000.

He's now the director of natural resources and construction for the Eastern Band of Cherokee Indians. When Principal Chief Michell Hicks mentioned the opening on SCC's board of trustees, Hyatt did not hesitate to accept Hicks'

offer to recommend him to the governor.

"I want to give back to this institution that has given me so much and done so much for me," Hyatt said. "When Chief Hicks told me about this opportunity, I jumped at it. I am absolutely up for this challenge."

Hyatt's appointment is for a four-year term that will run through June 30, 2018.

"We're are very proud to have Jeremy joining our board of trustees," said Dr. Don Tomas, president of SCC. "He brings tremendous leadership skills, and his perspective as a former student is invaluable to us as we make decisions that will shape Southwestern's future. We all look forward to working with him in the weeks and years ahead."

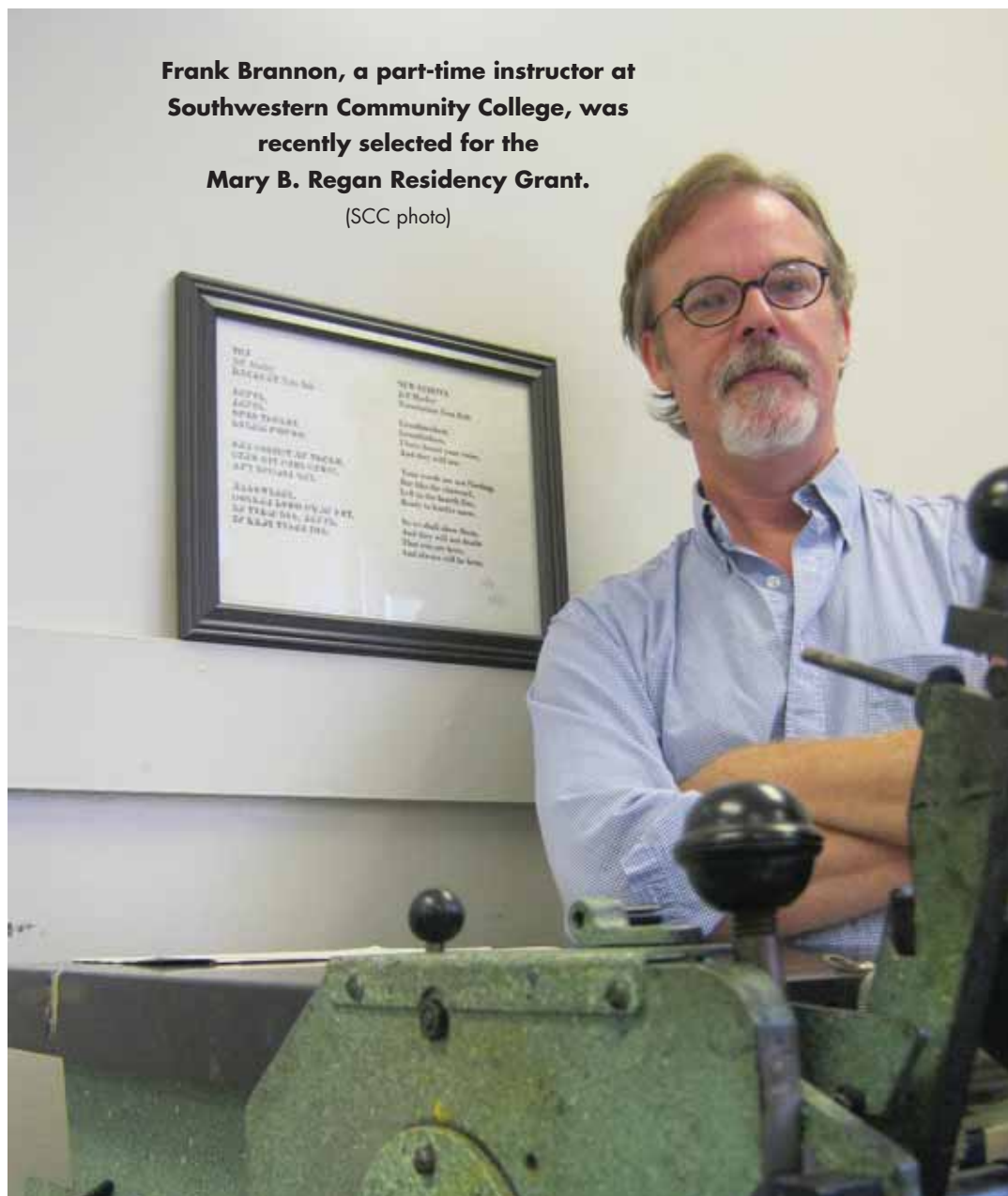
# SCC instructor to use grant to further syllabary printing

**S**YLABA - Frank Brannon, a book artist from Dillsboro and adjunct instructor at Southwestern Community College, has been selected for the first Mary B. Regan Residency Grant for a project to revitalize the Cherokee language through his artistry as a letterpress printer.

Brannon's one-year project is based on his work with a program he supports at SCC's Swain Center, near Cherokee, where students are learning the art of printmaking by printing materials using the Cherokee syllabary. The 85-character syllabary was developed in 1821 by Sequoyah - a silversmith, blacksmith and artist - making it possible to read and write the spoken language of the Cherokee.

Working with translations from the Cherokee Studies Program at Western Carolina University, Brannon uses manual printing techniques to preserve the language and its original Cherokee syllables. In a series of public workshops, members of the surrounding communities will produce prints that will culminate in an edition of handmade books. The workshops will be held at the Southwestern Community College printing studio as well as Brannon's own studio in Dillsboro.

"Like many languages

around the world, the Cherokee spoken language is struggling to continue as there are fewer and fewer speakers," Brannon said. "As a book artist I thought about how we might print in Cherokee in this way to support Cherokee language revitalization."

His master's of fine arts degree thesis was Cherokee Phoenix: Advent of a Newspaper, which focused on the historical 19th-cen-

tury newspaper, the Cherokee Phoenix, which was printed in both English and Cherokee.

The Mary B. Regan Residency is a one-year community artist grant named in honor of former N. C. Arts Council Executive Director Mary B. Regan's 39 years of service to the arts and artists of North Carolina. The \$15,000 grant, supported by donations, will allow

Brannon to focus on revitalizing the Cherokee language in partnership with students and the wider community in Swain and Jackson counties.

"When I think of myself as a community artist, I think about the ability of a person to use art to support or transform a community, and combined with visual arts, I expect my artwork to be a catalyst for change using a visual ap-

proach," he said.

Brannon focuses his work on three areas: hand papermaking, hand book-binding and letterpress printing. Working with book artist Steve Miller, Brannon produced the paper for a limited edition print of "Voyage" by former U.S. Poet Laureate, Billy Collins. He was commissioned to make 200 copies of "Absalom, Absalom!" celebrating William Faulkner's birthday. The commission for Square Books featured letterpress printing on handmade cotton rag paper.

He has also explored expanding the concept of the book form to include installations featuring imagery and text on handmade paper filling a gallery space and is experimenting with outdoor installations where the paper will interact with the environment.

Brannon has a master's of fine arts degree from the Book Arts Program at the University of Alabama. His work is in almost 50 library collections and he has been in four solo exhibitions and an exhibition that traveled to six venues in the Southeast.

He is a member of the Southern Highland Craft Guild, Southeastern College Art Conference and a past board member of Hand Papermaking, Inc.

# Record field expected for Cherokee Harvest Half Marathon and 5K

Over 800 runners are expected to be in Cherokee on Saturday, Oct. 18 for the 3rd Cherokee Harvest Half Marathon & 5K. This will far exceed last year's record breaking field of 600 participants.

The event was created in 2012 to benefit the Madison Hornbuckle Children's Cancer Foundation.

Over \$22,000 was raised from the event in 2013 to serve families of children with cancer that live in Jackson, Swain, Cherokee, Graham and Cherokee counties in Western North Carolina.

Both USATF-certified courses take runners through the heart of Cherokee, including a new section on the half marathon course that incorporates a section of the Great Smoky Mountain National Park. Also new for 2014 is that runners will complete one-lap on the Acquoni Events Center track before reaching the finish line.

The event is known for not only its amazing beauty in the heart of the fall foliage season but the swag package given to all race participants. This year's package includes a fleece beanie, ultra cinch bag and a quarter-zip, long-sleeve tech running shirt. Each participant also

receives a locally made, wood finishers medallion and two action photos. There is a \$1,600 cash purse for the half marathon.

After the race, runners are treated to a post-race feast created and served by the Culinary team at Harrah's Cherokee Resort.

Those traveling in Cherokee on

race morning will experience some delays and road and lane closures. Acquoni Road will be closed to all traffic from 8:15am to approximately 11:30am. The right lanes of both the eastbound and westbound lanes of US 19 will be closed to traffic from Hospital Road to Whitewater Drive. Drivers are

asked to follow the instructions of public safety officers assisting with the race and use patience and caution when in the presence of runners.

# Rattler sentenced to 70 months in prison on drug trafficking

**ASHEVILLE** — U.S. District Judge Martin Reidinger sentenced Taryn Krista Elizabeth Toineeta Rattler, 26, of Cherokee, N.C., to 70 months in prison on Friday, Oct. 10 on drug trafficking conspiracy charges, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina. Rattler was also ordered to serve three years under court supervision upon completion of her prison term.

U.S. Attorney Tompkins was joined in making the announcement by John S. Comer, Acting Special Agent in Charge of the Atlanta Field Division of the Drug Enforcement Administration (DEA), which oversees the North Carolina; Jason O'Neal, Deputy Associate Director

of the Bureau of Indian Affairs, Division of Drug Enforcement; Chief Ben Reed of the Cherokee Indian Police Department; Sheriff Curtis Cochran of the Swain County Sheriff's Office; Sheriff Mickey Anderson of the Graham County Sheriff's Office; and Sheriff Jimmy Ashe of the Jackson County Sheriff's Office.

According to filed court documents and court proceedings, from January 2007 to December 2012, Rattler and her conspirators engaged in a conspiracy to distribute narcotics including Oxycodone, cocaine, marijuana and Alprazolam in Swain and Jackson Counties. At the sentencing hearing, Rattler was found to be accountable for trafficking 404,400 milligrams of Oxycodone over the course of the

conspiracy, with a street value of \$404,400. In September 2013, Rattler pleaded guilty to one count of conspiracy to distribute a Schedule I controlled substance.

Three of Rattler's conspirators have already received prison sentences: Mark Allen Winstead was sentenced to 38 months; Timothy Leroy Rattler was sentenced to 18 months; and Jacob Hunter Rattler was sentenced to 15 months. Jackie Lee Rattler and Evan Thomas Norris, Jr. have also pleaded guilty and currently await sentencing.

In a separate case, Judge Reidinger also sentenced Kandace Rhean Griffin to 70 months in prison, followed by three years of supervised release. According to

court records, from March to October 2012, Griffin conspired with other individuals to distribute Oxycodone and other narcotics in Swain County. Griffin, 25, of Cherokee, pleaded guilty in September 2013 to one count of conspiracy to possess with intent to distribute a Schedule II controlled substance.

All federal sentences are served without the possibility of parole. U.S. Attorney Tompkins thanked all the law enforcement agencies involved in these investigations for their continued cooperation and assistance. The prosecution was handled by Assistant U.S. Attorney John Pritchard, of the U.S. Attorney's Office in Asheville.

## Federal Sentencings for Thursday, Oct. 9

### Maney sentenced prison for embezzlement

James Harley Maney, Jr., 32, of Cherokee, was sentenced on Thursday, Oct. 9 to five months in prison and to six months of home confinement on theft charges, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina. U.S. District Judge Martin Reidinger also ordered Maney to serve three years of supervised release and to pay \$286,738.50 as

restitution to Harrah's Cherokee Casino (Harrah's).

According to court records, in or about 2008, Maney embezzled the funds from Harrah's, a gaming establishment operated by and for and licensed by the Eastern Band of Cherokee Indians. Court records indicate that, at the time of the offense, Maney was a Harrah's employee. Maney pleaded guilty in March 2013 to one count of theft by officers or employees of gaming establishments on Indian lands and aiding and abetting.

### Maney sentenced to prison on assault charges

In a separate case, Christopher James Maney, 31, of Cherokee, was also sentenced on Thursday, Oct. 9, on assault charges. Judge Reidinger sentenced Maney to 51 months in prison followed by three years of supervised release. According to court records, in September 2011, in Jackson County, within the boundaries of the Eastern Band of Cherokee Indians reservation,

Maney assaulted a minor victim.

Court records indicate that Maney struck the minor in the abdomen, causing an intestinal perforation which required immediate surgery. Maney pleaded guilty in March 2013 to one count of knowingly and intentionally assaulting a minor resulting in substantial bodily injury.

The prosecution for the government was handled by Special Assistant U.S. Attorney Jon Smith of the U.S. Attorney's Office in Asheville.

Smoke testing of the Sanitary Sewer System in Cherokee will take place from Oct. 13-24 in the area from Tribal Bingo to Frontier Shopping Center only. This survey will assist inspection crews in locating breaks and defects in the sewer system.

Non-toxic smoke will be introduced into a manhole and forced down the sewer lines with the use of an air blower. Smoke will escape from the system at any point where there is an open break in the line. For example, smoke may arise from the ground in yards, stream banks, storm drains, etc. Smoke will also escape from all manhole lids, vents on building roofs, cleanouts, and from underneath buildings if poor plumbing exists.

Be advised that smoke can enter your home, office, or place of business. The completion of the smoke test survey may be delayed with the occurrence of a heavy rain event.

The smoke is non-toxic, non-staining, has a slight odor, white to gray in color and creates no fire hazard. You do not have to be onsite during testing. It is advisable to pour a gallon of water into every sink, tub, and floor drain that is not subject to everyday use. This will fill the p-traps and prevent smoke from entering the building.

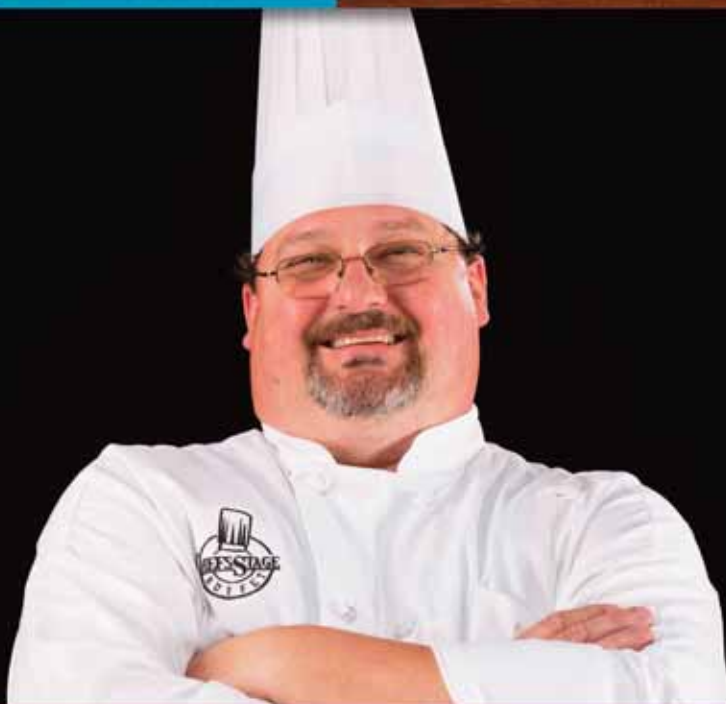
