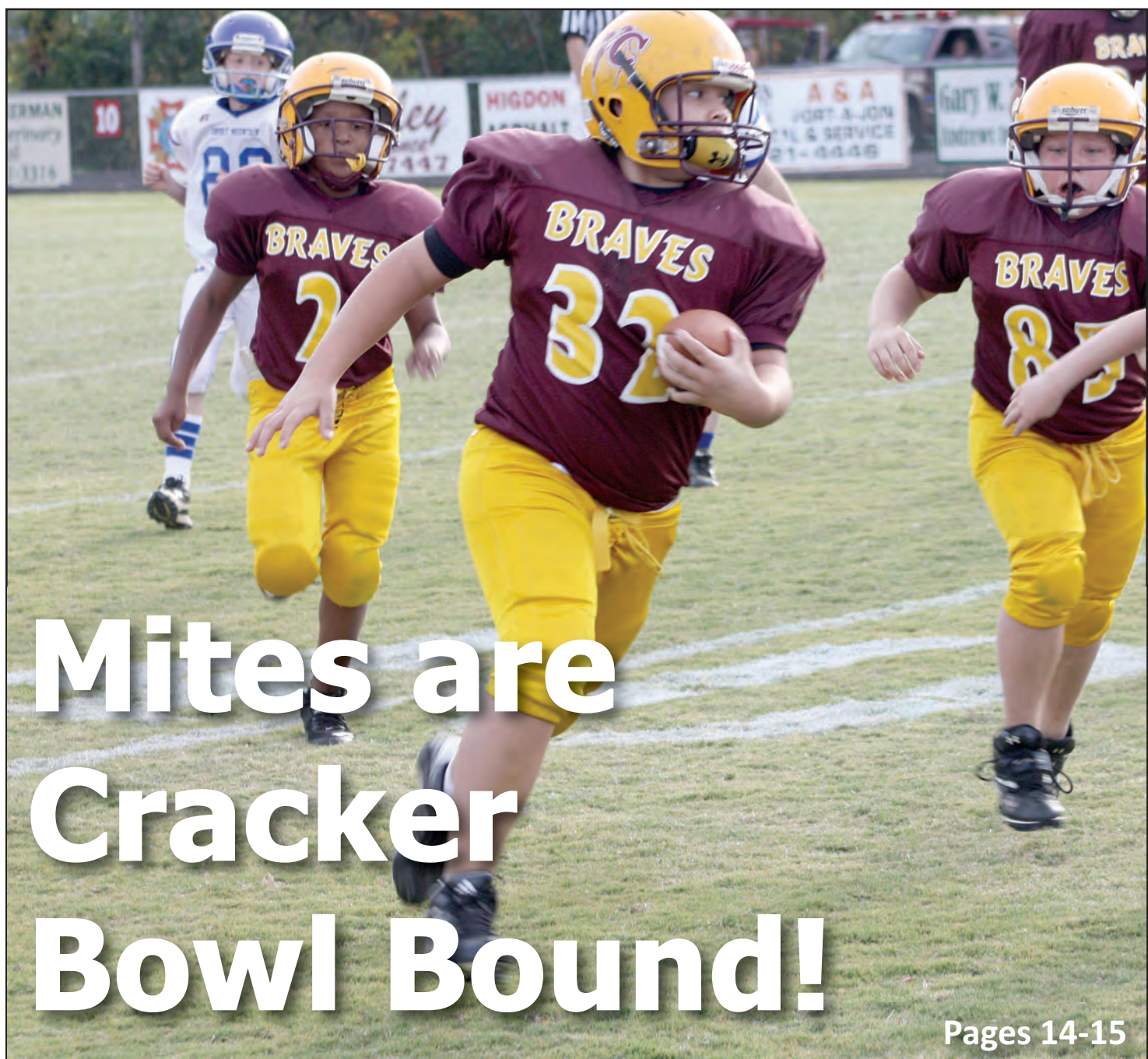

Previous co-hosts, the Eastern Band of Cherokee Indians Travel & Promotion Department and Harrah's Cherokee Casino, will continue as sponsors but the Rodders are handling all details of the popular show and shine for hundreds of classic and customized Pre-1972 cars and trucks.

The event is scheduled for Nov. 5-7 at the Acquoni Event Center (the old Cherokee High School) on Acquoni Road in Cherokee which is also near Saunooke Village.

Native Farmers to get \$760M

USDA settles with Native Farmers on Discrimination Suit

A lawsuit filed in 1999 alleging discrimination by the USDA towards American Indian farmers has been settled. Marilyn and George Keepseagle, a married couple who farm on the Standing Rock Indian Reservation filed the class action suit 11 years ago.

Keepseagle v. Vilsack was settled on Tuesday, Oct. 19 to the tune of \$760 million. The settlement ends a class action lawsuit alleging that American Indian farmers were denied access to low-interest loan rates from the USDA.

A new federal advisory committee, known as the Native American Farmer and Rancher Council, was also created out of the settlement. Comprised of 15 members, 11 of which will be American Indians or those representing their interests, the

committee is set to start early next year.

"I applaud (Agriculture) Secretary (Tom) Vilsack and Attorney General Holder for their hard work to reach this settlement – a settlement that helps strengthen the nation to nation relationship and underscores the federal government's commitment to treat all citizens fairly," President Barack Obama said in a statement on Tuesday, Oct. 19. "In light of that commitment, Congress must also act to implement the historic settlements of the Pigford II lawsuit, brought by African American farmers, and the Cobell lawsuit, brought by Native Americans over the management of Indian trust accounts and resources."

Vilsack said in a statement, "Today's settlement can never undo

the USDA, the Department "will pay \$680 million in damages to thousands of Native American farmers and ranchers and forgive up to \$80 million worth of outstanding farm loan debt."

Jefferson Keel, president of the National Congress of American Indians, said in a statement, "This settlement provides long awaited justice for American Indian farmers and ranchers who have only sought an equal opportunity to work hard and succeed. We are pleased that the court and the Obama Administration have taken tangible steps today to right a wrong and reinforce the trust relationship between the United States and the American Indian tribal nations."

According to a damages fact sheet for the settlement, "The Plaintiffs negotiated the payment of \$680

million in damages by relying heavily upon the expert analysis of Patrick O'Brien, an independent agricultural economist who was employed by the USDA's Economic Research Service for 27 years. In an expert report filed with the U.S. District Court for the District of Columbia, Mr. O'Brien estimated that Native Americans suffered economic losses of \$776 million during the period from 1981

to 2007 that could be attributed to discrimination by the USDA."

Joseph M. Sellers, a partner at Cohen Milstein Sellers & Toll, PLLC, was the attorney for the lead plaintiffs in the case. "This settlement marks a major turning point in the important relationship between Native Americans, our Nation's first farmers and ranchers, and the USDA. After three decades, Native American farmers and ranchers will receive the justice they deserve, and the USDA has committed to improving the farm loan system in ways that will aid Native Americans for generations to come."

According to the settlement damages fact sheet, *Keepseagle* class members can file a claim under two separate tracks.

Track A provides damages up to \$50,000 and is for American Indian farmers who were denied loans between 1981 -1999 by the USDA. Track B provides damages up to \$250,000 and is for those American Indian farmers who wish to provide proof of actual economic losses and "provide substantially more evidence about the discrimination they suffered."

White Bison seeking Federal Apology
for Boarding School Era

A well-known Colorado-based wellbriety organization is seeking a formal apology from the federal government for the treatment endured by countless American Indians during the federal Indian Boarding School Era. The White Bison non-profit organization has started the Boarding School Apology Initiative in the hopes that President Barack Obama will issue an apology on behalf of the U.S. Government.

"The purpose of the Apology is to bring healing to Native peoples as well as to the American nation as a whole," a statement from White Bison says. "The Native American Boarding School Era is one of the ill-conceived Federal policies that a national apology will begin to heal."

President Obama signed "An Apology to Native Peoples of the United States" contained in Section 8113 of HR 3326 on Dec. 19, 2009.

Because that legislation was at-

tached as an amendment to the Department of Defense Appropriations Act of 2010, White Bison officials feel it didn't get the proper media and public attention. "This Apology was never given the publicity and public recognition it deserves once the Bill was signed and became law."

Canadian Prime Minister Stephen Harper offered a formal apology to the Native Peoples of Canada in June 2008 for their treatment in Indian Residential Schools as they were called there.

In his apology, he stated, "The treatment of children in Indian Residential Schools is a sad chapter in our history. For more than a century, Indian Residential Schools separated over 150,000 Aboriginal children from their families and communities."

"Indeed, some sought, as it was infamously said, 'to kill the Indian in the child'. Today, we recognize that this policy of assimilation was wrong, has caused great harm, and has no place in our country."

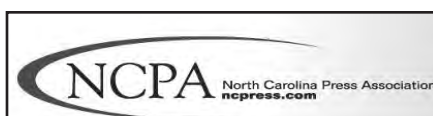

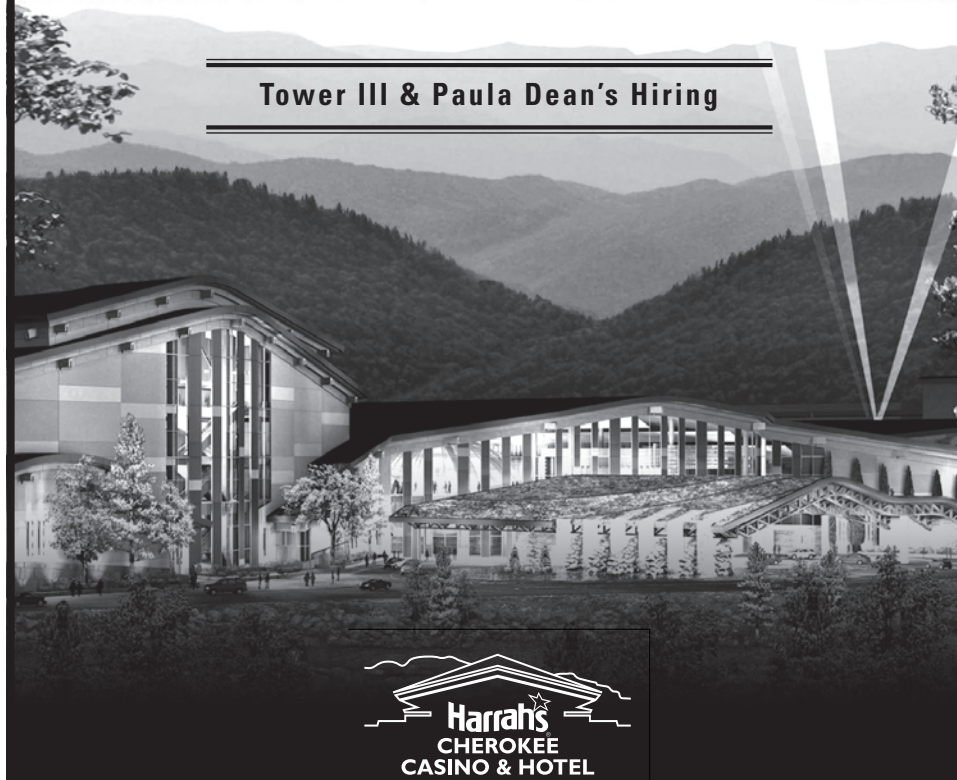

Mites are Cracker Bowl Bound!

Cherokee Mites defeat Jackson Co. to advance to Saturday's Cracker Bowl

The Cherokee Mites are Cracker Bowl bound! They defeated the Jackson Co. Mites 12-0 in a playoff game held at Andrews High School on Saturday, Oct. 23.

The first half started out slow with both teams turning the ball over on downs once and punting twice. Both teams had three "three and outs" in a half that was definitely a defensive struggle.

But, you just knew that something had to give. And, it did...

Following a Jackson County punt, the Braves set up shop at their own 34-

yard line with just over 30 seconds left in the half.

On first down, Ty Mintz cut up the middle, darted outside and was gone...66 yards later he crossed the end zone and the defensive struggle was over. The two-point conversion failed and Cherokee took a 6-0 lead into halftime.

Jackson County got the ball first in the third quarter, but they turned it over on downs following their third three-and-out of the game.

Cherokee took over at their own 37-yard line. On first down, Braves RB Issiah Bradley ran 19 yards to the Jackson

Co. 44-yard line.

On the next play, he ran another 19 yards down to the 25-yard line, but a holding penalty negated that run. The Braves continued pounding though and several plays later worked for a first down at the 18-yard line.

On first down, Bradley took it to the 5-yard line where the Braves set up for a first and goal.

Two plays later, Isaiah Evans busted into the end zone from three yards out for Cherokee's second score of the game. The two-point conversion failed and the Braves led 12-0 with just under two minutes left in the third quarter.

Jackson Co. started their next drive at midfield. Their drive, which went into the fourth quarter, started out well and they worked it down to the Cherokee 14-yard line following a personal foul penalty. But, a stiffened Braves defense combined with an intentional grounding call stifled their drive and they turned it over on downs again.

Cherokee punted on their next drive. Jackson Co. took over at their own 39-yard line to begin what ended up being a very odd drive.

Several nice runs and a facemask call later, Jackson Co. found themselves first and goal from the Cherokee two-yard line. They were stopped for no gain on



first and second down and gained one yard on third down to set up a fourth and goal from the 1-yard line.

Jackson Co. called a timeout. That's when it got confusing. Midway through the timeout, the referees threw an unsportsmanlike conduct flag on Jackson Co. That drew the ire of the Jackson Co. sideline and resulted in another unsportsmanlike conduct flag and one coach being ejected.

Jackson Co. went into the timeout with a first and goal from the 1-yard line and came out of the timeout with a first and goal from the 31-yard line.

They turned it over on downs and Cherokee was able to run out the clock to secure the win and a place in Saturday's Cracker Bowl against the Murphy Bulldogs.

Braves fall to Tigers

ONE FEATHER STAFF REPORT

ROSMAN – Cherokee RB Dorian Walkingstick continued his ground assault Friday, Oct. 22 against Rosman gaining 211 yards on 25 carries and scoring four times. His performance wasn't enough to garner a win against the Tigers who gained 435 total yards on offense. Cherokee fell to 3-6 on the year with a 43-39 loss to the Tigers (3-7).

Cherokee lost by four points, and the point-after touchdown conversions killed them. Overall, Cherokee and Rosman each scored six touchdowns in the game. The difference came down to the point-after tries in which Cherokee missed one point-after kick and failed on three two-point conversions. Rosman made three kicks, missed one, but were able to convert two two-point conversion tries.

Rosman's Duran Scruggs scored four TDs of his own and ended with 152 yards on 23 carries to help the Tigers secure the win. Blaine McCall also went over the 100 yard mark for Rosman with

130 on 16 carries and 1 TD.

Rosman jumped out to a 14-7 lead in the first quarter on two touchdown runs by Scruggs (16, 6). Walkingstick kept Cherokee in the hunt with a 46-yard touchdown run of his own.

The second quarter was very similar as Rosman would score twice and Cherokee would score once. McCall ran for a 42-yard touchdown and Whitmire

added a 3-yard score for the Tigers and Cherokee QB Jesse Blanton ran for a 4-yard run.

Cherokee trailed 28-13 at half-time.

The Braves came out blazing in the third quarter as Walkingstick added two scores on runs of 9 yards and 20 yards. Both two-point conversions failed and Cherokee trailed 28-25 going into the final quarter.

Each team scored twice in the fourth quarter. Scruggs scored on two separate runs of 2 yards each. Walkingstick added his fourth score of the game on a 15-yard run and Poncho Ramirez scored the last touchdown of the game on a 7-yard pass from Blanton.

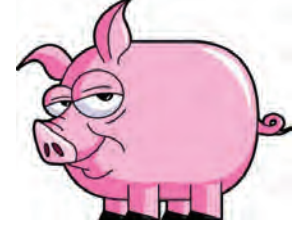

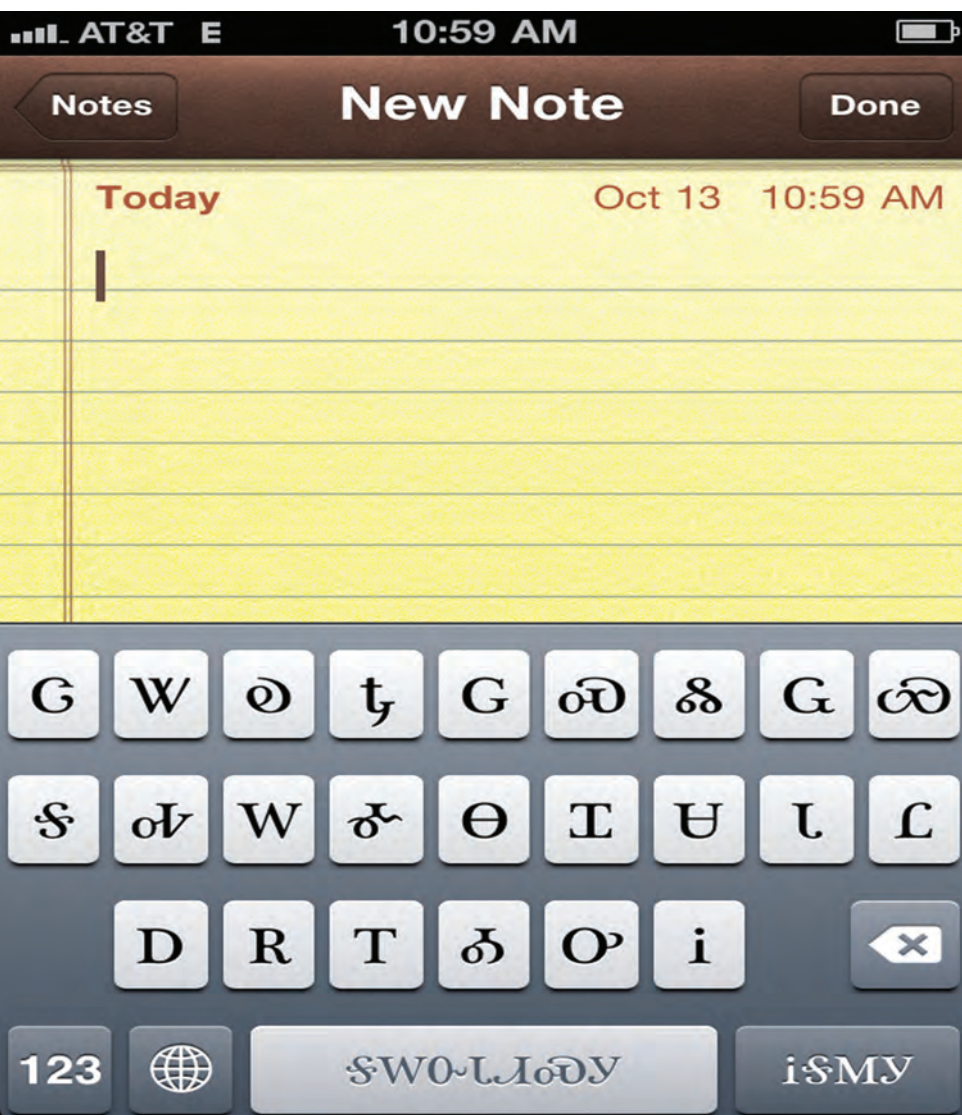

Housing & Community Development offers 11 Home Maintenance Tips for this Fall Season



Fall is a very important season for home maintenance because it's your last chance to get your home ready for the cold weather that's right around the corner.

- 1.) Examine your roof/gutters/downspouts for debris:** Your roof is often forgotten about because it is not at eye level to give you a subtle reminder every time you walk past it. Clear leaves, dirt, and pine needles from gutters and examine downspouts for damage or loose pieces.
- 2.) Change the filters in your home:** If you have a central air conditioning system, change the air filter regularly. If you have a window air conditioning unit, remove from the window or place a waterproof cover over it to prevent damage. Clean air filters will keep your family healthier in the fall months.
- 3.) Still have leaky faucets?** Repair them now: Before the temperatures start to dip low, examine leaky faucets in the kitchen, bathrooms, and utility room locations. Most likely the time and money spent now to fix will be less than a broken pipe in the dead of winter!
- 4.) Check windows and doors for drafts:** The majority of conditioned air in your home is lost through the windows and doors. Go through your home and open windows to ensure the seal and caulking around the window frame is in good condition. Think of adding heavier drapery around windows that are extra drafty, to help block some air infiltration. Check weather stripping around exterior doors and adjust thresholds to prevent air drafts.
- 5.) Remove, drain and store garden hoses, drain exterior water faucets.** Freezing water expands and will cause damage to you the hose fittings, spray nozzles, and valves. Replace your regular water faucets with a frost-free type for extra protection.
- 6.) Check your electrical outlets for potential fire hazards such as frayed wires or loose-fitting plugs.** Be sure not to overload electrical outlets, fuse boxes, extension cords or any other power service.
- 7.) Inspect your smoke detectors.** Make sure there is one on each floor of your home. Test them monthly, and change the battery annually or as needed.
- 8.) Insulate water pipes in areas exposed to cold temperatures, and turn up the thermostat during extra cold periods.**
- 9.) Run all gas-powered lawn equipment until the fuel tank is empty.** Gasoline left in the tank loses its volatile components over the winter, making your mower hard to start in the spring.
- 10.) Maintain steps and handrails.** Repair broken steps and secure loose banisters. Broken steps are easily hidden beneath snow, which could cause a dangerous fall. Similarly, a person slipping on ice will grab a handrail for support.
- 11.) Check and or replace heat tape in well/pump house.**
