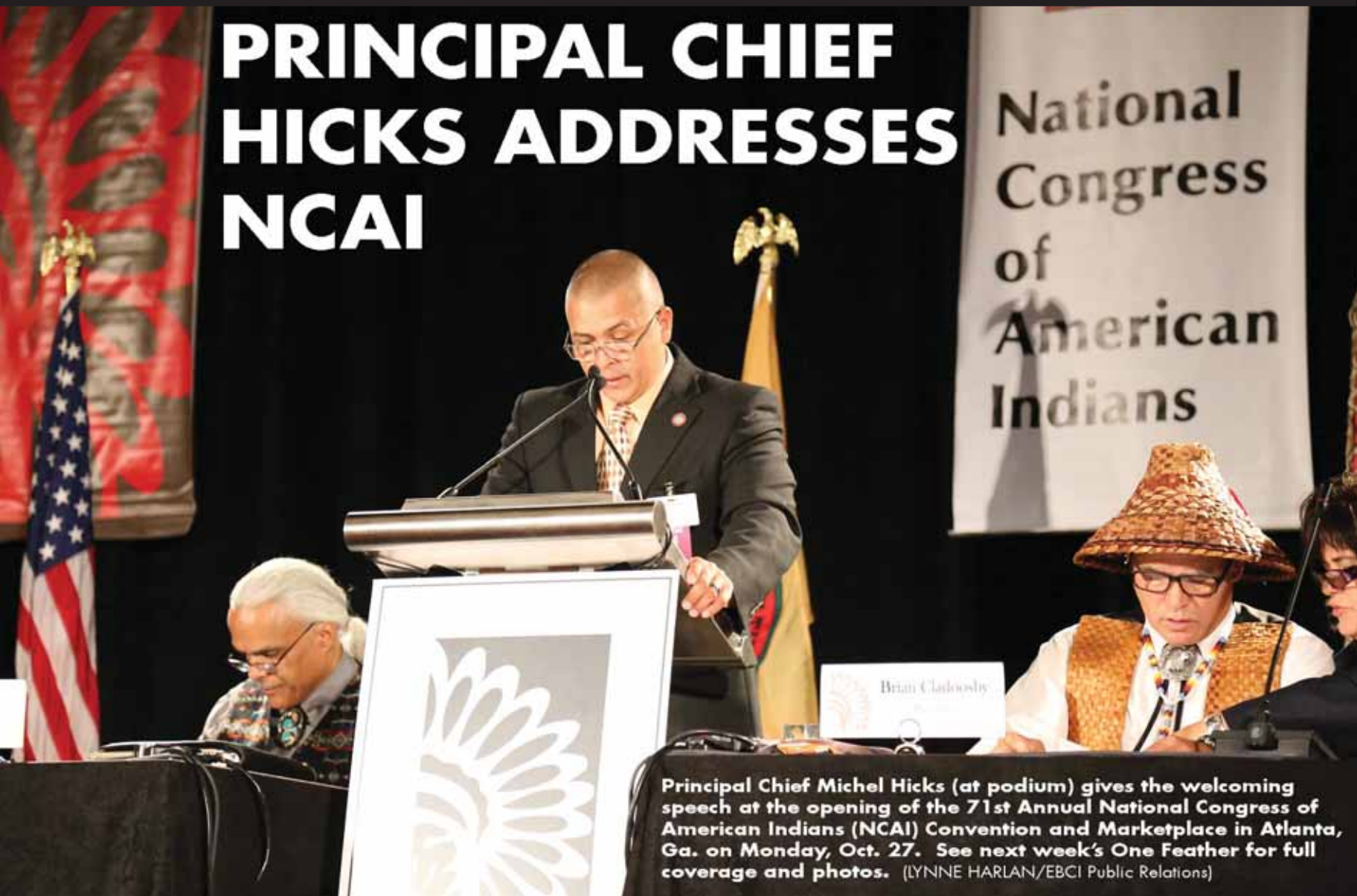

HOSPITAL TOPPED OFF

In a construction tradition dating back hundreds of years, an evergreen tree was attached to the final steel beam of the new Cherokee Indian Hospital building, and it was lifted into place during a topping-out ceremony on Friday, Oct. 24. Principal Chief Michell Hicks and Carmaleta Monteith, Cherokee Indian Hospital Authority Governing Board chairperson, helped attach the beam.

"It's hard to believe that just seven months ago, we stood on top of the mountain here and broke ground," said Casey Cooper, Cherokee Indian Hospital CEO. "Seven months ago, we talked about the importance and the value of seeds versus bouquets. We talked about how it was usual and customary for this community and this Tribe and our tribal leadership to value the sowing of seeds more than the reaping and the cutting of flowers. Standing around us is the result of the seeds that we sowed more than seven months ago."

Cooper thanked tribal leadership, the construction team and especially the workers at the site. "I understand that is usual

and customary that the topping-off ceremony is an opportunity where we not only celebrate a milestone in the construction, but we celebrate the iron workers who put themselves at risk every day to erect the steel that makes the structure possible."

"As you can see, it has been an extremely busy

seven months. This has been the most incredible team that I've ever seen and participated with."

Chief Hicks recognized the Cherokee Indian Hospital Authority Governing Board, the Cherokee Indian Hospital staff, Tribal Council, and the construction workers.

"We're not here by

chance, and we're not here by luck this morning," he commented. "We're here because we're a blessed Tribe. This project is just not going up because we had some extra resources or that we wanted to build a new building. This Tribe has focused on a number of issues and health is a major priority."

Chief Hicks continued, "We know the old hospital has served a lot of people over time, but it has become inefficient. The technology is not where it needs to be, and, so as we began this endeavor on the new hospital, those things were out front."

"I just want to commend anyone who has had

a hand in this particular building because it's not just a building. It represents the future of our Tribe, and it will give us the opportunity to be a more healthy people than we've ever been before."

Bill Stevens, of Robins and Morton, the construction company slated to manage the construction of the new facility, stated, "This is an amazing opportunity in these beautiful mountains."

He added, "Casey (Cooper) told me after we were selected that he could

have selected 10 other contractors that could have built this job on time, safely, under budget, and a high quality project, but he trusted in us to embrace the community and the Eastern Band of Cherokee Indians to build this project and take it to a new level... it's been a pleasure for us and our families to be able to come here and do this."

The new 140,000 square foot facility is being built adjacent to the current hospital and is expected to open in January 2016.

Asheville Initiative wins HIDTA Award for drug enforcement on EBCI lands

The Cherokee Indian Police Department, part of a multi-jurisdictional team, has won the High Intensity Drug Trafficking Areas (HIDTA) Program Award for Outstanding Enforcement on Tribal Lands.

"This year, the accomplishments of the Atlanta/Carolinas HIDTA were truly outstanding", stated R. Gil Kerlikowske, director of the Executive Office of the President, Office of National Drug Control Policy in a letter to Jack Killorin, director of the Atlanta/Carolinas HIDTA.

He further stated, "The HIDTA program plays a vital role in the Administration's effort to make the Nation safer and healthier by reducing drug use and its consequences. The work done by the HIDTAs disrupting and dismantling drug trafficking organizations is fundamental to this goal, and the tireless efforts of individuals like you are critical to the success of the HIDTA program."

The High Intensity Drug Trafficking Areas (HIDTA) program, created by Congress with the Anti-Drug Abuse Act of 1988, provides assistance to Federal, state, local, and tribal law enforcement agencies operating in areas determined to be critical drug-trafficking regions of the United States.

The Atlanta-Carolinas HIDTA nominated the Asheville Initiative for the Outstanding Enforcement on Tribal Lands Award for the period of September 2012 through Oct. 1, 2013. The Asheville Initiative is responsible for the enforcement of the Controlled Substance Act on the Eastern Band of Cherokee Indian Reservation which en-

compasses five counties within the Asheville Initiative area of responsibility including: Cherokee, Graham, Haywood, Jackson, and Swain Counties.

In March 2012, the Asheville Initiative, initiated an investigation into the drug trafficking activities of Jackie Rattler's drug trafficking organization (DTO). Rattler was identified as a local based drug trafficker who was being supplied diverted pharmaceuticals by several sources of supply. This investigation was a cooperative effort among federal, state and local law enforcement agencies utilizing multiple investigative techniques that led to significant arrests and seizures of drugs and currency from this large scale DTO operating in North Carolina and along the East Coast.

The Asheville Initiative was quickly able to identify Rattler's command and control hierarchy within the DTO, with several of the members being part of Rattler's immediate family. The Rattler DTO was responsible for receiving the diverted pharmaceuticals from multiple sources of supply and then distributing them to a large customer network, including other enrolled members of the tribe. Over the course of the next several months, the Asheville Initiative conducted numerous enforcement operations in order to gain additional evidence against the Rattler DTO.

The award recipients worked this investigation from street level pill purchases into large seizures of oxycodone, hydro morphine, other diverted pharmaceuticals, cocaine, and US currency. The nominees displayed outstanding ability in di-

recting a complex narcotics investigation that started with a lower level pill trafficker and culminated in arrests of more than 70 members of this DTO and include Rattler, the sources of supply, and all other members on federal/state/tribal related drug charges. In total, the Asheville Initiative seized over \$140,000.00 in US currency; vehicles valued in excess of \$110,000; 42 firearms; and drugs to include 9,016 dosage units of Oxycodone; 5,082 dosage units of hydro morphine; 4,319 dosage units of benzodiazepine; 3,723 dosage units of other controlled pharmaceuticals; 114 grams of cocaine; and 3,247 grams of marijuana.

In December 2012, Rattler, along with other members of his DTO were arrested and search warrants were conducted on multiple residences on tribal land. As a result of the enforcement operations and the execution of the arrests/search warrants in December 2012, thousands of diverted pills, large amounts of US currency, firearms, and high end vehicles were seized. Subsequent to the arrest and search warrant execution, the investigation continued in order to identify additional co-conspirators.

Maney sentenced to 20 months in prison for sexual contact with minor

ASHEVILLE – Brian Dallen Maney, 50, of Cherokee, was sentenced on Wednesday, Oct. 22 by U.S. District Judge Martin Reidinger to serve 20 months in prison for engaging in sexual contact with a minor, announced Anne M. Tompkins, U.S. Attorney for the Western District of North Carolina. Judge Reidinger also ordered Maney to serve a lifetime under court supervision after he is released from prison.

According to court records, between August 2012 and May 2013 in Jackson Co., Maney engaged in

sexual contact with a minor victim under the age of 16. Court records indicate that at the time of the offense Maney was on supervised release for a prior conviction related to a 2009 charge. Maney pleaded guilty in October 2013 to one count of sexual contact with a minor.

The prosecution for the government was handled by Special Assistant U.S. Attorney Jason Smith of the U.S. Attorney's Office in Asheville.

The Cherokee Indian Police Department attempted to serve a US Marshal Warrant for the arrest of Timothy Ray Smith, a 45 year-old, male, for a probation violation on the morning of Thursday, Oct. 23.

When officers arrived on scene to serve the warrant at approximately 7:35am, Smith barricaded himself in a residence on Driver Road in the Big Cove Community.

Smith surrendered himself around 9:13am, shortly after officers arrived with an armored police vehicle. He was taken into custody with no further incident.

Johnson nets 188 yards receiving in Braves loss

ROSMAN – Dustin Johnson, Braves wide receiver, had a massive game at Rosman on Friday, Oct. 24 as he caught 9 passes for 188 yards and 2 TDs. Cherokee (3-6) scored 22 third quarter points but came up a little short as they lost to the Tigers 46-22.

Brandon Buchanan, Braves quarterback, went 17 of 39 for 235 yards, 2 TDs and 1 INT.

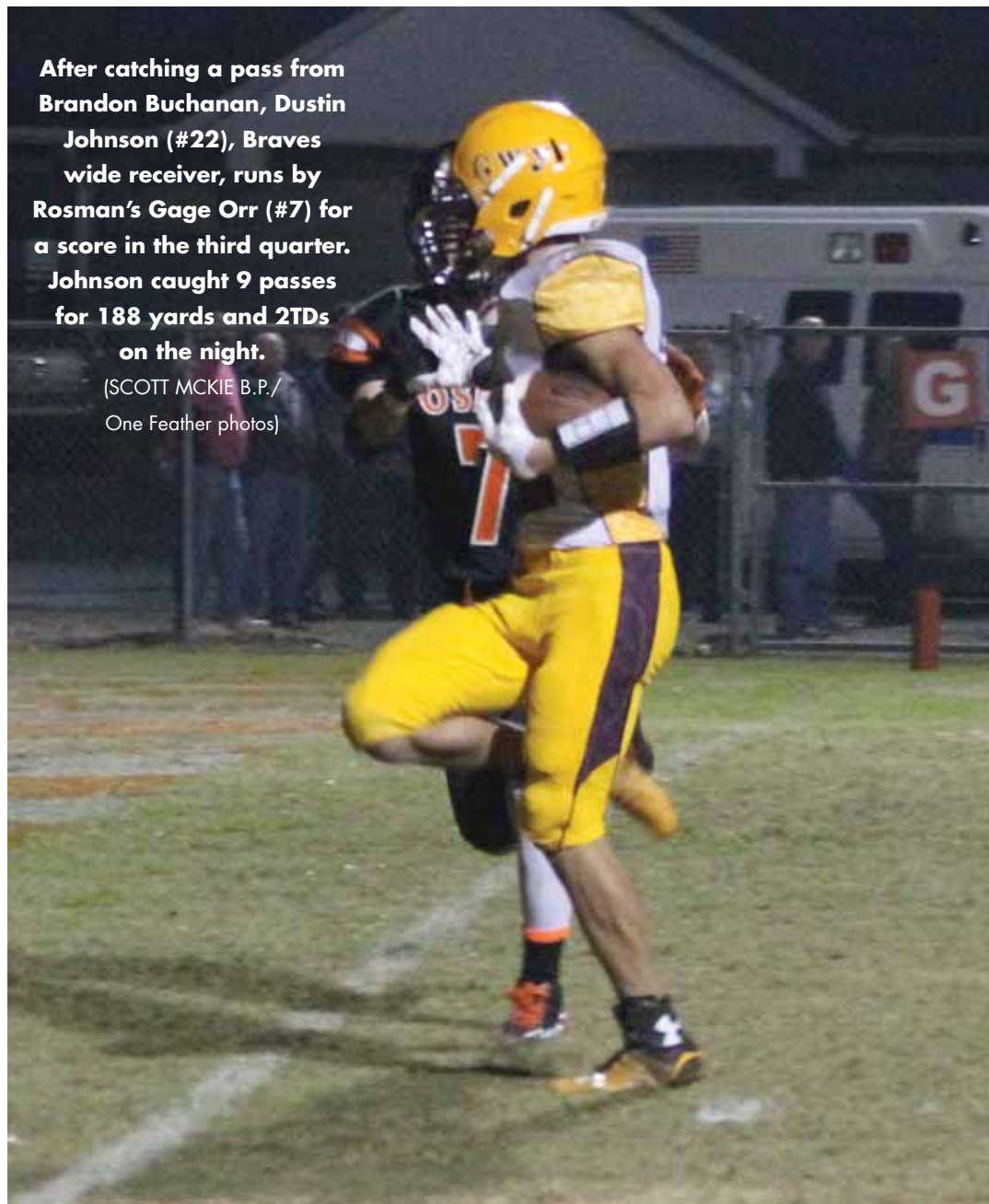
In the Braves big third quarter, they gained 157 yards including 140 in the air.

Cherokee's defense was led by Kennan Panther, the second leading tackler in the state, with 23 tackles. He was followed by Logan Teesateskie with 21 and Tye Mintz, fresh off the JV squad, with 15. Three Braves recovered fumbles in the game including Jaron Bradley, Steven Swayney and Channing Lossiah.

Cherokee got the ball first and turned it over on downs after six plays. Rosman took over on their own 43-yard line. Two plays later, Tanner Green ran 54 yards for the first score of the game. The point-after kick was no good and Rosman led 6-0 with 9:45 left in the first quarter.

After catching a pass from Brandon Buchanan, Dustin Johnson (#22), Braves wide receiver, runs by Rosman's Gage Orr (#7) for a score in the third quarter. Johnson caught 9 passes for 188 yards and 2TDs on the night.

Four plays into their next drive, the Braves fumbled which was recovered by Rosman at their own 45-yard line. The Tigers would get into the end zone six plays later as Josh Rice scored on a 27-yard run. Rice also ran for the two-point conversion to make it 14-0 at the 6:02 mark in the first.

Cherokee had to punt

on their next possession, but Rosman fumbled the punt reception which was recovered by Lossiah at the Rosman 39-yard line. The Braves drove down to the Rosman 11-yard line, but were unable to punch it in and turned the ball over on downs.

Cherokee's defense held strong though and held the Tigers to a three-

and-out. But, Rosman got the ball back three plays later with an interception.

Rosman started at their own 11-yard line and got four first downs driving to the Cherokee 35-yard line when they fumbled the ball which was recovered by Bradley.

The Braves couldn't move the ball though and had to punt on the ensuing

possession. Rosman then took over at the Cherokee 41-yard line. Ten plays later, Rice punched it in from two yards out for a touchdown. Green ran for the two-point conversion and Rosman led 22-0 with 19 seconds left before half-time.

Cherokee came out of the locker room pumped up and caused a fumble on the opening kickoff of the second half. The ball was recovered by Swayney at the Rosman 18-yard line. On second down, Buchanan found Johnson down the left sideline for an 18-yard touchdown pass.

Buchanan connected with Panther for the two-point conversion pass to make it 22-8 just 40 seconds into the third quarter.

Rosman answered quickly though as they had a 4-play, 61-yard drive that culminated in a 41-yard touchdown run by Green. The two-point try failed and Rosman led 28-8 with 8:53 left in the quarter.

The Braves came back with a 4-play scoring drive of their own as they started on their own 37-yard line and ended with a 31-yard touchdown pass from Buchanan to Johnson. The two-point conversion failed and the score was 28-14 with 7:18 left in the third.

The Tigers scored again 22 seconds later as Green ran 44 yards for a

score. The two-point conversion failed and Rosman led 34-14.

Cherokee had a three-and-out and punted on their next possession and the Tigers started at their own 40-yard line. They put together a 4-play drive that ended with a 43-yard touchdown run by Gage Orr. The two-point failed again and the score was 40-14 with 4:10 left in the busy quarter.

The Braves answered back a little more than a minute later. They started the drive on their own 44-yard line, and Johnson ran under a Buchanan bomb for a 55-yard gain on second down. Two plays later, Buchanan finished it off by

running it into the end zone from 4 yards out. Buchanan passed to Jason McMillan for the two-point conversion and Cherokee cut into the lead at 40-22 at the 3:03 mark in the third.

Green added another Rosman score on a 9-yard run in the fourth quarter. The two-point try failed and Rosman took the win at 46-22.

Cherokee hosts Andrews (1-8) in a key Smoky Mountain Conference matchup on Friday, Oct. 31 at 7:30pm at Ray Kinsland Stadium. It will be Seniors Night for Cherokee with senior players in all fall sports being honored.

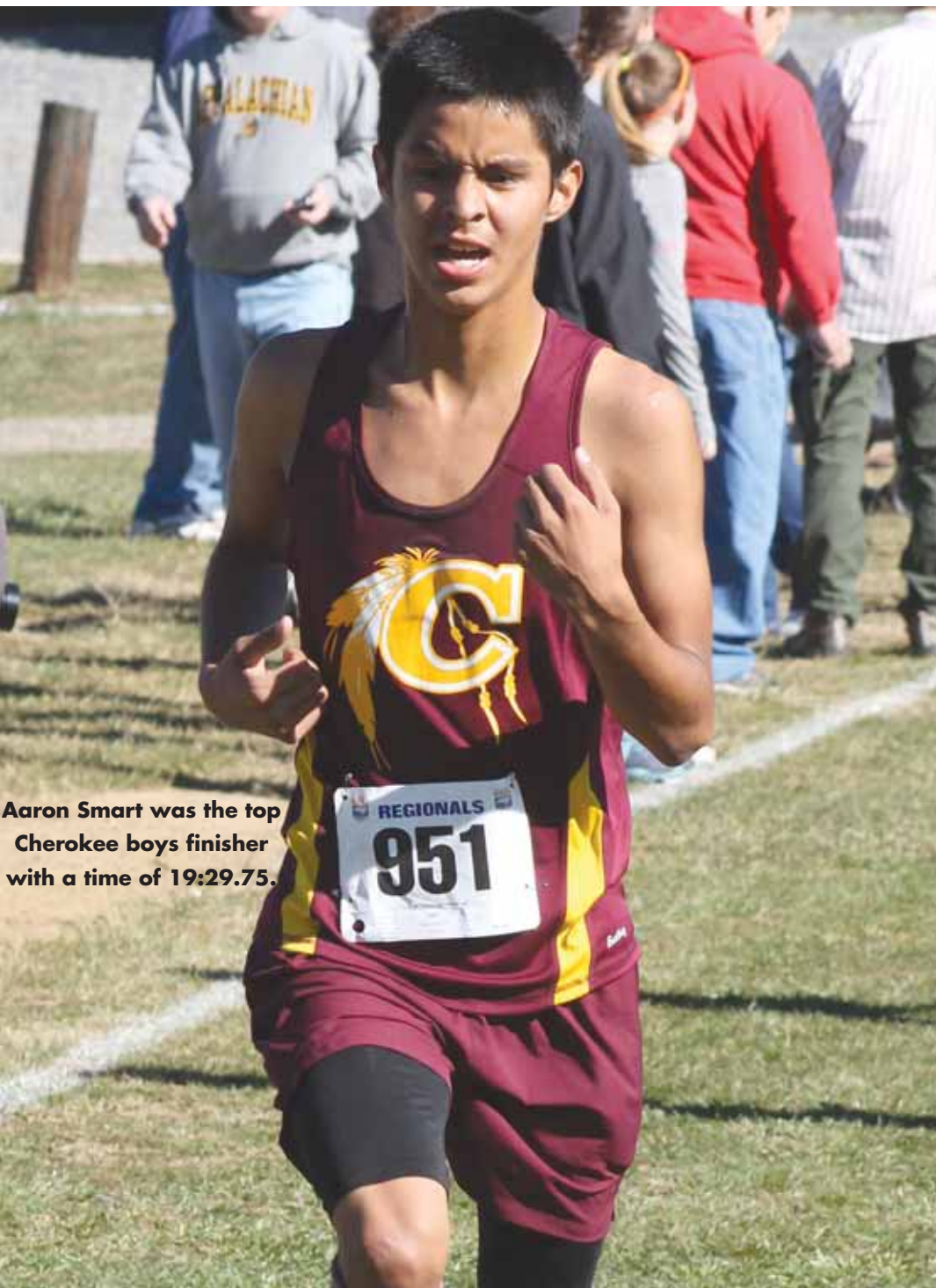

Swain County Schools celebrated Native American heritage and culture by having school assemblies at Swain County Center for the Arts for the high school and middle school last month and for the elementary schools on Tuesday, Oct. 21. The five assemblies featured Daniel Tramper and the Deer Clan Dancers, all EBCI tribal members, performing a variety of pow wow style dances. These assemblies received support from the North Carolina Arts Council, a division of the Department of Cultural Resources.

Dancers included Daniel Tramper, his wife Teresa Reed and son Scrappy Sherrill. They performed both northern and southern plains style dances while John Grant Jr. or Ricky Joe Taylor gave some of the history of each dance and sang.

In addition to playing the drum for the dancers, John Grant Jr. told a story about instructions from a father to his three sons and

how the third son gave the gift of love and compassion and another story about how the woodpecker created the first flute out of a tree limb that was used by a young man to woo his girl. He also described the difference in the old-style northern songs with no words and the contemporary northern style songs with words. He sang a northern

two-step song and a southern plains song.

At the end of high school and middle school assemblies, several students from the audience were asked to join the dancers on the stage for the Friendship Dance. At the end of each of the elementary school assemblies, six teachers and six students were invited to the stage to

participate in a musical hoop game to the rhythm of Ricky Joe Taylor's drum. The storytellers closed with the Cherokee words for "till we meet again" since there is not a word in the Cherokee language for goodbye.

VETERANS CORNER

Staff Sergeant Joshua Rory Welch

AMBLE SMOKER ONE FEATHER STAFF

Staff Sergeant Joshua Rory Welch, an EBCI tribal member, enlisted in the United States Army in June 2003 and completed Basic Training at Fort Sill, Okla. He entered Advance Individual Training-Field Artillery, and upon completion, he was deployed to South Korea.

In 2005, his unit was deployed to Southwest Asia in support of operation Iraqi Freedom in 2005 and redeployment again in 2008 where fighting in Iraq was a daily venture. In February 2005, while deployed

to Afghanistan in support of Operation Enduring Freedom, his unit, Task Force Iron Rakkasans, conducted counterinsurgency operations in Paktika and Ghazni Afghanistan that crossed five lines of effort: Governance, Development, Agriculture, Security, and Information engagement.

On June 16, 2010, SSGT Welch was wounded in action. He was one of five soldiers patrolling in a mine resistant vehicle searching the outskirts of a village harboring Taliban soldiers. An improvised explosive device detonated under the vehicle transporting Welch. The mine resistant vehicle was com-


pletely destroyed in explosion, which resulted in two occupants being killed in action and the others suffering severe wounds. A medevac crew transported SSGT Welch from Kandahar Afghanistan to Llanstuhl Army Hospital in Germany. From that base, he has since returned to Fort Campbell, Ky. where he is being treated for his wounds sustained in combat.

SSGT Joshua R. Welch is extremely proud of his Cherokee cultural heritage, and he holds dear Cherokee traditions that are such an important part of both his personal and professional life.

For his service, SSGT Welch has

been awarded the following decoration and awards: Purple Heart Medal, Army Commendation Medal 6th Award, Army Achievement Medal 6th Award, Good Conduct Medal, Overseas Ribbon 4th Award, Global War on Terrorism Award, Iraqi Campaign Medal, Afghanistan Campaign Medal, Korean Defense Service Medal, Combat Action Badge, Air Assault Badge, Expert Marksmen's Badge, Professional Leadership Development Course 4th Award, and the 101st Airborne Division Combat Patch.

Museum receives North Carolina Arts Council Grant

The Museum of the Cherokee Indian has received a grant from the North Carolina Arts Council for \$56,905 for the year beginning July 1, 2014 through June 2015. The Arts Council has designated the Museum a "State Arts Resource" organization because of its role in preserving and perpetuating Cherokee traditions.

"The Museum appreciates this support because it enables us to carry out our mission," said Bo Taylor, executive director. "Our community still holds on to many of our traditions. Support from the arts council allows us to help Cherokee artists, not only to pass on those traditions, but also to bring back traditions that have been lost."

The Museum showcases Chero-

kee artists and performers at the "Cherokee Voices Festival," the second Saturday in June, now in its eighteenth year. The event is sponsored by the Arts Council and is open and free to the public. "This is one of the few events in Cherokee or in the Southeast where all the presenters are enrolled members of a federally-recognized tribe. They are the true tradition bearers," said Barbara R. Duncan, Museum education director and folklorist.

These artists and performers also work with small groups of visitors in "The Cherokee Experience". This program provides cultural immersion for visiting groups, with presentations by experts from the Eastern Band of Cherokee Indians. Advance scheduling allows groups to not only tour the Museum's

award-winning exhibits, but also to take a nature walk, eat Cherokee food, hear stories, learn dances, and have a hands-on workshop on Cherokee skills like pottery making, flintknapping, beadwork, or finger-weaving. Cherokee artists and performers also provide information in classes and workshops throughout the year. Their work is sold in the Museum Store on-site and online at www.cherokeemuseum.org.

The Museum has partnered with the North Carolina Arts Council on the Cherokee Heritage Trails Project, the Blue Ridge National Heritage Area, the revitalization of stamped pottery, exhibits, workshops, and more.

Junaluska Wreath Laying event set for Nov. 7

ROBBINSVILLE - Junaluska Memorial Site and Museum will host the annual Junaluska Wreath Laying Ceremony on Friday, Nov. 7 at 11:30 a.m. This year marks the 104th anniversary of the commemoration of the Junaluska gravesite monument.

Junaluska gained fame for his participation in the Battle of Horseshoe Bend. It was there that the Cherokee Nation assisted Andrew Jackson's Tennessee forces in the defeat of the Creek Nation in 1814. Junaluska is credited for recruiting 100 Cherokee warriors from North Carolina for the American cause.

During the removal of 1838, Junaluska departed with a detachment led by the Reverend Jesse Bushyhead on Sept. 3, 1838, on the infamous Trail of Tears. Several weeks later, Junaluska and Wachacha led a group of 50 others who deserted their detachment and attempted to return to their homes. Junaluska led a group of 25 older people while his little brother led a younger group of 25. Junaluska's group was captured just north of Knoxville, Tenn., and he was taken to Indian Territory under military escort.

A couple years later, Junaluska made his way back to North Carolina, and returned to his home place along Valley River. The state of North Carolina granted Junaluska 337 acres of land in 1847. A large

portion of his land is now a part of the present day town of Robbinsville.

Junaluska passed away on Nov. 20, 1858. He was buried on the land granted to him, along with his third wife Nicie. In 1910, the General Joseph Winston Chapter of the Daughters of the American Revolution placed a monument at his gravesite. This property was donated to the EBCI in 1998, when the Friends of Junaluska assumed responsibility for the memorial site and museum. In 2001, the then-EBCI Cultural

Resources Office (now the Kituwah Preservation and Education Program) began managing the site.

This year's guest speaker is Warren Dupree, Staff Sergeant U.S. Army Retired. He is with the Steve Youngdeer American Legion Post 143 which will act as the color guard for this year's event.

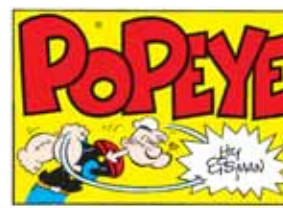
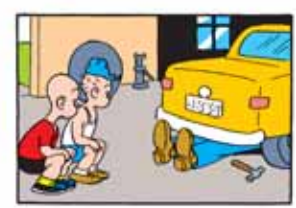
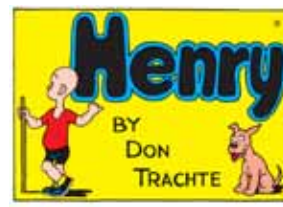


The Garden Bug

Leaves into compost

Rake leaves into a pile low enough to run over with a lawn mower. This shreds the leaves into smaller pieces that break down more quickly. 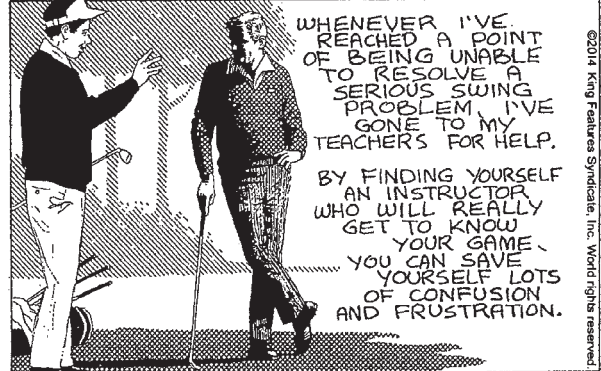
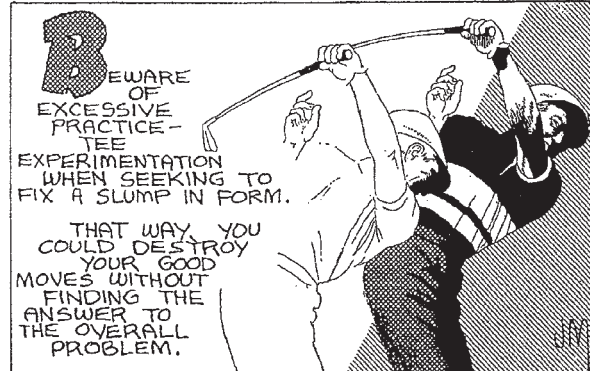

TEFAP Distribution for Cherokee Reservation

The TEFAP Distribution for this quarter will be held Thursday, Nov. 20 from 9-11:45am and 1-3:45pm. This distribution will be held at the Commodity Building on Old Mission Road. Foods will be served on a first-come, first-serve basis. This TEFAP distribution is ONLY for residents of the Qualla Boundary. If you do not reside on the Qualla Boundary but live in Jackson or Swain counties, you should seek assistance from the Department of Social Services in those counties. The TEFAP guidelines are different from the regular commodity program in this manner. The regular commodity program allows you to live off the Qualla Boundary in Jackson and Swain counties and still get assistance if you have an enrolled member residing in your household and meet the other guidelines. For this program, you must live on the Qualla Boundary.

Guidelines for the TEFAP program remain the same as in the past. If you receive assistance from Food Stamps or Commodities, you are eligible to receive the TEFAP foods. If you do not receive Food Stamps or Commodities and meet the income guidelines at the bottom of this announcement, you will also be eligible. Any questions, please call 497-9751.

People wishing to apply for the food products MUST come prepared to provide the following information:

- Name and physical address of household
- Total number of household members
- Total household monthly gross income if not receiving Food Stamps or Commodity Foods

VERY IMPORTANT: If the head of household is not present when the application is made, a note from them must be presented giving you permission to apply on their behalf. If a spouse is considered head of household on Food Stamps and the other spouse or another person living in the household is applying, then the head of household on the Food Stamp case must send a note giving that person permission to pick up their food.

Authorized Representatives may only pick up for two households. They may pick up for themselves and one other household or they may pick up for two households and not themselves.

Available items for this distribution are: applesauce cups, frozen blueberries, carrots, cranberry sauce, apple juice, cranberry juice concentrate, grapefruit juice, orange juice, macaroni, UHT milk, peanut butter, slice potatoes, and salmon. These items are served on a first-come, first-serve basis.
