Three to vie for Miss Cherokee title

Three EBCI tribal members are vying for the title of Miss Cherokee 2010. The pageant will be held in the Cultural Arts Center at the Cherokee Central Schools on Saturday, Oct. 2 at 6pm. The three contestants for the crown are Tonya Carroll, Cristyn Jones and Kelly Murphy.

Carroll, 25, is the daughter of Jan Smith and the late Kermit Carroll. She represents the Bird Town Community and holds a Masters Degree in History from Western Carolina University. She is currently the Outreach Coordinator for the Qualla Arts & Crafts Mutual Inc.

Jones, 18, is the old daughter of Carrie Smith and Bud Jones and Tracy Clark. She is the granddaughter of Lou Jackson and the Great-Granddaughter of Ed and Ella Jackson. She represents the Snowbird Community, and is a freshman at Western Carolina University.

Murphy, 20, is the daughter of Delores Queen and Clarence Murphy. She resides with her Grandmother Naomi Queen in the Painttown Community. She is currently employed at the New Kituwah Academy and is a second year student at Southwestern Community College.

"As we look back over the years, Miss Cherokee has always been a position of honor, dignity and respect," the EBCI Royalty Board said in a statement to the *One Feather*. "The early pageants had as many as 12 young Cherokee women competing for the coveted title. While there was zero to a very small budget available, it wasn't about the budget. It was about the honor of holding the Title and representing our great Nation, the 'Eastern Band of Cherokee'. It was also the utmost honor when an organization or business called and asked 'will you represent us as a contestant in the Miss Cherokee Pageant?'"

The statement continued, "For the past several years we have seen participation in the Pageant go from 8 to 12 contestants down to 3, 2, 1 and even 0. With the number of beautiful young women within our Tribe, and the many opportunities available for the Princess, it saddens us to see the lack of interest in today's pageants. Today we have a Royalty Board, whose primary objective is to advocate solely for the Princess. They see that she is available and able to attend many events and functions in order to promote Cherokee, NC."

But, the Board excited about this year's Pageant, "This year we have three beautiful and talented young women competing for the Title and we commend them and wish them the very best in not only the Pageant but also in their future endeavors."

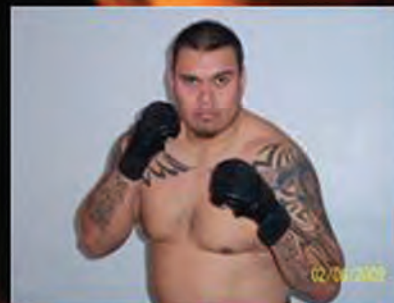

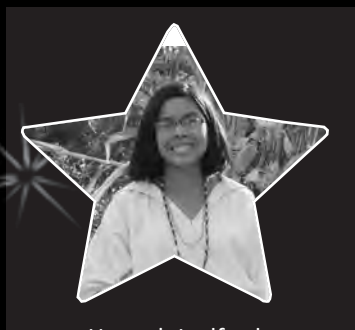

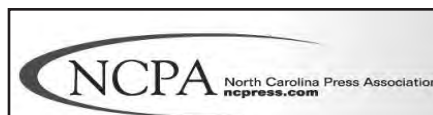

Tribe to receive \$1.6M in DOJ Grants

Funding from new CTAS Program to help Law Enforcement and Justice Programs

The Eastern Band of Cherokee Indians soon will be receiving major funding help with its law enforcement and justice programs. The U.S. Department of Justice announced on Wednesday, Sept. 15 that it is awarding \$127 million in grants to various tribes and the EBCI is slated to receive around \$1.6 million in three grants under a new program designed to help tribal law enforcement and public safety programs nationwide.

The Coordinated Tribal Assistance Solicitation (CTAS) program was developed out of Tribal consultation events according to Associate Attorney General Perelli.

"Today, we take another major step toward true nation-to-nation collaboration," he said. "CTAS is not only a more streamlined grant-making process, it is part of the department's broader strategy of increased engagement with tribal communities across a broad range of areas."

Cherokee Chief Justice Bill Boyum related that \$375,130 has been awarded to the Cherokee Tribal Court to fund three projects including: digitizing and shipping 66,000 files which are required to be stored in Kansas at the BIA document depository, fund the development of an electronic case management system, and provide training funding for all Court departments.

On the first project, Boyum related, "These files will be scanned and entered into a database that will allow us to access them through our current computer system. The Court will end up sending approximately 1,000 boxes of files to Kansas."

The second project will allow the Cherokee Court to purchase the ACIS electronic case management system. "The ACIS system will allow the Court to electronically access all cases within the system and will automatically notify NCDMV of traffic convictions," said Boyum. "Additionally, it will allow the Cherokee Police Department to access eCitations, which automatically enters traffic tickets into the Court's computer system and to access the NCAware system,

which provides notifications of pending state-wide warrants."

Boyum related that the training, provided for in the third project, will be utilized by the Probation Dept., clerks, magistrates and judges and will have an "emphasis on Federal Indian law."

Another grant totaling \$478,496 has been received by the Tribe's Juvenile Justice System. "The grant will allow for system-wide training on evidence-based models (judges, juvenile services staff, school staff, and law enforcement), and it will allow for the development of a tribal specific, culturally-based service/model as well as gender specific services/programs," said Hannah Smith, EBCI Legal Dept. "Finally, it will allow for the resources to track and analyze the success or failure of certain services and programs in order to capitalize on what helps youth become stronger, more responsible young adults and what does not."

In addition to above-listed funding, the Tribe will also receive \$750,000 from the Office of Violence Against Women to further its fight against domestic violence.

CTAS grants fall into several categories including: Tribal Resources Grant Program, Indian Alcohol and Substance Abuse Prevention Program, Tribal Courts Assistance Program, Correctional Facilities on Tribal Lands Program, Tribal Sexual Assault Services Program, Tribal Governments Program, Tribal Elder Outreach Program, Tribal Youth Program, and the Tribal Juvenile Accountability Discretionary Program.

In other law enforcement news, data from tribal nations has been included in the 2009 FBI Uniform Crime Report. According to the report, the Navajo Nation (Ariz.) reported the highest incidence of violent crimes at 905. The FBI defines violent crimes as murder or nonnegligent manslaughter, forcible rape, robbery, and aggravated assault.

Of the 905 violent crimes reported by the Navajo Nation, there were 15 murders, 374 rapes, 37 robberies and 479 aggravated assaults.

The EBCI only reported 34 violent crimes including 1 murder, 8 rapes, 3 robberies, and 22 aggravated assaults.

Nearby tribes reported much higher incidences of violent crime than the Eastern Band. The Seminole Tribe of Florida reported 110 (1 murder, 7 rapes, 34 robberies, 68 aggravated assaults) and the Mississippi Band of Choctaws reported 175 (1 murder, 7 rapes, 0 robberies, 167 aggravated assaults).

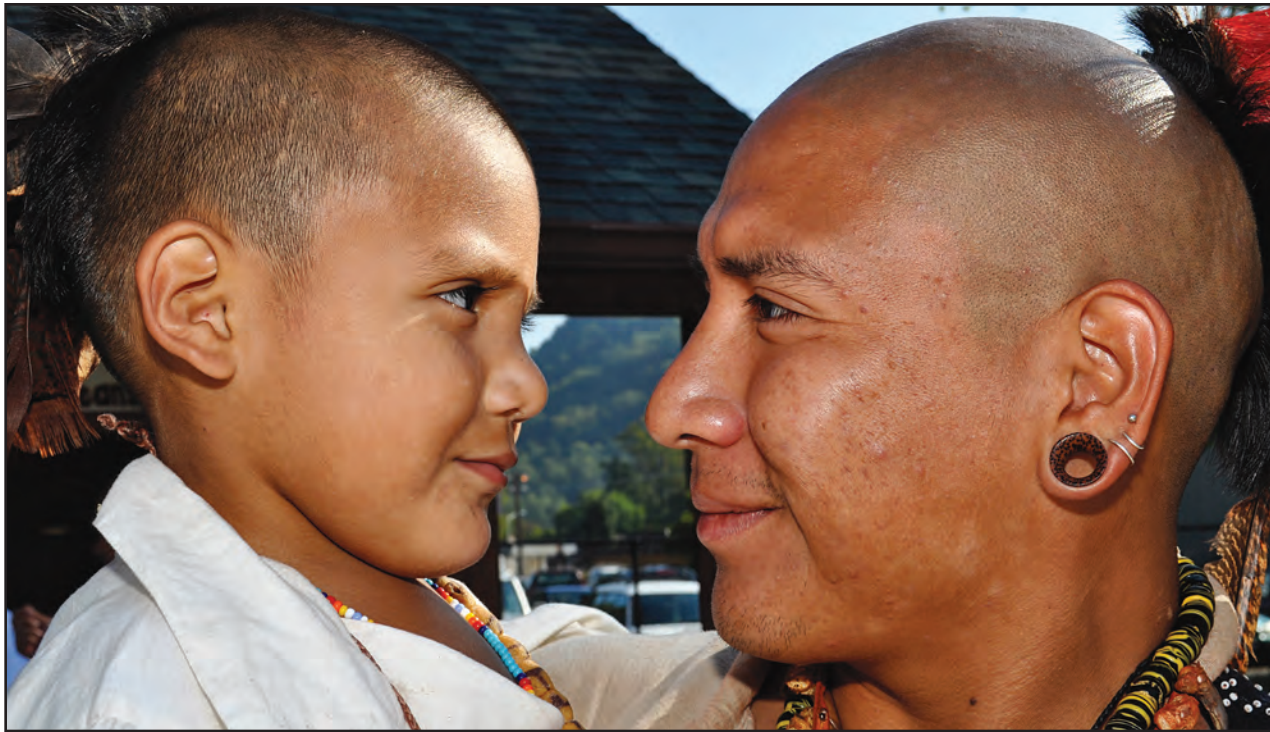

Hayesville squeaks by Braves in thriller

Two penalties late in the game definitely turned the tide away from the Braves and gave the Hayesville Yellow Jackets an early Christmas present in the form of a 29-28 win on Friday, Sept. 24 at Ray Kinsland Stadium.

Hayesville QB Zach Wall hit Blake Dockery on an 11-yard touchdown pass with just over two minutes left in the game. The play involved a controversial pass interference call against Cherokee which was declined by the Yellow Jackets who pulled to within a point on the play. Dakota Lyvers, who gained 100 yards on 14 carries in the game, ran for the 2-point conversion to give Hayesville the lead and the eventual win.

Cherokee got the ball back with 2:15 left and started at their own 37-yard

line following a 22-yard return by Seth Littlejohn. A penalty took the ball to mid-field and Cherokee set up shop 50 yards away from a win. The Braves gained two yards on their first two plays of the drive and one yard on a 3rd and 6 bringing up a crucial 4th and 5.

Cherokee QB Jesse Blanton darted and dipped on fourth down and made the sticks and then some down to the Hayesville 35-yard line for a Braves first down.

They tried for the homerun on first down, but the ball was incomplete in the end zone. Blanton completed a short pass on second down, but a holding call brought it back. With 38 seconds left and facing a 2nd and 19, Blanton took off around the right side, got the corner and ran it down to the 29-yard line when a Hayesville player knocked him into the brick side wall about five yards out of

bounds. No flag was thrown ...at least not on the Yellow Jackets. Cherokee got a sideline warning on the play and again the Braves were backed up.

Third down saw another incomplete pass near the end zone and Blanton was sacked on fourth down. Hayesville would just run out the remaining thirty seconds.

Cherokee led by two touchdowns twice in this game. They scored twice out of the blocks as Blanton ran for a 1-yard run on their first possession and Dorian Walkingstick returned an interception 42 yards for a score just two minutes later.

This was a game of two scores it seemed. Following Cherokee's two scores in the first quarter, the Yellow Jackets scored twice in the second quarter. Lyvers ran for a 6-yard touchdown and then Josh Maddox followed suit on a 3-yard run. The second point-after kick failed and the

Braves led 14-13 with just over two minutes left in the half.

But, Cherokee hadn't gotten their two yet...

On the next possession, Blanton hit Gabe McMillan on a 20-yard pass with under a minute left. Walkingstick would add the two point conversion to make it 22-13.

Hayesville fumbled the ensuing kickoff and the Braves set up shop at mid-field with just over 50 seconds left in the half.

On second down, Blanton hit Corbin Wright to the Hayesville 28-yard line. Following a couple of penalties on either side including a costly facemask penalty against the Yellow Jackets, the Braves hit the end zone against as Blanton found McMillan on a 7-yard pass. The

two-point run failed and Cherokee led 28-13 at halftime.

Both teams had one possession during the third quarter, but nothing came of either short of eating a lot of clock.

Hayesville got the ball to start the fourth quarter and started their comeback. After driving deep into Braves territory, Cody Gibson ran two yards for a score just several minutes into the quarter. Lyvers ran for the two-point conversion and the Yellow Jackets cut the lead to 29-21.

Cherokee fumbled on their next possession and gave the Yellow Jackets good field possession at the Braves 44-yard line. Minutes later, Wall would hit Dockery for the aforementioned pass and Lyvers would put the nail in the coffin with the two-point conversion.

This was a penalty-ridden game with 22 total in the game (Cherokee 13, Hayesville 9). Each team lost a fumble, and Hayesville threw one interception.

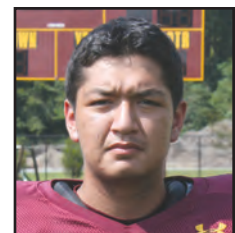

Cherokee Middle School receives funds from the Burroughs Wellcome Fund

The "CSI: Cherokee Science Investigation" program announced that it has received funding from the Burroughs Wellcome Fund. The CSI program is a two-week long early summer camp for students to excel in the sciences: Ecology, Environmental Chemistry, Biology, Geology, and Chemistry. The program also offers a week-long technology and engineering camp dealing with robotics in late summer. To provide a continuum of learning, students who attend the early summer camp will attend a fall and

spring Saturday Academy. Cherokee Central Schools fund a robotics team to compete in LEGO League tournaments throughout the year.

The students who participate in this program will have an opportunity to expand their scientific knowledge by learning through research and hands-on investigations. They will use environmental science equipment to analyze reservation conditions. They will collect and analyze data in the field as well as become exposed to scientific equipment in the lab, such as the projection microscope. Students in this program will learn how to safely conduct environmental and chemistry experiments with the help of trained professionals, as

well as travel to nearby Western Carolina University and other universities for a broader exposure.

This program is a two week program available to Middle School students at Cherokee Central Schools. Other institutes receiving funds are Durham Academy, Elizabeth City State University, and Foundation of the Carolinas/McClintock Partners in Education, NC Society of Hispanic Professionals, NC State University, Shodor Education Foundation Inc., Wake Forest University, and West Marion Elementary School. 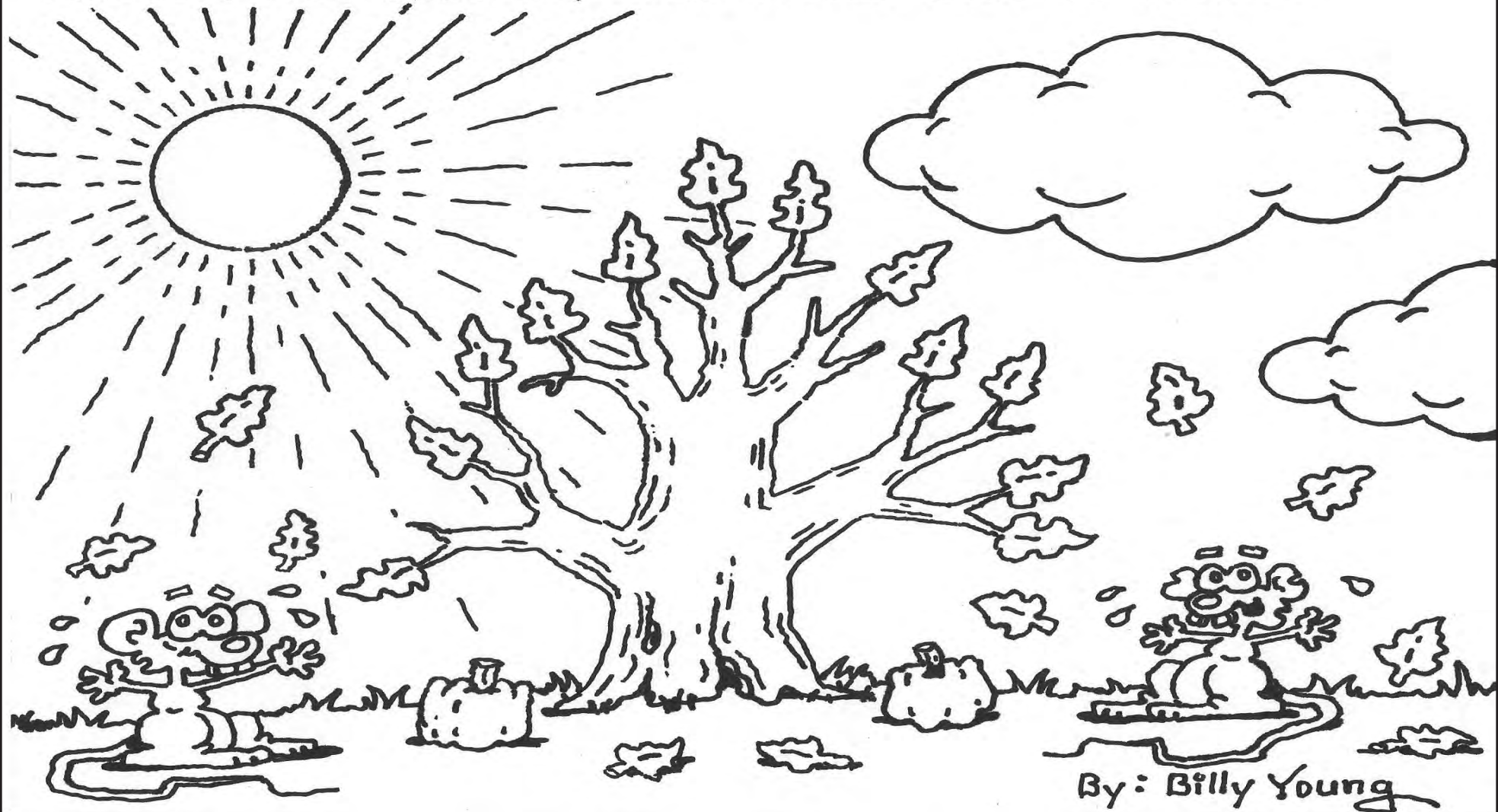

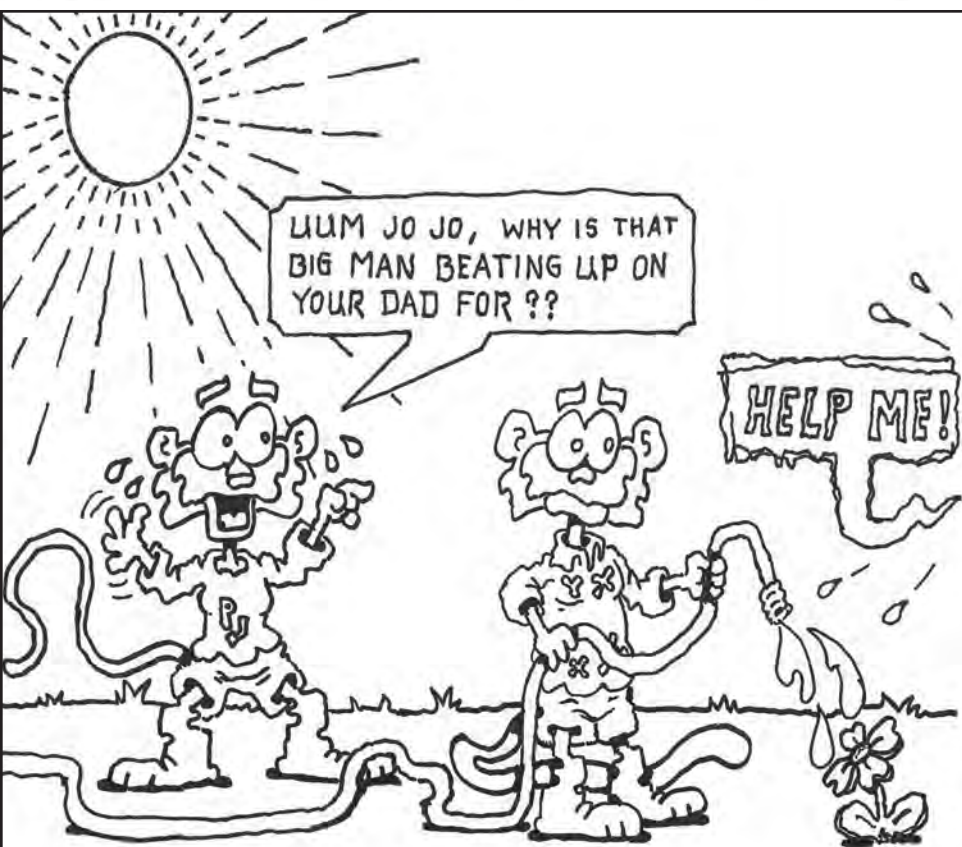

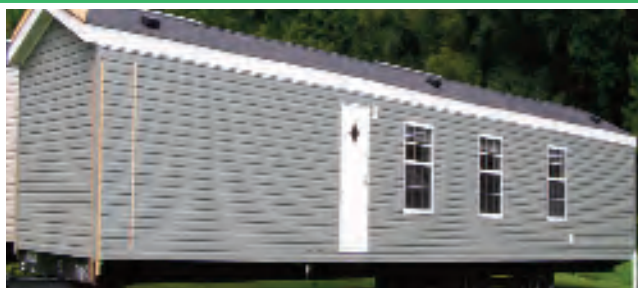
