**RESOLUTION NO. 50 (2021)**

*A resolution to exclude April Nations from the lands of the Eastern Band of Cherokee Indians.*

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of those lands and the welfare of the members of the Tribe; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and
- WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and
- WHEREAS, APRIL NATIONS (date of birth 07/25/1985) is not a member of the Eastern Band of Cherokee Indians, but has been found to be on tribal trust lands while allegedly committing crimes; and
- WHEREAS, on March 25, 2021, APRIL NATIONS was arrested at Whitewater Drive on the Qualla Boundary and charged with Possession of a Controlled Substance, Schedule II – Heroin, and Possession of Schedule II – Methamphetamine, in violation of state and tribal law; and
- WHEREAS, according to the Cherokee Police Department's Master Name Index Involvement History, APRIL NATIONS has at least eighty-two (82) entries, which indicate numerous incidents with CIPD officers going back to 2010; and
- WHEREAS, APRIL NATIONS has faced numerous charges in several jurisdictions as an adult person; and
- WHEREAS, APRIL NATIONS has faced numerous recent charges of drug offenses and theft crimes;
- WHEREAS, APRIL NATIONS was taken before a Cherokee Court Magistrate on September 9, 2021, and a Writ of Emergency Temporary Exclusion was issued and served on her by hand delivering a copy of the Writ to her, and she was scheduled to appear before Tribal Council on November 4, 2021; and
- WHEREAS, due to the nature of these charges and based on her lengthy history with CIPD officers, the Tribal Council has good reason to believe that APRIL NATIONS is a threat to the integrity, law and order of EBCI lands and the welfare of the

members of the Tribe.

NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present and with the number of votes required by Tribal law, APRIL NATIONS is hereby permanently excluded from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

BE IT FURTHER RESOLVED that this permanent exclusion prohibits APRIL NATIONS from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.

BE IT FURTHER RESOLVED that if APRIL NATIONS is found improperly on Tribal lands at any time after the effective date of this resolution She shall be treated as a trespasser and appropriate legal action shall be taken against her.

BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
