RESOLUTION NO. 56 (2021)

*A resolution to exclude Haley Lauren Jarvis from the lands of the Eastern Band of Cherokee Indians.*

WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of those lands and the welfare of the members of the Tribe; and

WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and

WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and

WHEREAS, HALEY LAUREN JARVIS (date of birth 06/09/1992) is not a member of the Eastern Band of Cherokee Indians; and

WHEREAS, on October 26, 2021, HALEY LAUREN JARVIS was arrested on the Qualla Boundary on Soco Mountain at Hyatt Cove Road and charged with Possessing a Controlled Substance Classified in Schedule I of the Controlled Substances Act, in violation of Cherokee Code 14-95.5(a), and Possession of Drug Paraphernalia in violation of N.C.G.S. 90-113.22(A); and

WHEREAS, on October 26, 2021, HALEY LAUREN JARVIS was taken before a tribal magistrate and served with a Writ of Emergency Temporary Exclusion and told she was being excluded from the lands of the Eastern Band of Cherokee Indians; and

WHEREAS, in 2020, HALEY LAUREN JARVIS was arrested in Buncombe County NC and charged with Misdemeanor Child Abuse and Possession of Drug Paraphernalia (Misdemeanor); and

WHEREAS, due to the nature of these charges, the Tribal Council has good reason to believe that HALEY LAUREN JARVIS is a threat to the integrity, law and order of Eastern Band of Cherokee Indians lands and the welfare of the members of the Tribe.

NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present and with the number of votes required by Tribal law, HALEY LAUREN JARVIS is hereby permanently excluded from all Tribal lands

and is hereby notified and ordered to vacate all tribal lands.

BE IT FURTHER RESOLVED that this permanent exclusion prohibits HALEY LAUREN JARVIS from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.

BE IT FURTHER RESOLVED that if HALEY LAUREN JARVIS is found improperly on Tribal lands at any time after the effective date of this resolution she shall be treated as a trespasser and appropriate legal action shall be taken against her.

BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.


