RESOLUTION NO. 114	_ (2022)	

A resolution to exclude Brandon Lee Gibson from the lands of the Eastern Band of Cherokee Indians.

WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of the lands, and the welfare of Tribal members; and WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and WHEREAS, BRANDON LEE GIBSON (Date of Birth: 04/12/1977) is not a member of the Eastern Band of Cherokee Indians, and has been residing in Haywood County, North Carolina; and WHEREAS, on November 17, 2021, BRANDON LEE GIBSON was a passenger in a vehicle leaving a known drug house in the Wrights Creek area of the Qualla Boundary; and WHEREAS, the vehicle was stopped by Cherokee Indian Police Department officers after the driver of the vehicle failed to stop at a stop sign prior to turning from Wrights Creek Road onto US Highway 19; and WHEREAS, BRANDON LEE GIBSON was found sitting in the back seat of the vehicle in proximity to a plastic baggie containing a substance consistent with methamphetamine; and WHEREAS, BRANDON LEE GIBSON was arrested and charged with Possession of a Schedule II Controlled Substance, Methamphetamine, in violation of N.C.G.S. § 90-95(A)(3), in Jackson County District Court; and WHEREAS, while in custody, BRANDON LEE GIBSON was served with a Writ of Emergency Temporary Exclusion issued by a Cherokee Court magistrate; and WHEREAS, on October 22, 2021, BRANDON LEE GIBSON was arrested in Haywood

- WHEREAS, BRANDON LEE GIBSON has a lengthy criminal history, including charges for Breaking or Entering a Motor Vehicle, Larceny, Possession of Stolen Goods, Uttering Forged Instruments, Larceny of a Motor Vehicle, Felony Identify Theft, Felony Failure to Stop for Hit and Run Causing Serious Injury, Harassment of a Juror, Obstruction of Justice, Felony Conspiracy, Injury to Telephone Wires, Larceny of a Firearm, and other assorted criminal charges; and
- WHEREAS, dating back to 2009, BRANDON LEE GIBSON has over 27 total involvements with the Cherokee Indian Police Department; and
- WHEREAS, due to the nature of the alleged criminal actions and lengthy criminal history of BRANDON LEE GIBSON, and based on his residing near Tribal trust lands, the Tribal Council has good reason to believe that BRANDON LEE GIBSON is a threat to the integrity, law and order of EBCI lands and the welfare of the members of the Tribe.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, BRANDON LEE GIBSON is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.
- BE IT FURTHER RESOLVED that this permanent exclusion prohibits BRANDON LEE GIBSON from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if BRANDON LEE GIBSON is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
