RESOLUTION NO. <u>130</u> (2022)

A resolution to exclude Lori Ann Buchanan from the lands of the

Eastern Band of Cherokee Indians. WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of the lands, and the welfare of Tribal members; and the Tribal Council has codified its authority to exclude persons from the lands of WHEREAS, the Eastern Band at Chapter 2 of the Cherokee Code; and WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and WHEREAS, LORI ANN BUCHANAN (Date of Birth: 02/20/1970) is not a member of the Eastern Band of Cherokee Indians, and has been residing at 163 Bird Hill Road in Cherokee; and WHEREAS, on December 13, 2021, LORI ANN BUCHANAN was found on Tribal trust lands allegedly while in possession of methamphetamine and suboxone; and WHEREAS. subsequent to her arrest by Cherokee Indian Police Department officers, a Swain County magistrate found probable cause to charge LORI ANN BUCHANAN with Felony Possession of a Schedule II Controlled Substance, in violation of N.C.G.S. § 90-95(A)(1), and Misdemeanor Possession of a Schedule III; and WHEREAS, LORI ANN BUCHANAN is currently facing charges of Felony Possession of Methamphetamine and Misdemeanor Possession of Schedule III Controlled Substance in Swain County District Court in case number 21-CR-50586, with a court date pending on January 18, 2022; and WHEREAS, while in custody, on December 13, 2021, LORI ANN BUCHANAN was served with a Writ of Emergency Temporary Exclusion issued by a Cherokee Court magistrate; and WHEREAS, LORI ANN BUCHANAN is currently facing the following charges by Cherokee Indian Police Department officers, which have been filed in Swain County District Court:

- WHEREAS, due to the nature of the alleged criminal actions of LORI ANN BUCHANAN and based on her residing on or near Tribal trust lands, the Tribal Council has good reason to believe that LORI ANN BUCHANAN is a threat to the integrity, law and order of EBCI lands and the welfare of the members of the Tribe.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, LORI ANN BUCHANAN is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.
- BE IT FURTHER RESOLVED that this permanent exclusion prohibits LORI ANN BUCHANAN from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if LORI ANN BUCHANAN is found improperly on Tribal lands at any time after the effective date of this resolution, she shall be treated as a trespasser and appropriate legal action shall be taken against her.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
