RESOLUTION NO. 132 (2022)

A resolution to exclude Evanna Ulexis Lee from the lands of the Eastern Band of Cherokee Indians.

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of the lands, and the welfare of Tribal members; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and
- WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and
- WHEREAS, EVANNA ULEXIS LEE (Date of Birth: 03/28/1980) is not a member of the Eastern Band of Cherokee Indians, and has been residing in and around Tribal trust land, including at the address of 30 Twin Forks Drive in Cherokee; and
- WHEREAS, on January 7, 2022, EVANNA ULEXIS LEE was found on Tsali Manor Street, Apartment 15, on Tribal trust lands, where she is alleged to have been in possession of methamphetamine; and
- WHEREAS, subsequent to her arrest by Cherokee Indian Police Department officers, a Swain County magistrate found probable cause to charge EVANNA ULEXIS LEE with Felony Possession of a Schedule II Controlled Substance, in violation of N.C.G.S. § 90-95(A)(1); and
- WHEREAS, EVANNA ULEXIS LEE is currently facing the following charges in the following neighboring county jurisdictions:

- WHEREAS, while in custody, on January 7, 2022, EVANNA ULEXIS LEE was served with a Writ of Emergency Temporary Exclusion issued by a Cherokee Court magistrate; and
- WHEREAS, the criminal history search of EVANNA ULEXIS LEE reveals a wide range of criminal charges from various states, including Felony Receiving Stolen Goods in South Carolina, Felony Larceny and Felony Obtaining Property by False Pretenses in North Carolina, and Possession of Methamphetamine and Possession of a Controlled Substance on a Jail Premises in North Carolina; and
- WHEREAS, due to the nature of the alleged criminal actions of EVANNA ULEXIS LEE and based on her residing in and around Tribal trust lands, the Tribal Council has good reason to believe that EVANNA ULEXIS LEE is a threat to the integrity, law and order of EBCI lands and the welfare of the members of the Tribe.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, EVANNA ULEXIS LEE is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.
- BE IT FURTHER RESOLVED that this permanent exclusion prohibits EVANNA ULEXIS LEE from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if EVANNA ULEXIS LEE is found improperly on Tribal lands at any time after the effective date of this resolution, she shall be treated as a trespasser and appropriate legal action shall be taken against her.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.

WHEREAS, ERIC DANIEL VAUGHN was previously convicted in Federal District Court of one count of Committing an Act of Juvenile Delinquency by Assaulting an Indian

- with the Intent to do Bodily Harm, for which he was sentenced to 18 months in federal prison; and
- WHEREAS, ERIC DANIEL VAUGHN has a lengthy criminal history involving multiple felony charges in different states, including drug crimes; and
- WHEREAS, due to the nature of the alleged criminal actions in January 2022 and previously of ERIC DANIEL VAUGHN, the Tribal Council has good reason to believe that ERIC DANIEL VAUGHN is a threat to the integrity, law and order of EBCI lands and the welfare of the members of the Tribe.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, ERIC DANIEL VAUGHN is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.
- BE IT FURTHER RESOLVED that this permanent exclusion prohibits ERIC DANIEL VAUGHN from entering on or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if ERIC DANIEL VAUGHN is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
