RESOLUTION NO. 728 (2015)

- WHEREAS, the Eastern Band of Cherokee Indians (Tribe) has the sovereign authority to exclude persons from lands of the Tribe in order to protect the integrity and law and order of those lands or the welfare of the members of the Tribe; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Tribe at Chapter 2 of the Cherokee Code; and
- WHEREAS, MATTHEW ADAM FREEMAN is not a member of the Eastern Band of Cherokee Indians and is or has been entering or residing on Tribal lands; and
- WHEREAS, MATTHEW ADAM FREEMAN was temporarily excluded on June 1, 2015 due to violation of Cherokee Criminal Code and North Carolina General Statutes for the following drug related offenses:

- WHEREAS, Tribal Council has good reason to believe that MATTHEW ADAM FREEMAN is a threat to the law and order on Tribal lands and a threat to the welfare of enrolled members by engaging in drug related conduct.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled, with a quorum present and with the number of votes required by Tribal law that MATTHEW ADAM FREEMAN is hereby <u>permanently</u> excluded from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

BE IT FURTHER RESOLVED that this permanent exclusion prohibits MATTHEW ADAM FREEMAN from entering on or being present on Tribal lands for any purpose except as required by a subpoena issued by Tribal Council or Tribal Court.

BE IT FURTHER RESOLVED that if MATTHEW ADAM FREEMAN is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.

BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
