## RESOLUTION NO. <u>618</u> (2011)

- WHEREAS, the Eastern Band of Cherokee Indians has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of those lands and the welfare of the members of the Tribe; and
- WHEREAS, Charles Kyle Doalson is not a member of the Eastern Band of Cherokee Indians and is currently entering or residing on Tribal lands; and
- WHEREAS, Charles Kyle Doalson threatens law and order on Tribal lands and the welfare of enrolled members; and
- WHEREAS, Charles Kyle Doalson's behavior has resulted in the reasonable belief among members of the Eastern Band of Cherokee Indians that he poses a substantial threat of further injury to property and persons if he is allowed to remain; and
- WHEREAS, Charles Kyle Doalson has been charged by the Cherokee Police for the following criminal acts:
  - a. Cherokee Code 14-95.(a) Possessession of a Schedule III controlled substance (Vicodin)
  - b. Cherokee Code 14-95.5(b) Possession of Marijuana, less than one half once
  - c. Cherokee Code 14-95.11(c) Possession of Drug paraphernalia
  - d. Cherokee Code 14.95.22 Prior convictions
- WHEREAS, Charles Kyle Doalson's continued presence and behavior constitutes a threat to the integrity and order of the lands and territory of the Eastern Band and to the welfare of its members; and
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled, and with a quorum present, and by a three-fourths vote of the Tribal Council, that for good cause shown, that a hearing will be held before Tribal Council to determine whether Charles Kyle Doalson should be temporarily excluded from Tribal lands owned by or held in trust for this Tribe.

- BE IT FURTHER RESOLVED that if after the exclusion hearing Tribal Council shall determine that exclusion is warranted, Charles Kyle Doalson shall be given notice to vacate and shall remove himself and his personal property from all Tribal lands within the time specified by Tribal Council.
- BE IT FURTHER RESOLVED that written notice of the exclusion hearing shall be provided to Charles Kyle Doalson.
- BE IT FURTHER RESOLVED that if Charles Kyle Doalson is found on Cherokee lands at any time after being excluded, he shall be treated as a trespasser and law enforcement personnel shall arrest him and take other appropriate legal action against him.
- BE IT FINALLY RESOLVED that this resolution shall be effective upon ratification by the Principal Chief.

- Amendment: In the "NOW, THEREFORE BE IT RESOLVED" paragraph, strike the word "temporarily" and replace with "permanently."
