RESOLUTION NO. 712 (2011)

WHEREAS, the Eastern Band of Cherokee Indians has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of those lands and the welfare of the members of the Tribe; and

WHEREAS, Patrick Scott Carringer is not a member of the Eastern Band of Cherokee Indians and is currently entering or residing on Tribal lands; and

WHEREAS, Patrick Scott Carringer uses the following aliases:

Eddie Patrick Carringer
Scott Patrick Carringer
Patrick Eddie Scott Carringer

WHEREAS, Patrick Scott Carringer threatens safety and welfare of the community of Tribal lands and the welfare of enrolled members; and

WHEREAS, Patrick Scott Carringer's behavior has resulted in the reasonable belief among members of the Eastern Band of Cherokee Indians that he poses a substantial threat of further injury to property and persons if he is allowed to remain; and

WHEREAS, Patrick Scott Carringer's continued presence and behavior constitutes a threat to the integrity and order of the lands and territory of the Eastern Band and to the welfare of its members; and

NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled, and with a quorum present, and with the number of votes required by Tribal law that Patrick Scott Carringer is hereby **temporarily excluded** until the next Tribal Council Session on **June 2, 2011**, from all Tribal lands and that for good cause shown, that a hearing will be held before Tribal Council to determine whether Patrick Scott Carringer should be **permanently** excluded from Tribal lands owned by or held in trust for this Tribe.

BE IT FURTHER RESOLVED that if after the exclusion hearing Tribal Council shall determine that exclusion is warranted, Patrick Scott Carringer shall be given twenty-four (24) hours to remove himself and his personal property from all Tribal lands.

BE IT FURTHER RESOLVED that written notice of the exclusion hearing shall be provided to Patrick Scott Carringer.

BE IT FURTHER RESOLVED that if Patrick Scott Carringer is found on Cherokee lands at any time after being excluded, he shall be treated as a trespasser and law enforcement personnel shall arrest him and take other appropriate legal action against him.

BE IT FINALLY RESOLVED that this resolution shall be effective upon ratification by the Principal Chief.


