RESOLUTION NO. <u>773</u> (2009)

- WHEREAS, the Eastern Band of Cherokee Indians (Tribe) has the sovereign authority to exclude persons from lands of the Tribe in order to protect the integrity and law and order of those lands or the welfare of the members of the Tribe; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Tribe at Chapter 2 of the Cherokee Code; and
- WHEREAS, DERRICK JAMISON GRAHAM is not a member of the Eastern Band of Cherokee Indians and is or has been entering or residing on Tribal lands; and
- WHEREAS, DERRICK JAMISON GRAHAM was temporarily excluded on March 10, 2009 due to violation of Cherokee Criminal Code for the following drug related offenses:
 - a. Cherokee Code 14-95.5(a) Possession of Controlled Substance –
 Schedule I
 - b. Cherokee Code 14-95.11(c) Possession of Drug Paraphernalia; and
- WHEREAS, Tribal Council has good reason to believe that DERRICK JAMISON GRAHAM is a threat to the law and order on Tribal lands and a threat to the welfare of enrolled members by engaging in drug related conduct.
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled, with a quorum present and with the number of votes required by Tribal law that the Writ previously issued upon DERRICK JAMISON GRAHAM be renewed until the next scheduled session of Tribal Council for a hearing to review all facts and determinations in this matter.
- BE IT FURTHER RESOLVED that this renewed Writ prohibits DERRICK JAMISON GRAHAM from entering on or being present on Tribal lands for any purpose except as permitted by Tribal Council.

- BE IT FURTHER RESOLVED that if DERRICK JAMISON GRAHAM is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.


