RESOLUTION NO. 374 (2022)

A resolution to exclude William Jesse Garrett from the lands of the Eastern Band of Cherokee Indians.

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of the lands, and the welfare of Tribal members; and the Tribal Council has codified its authority to exclude persons from the lands of WHEREAS. the Eastern Band at Chapter 2 of the Cherokee Code; and WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and WHEREAS, WILLIAM JESSE GARRETT (Date of Birth: 09/22/1991) is not a member of the Eastern Band of Cherokee Indians; and WHEREAS, on July 17, 2022, Cherokee Indian Police Department officers responded to 719 Seven Clans Lane to a call about a suspicious vehicle and possible drug activity in the casino parking deck; and WHEREAS, WILLIAM JESSE GARRETT was arrested and charged in Jackson County District Court with Felony Possession of Schedule I Controlled Substance and Possession of Drug Paraphernalia in case 22-CR-381; and WHEREAS, WILLIAM JESSE GARRETT was served with a Writ of Temporary Emergency Exclusion in case TB-22-021 and was given a date by the Cherokee Court magistrate to appear before Tribal Council: and
- WHEREAS, due to the nature of the alleged criminal actions of WILLIAM JESSE GARRETT,
 Tribal Council has good reason to believe that he is a threat to the integrity, law
 and order of EBCI lands and the welfare of the members of the Tribe; and
- WHEREAS, WILLIAM JESSE GARRETT is a white male, 5'11" tall, with blonde hair and blue eyes; and
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, WILLIAM JESSE GARRETT is hereby PERMANENTLY EXCLUDED from all
