BE IT FURTHER RESOLVED this resolution shall become effective upon ratification by the Principal Chief.



#### Biographical Sketch of Mary A. Herr

Born in Springfield, IL, Mary Herr grew up on a farm 60 miles south of there. A former VISTA volunteer with a secretarial and insurance background, Mary met FOCIS members in Knoxville, joined FOCIS in 1969 and began volunteering in Clairfield, TN the next year. Mary later moved to Clairfield, helping establish the legal services program there and training numerous paralegals throughout the region. Since 1978 Mary has lived in the Cherokee, North Carolina area and has been the founding member of several non-profit organizations serving the Qualla Boundary including a domestic violence program, mediation center, a scholarship fund for higher education for Eastern Cherokees, and the Healing and Wellness Coalition.

Mary is currently Regional Faith Formation Consultant and Multi-Cultural Worker in the Smoky Mountain Vicariate (seven western counties in North Carolina including the Qualla Boundary) employed by the Roman Catholic Diocese of Charlotte. Mary has a B.A. in Business Administration and Legal Education from Roger Williams University and has been employed with several legal services programs in TN and NC as a paralegal and community educator. She also served as program supervisor for the Guardian ad Litem program serving the Qualla Boundary and three counties for six years. Mary serves on boards of several non-profit and community organizations including Cherokee Compassionate Ministries, Cherokee Interdenominational Fellowship, Far West Families First, Healing and Wellness Coaliton, Mountain Mediation Services, Office of Economic Opportunity of Catholic Social Services, Qualla/Swain Families First, and the local Legal Aid of North Carolina program.

### 4/10/07 History of Cherokee Healing and Wellness Coalition

2002 – Coalition formed after concern by tribal programs and Indian Health Service, some churches and hospital chaplains about increasing substance abuse, diabetes and depression followed by a presentation by Maria Brave Heart, PHD, and Birgel Kills Straight, Lakota Traditionalist.

2003 - Presentations by Patty Grant to each community club, and other organizations in the surrounding area. The Coalition sponsored an eight week cultural orientation at the Cherokee Indian Hospital for hospital employees and community members.

2004 – Sponsored "Healing 500 Years of Pain: Creating a Peaceful Spirit" conference with nationally known speakers, bringing together community members, mental health and medical professionals, ministers, the recovery community, and other interested tribal and non-tribal people from surrounding areas, other states and Canada.

2005 - Coalition sponsored a two day seminar lead by Loretta Standley, DC, an enrolled member of EBCI, and additional training by Eduardo Duran, PHD, an author, mental health counselor, program director, and nationally known for his work in the area of historical grief and trauma. The Coalition submitted a resolution to Tribal Council requesting that a parcel of land which was formerly part of the Cherokee Indian Boarding School be preserved, and the resolution was approved. Planning began for a conference in 2006.

2006 - Coalition sponsored "Creating a Peaceful Spirit: A Journey to Healing" conference August 3-4, 2006 at the Cherokee High School. On September 26, 2006, the Coalition held a convening of the entire Cherokee community including tribal government and programs, educational systems, human and health service populations and surrounding area service providers to encourage collaboration and cooperation of all of these entities.

2007 – On January 25, 2007, the Coalition approved a partnership with the Kituwah Preservation and Education Program regarding a Boarding School Memorial Project. Several Coalition members agreed to work on this project.

On January 31, 2007 a half-day retreat was held facilitated by Craig White with Center for Participatory Change to look at where we have come from, problems, vision and strategies.

On March 22 and 23, 2007 the Coalition in partnership with Cherokee Indian Helpers/Wellbriety and several churches on the Qualla Boundary sponsored the Broken Walls group from Canada for two concerts and a workshop on bullying.

Plans are underway for another conference "Healing Cultural Oppression" to be held August 15-17, 2007.
