NOW THEREFORE BE IT RESOLVED BY The Eastern Band of Cherokee Indians in Annual Council assembled at which a quorum is present that: The Eastern Band of Cherokee Indians hereby express our deep appreciation to Mr. Sandleitner for his friendship, leadership, and distinguished service.

BE IT FURTHER RESOLVED THAT: Mr. Sandleitner is adopted this 4th day of August 1994, as an honorary member of the Eastern Band of Cherokee Indians and be given the name of: a s ga ya a ga ta na i, which means "Man of Knowledge".
