RESOLUTION NO. 592

BE IT RESOLVED BY THE EASTERN BAND OF CHEROKEE INDIANS IN SPECIAL COUNCIL ASSEMBLED THAT WE DO HEREBY PROCLAIM THAT:

- WHEREAS; Darrell Fleming officially was assigned to Cherokee as the Agency Superintendent by the Bureau of Indian Affairs on September 20, 1959, and
- WHEREAS; he has been in this position since that date to the present, and
- WHEREAS; he has performed the duties of the Agency Superintendent in such an outstanding manner as to far exceed the usual requirements or expectations of the position, and
- WHEREAS; he has been influential and instrumental in developing and making available many programs and resources to better the life and living conditions of the Cherokee Indians, to wit:
 - 1. He has been largely responsible for providing an overall planning program for the Cherokee Indian Reservation, the implementation of which plan will continue to benefit the Eastern Band of Cherokee Indians.
 - 2. He has been elargely responsible for the establishment of two industrial plants on or near the reservation, and has in this and other ways increased the employment opportunities for the Indians.
 - 3. He has been responsible for clarifying and surveying Indian possessory holdings in such a way as to establish the vehicle to make credit available for the first time to the Cherokees for housing and for business purposes.
 - 4. He has been responsible for making a government low rent housing project available to meet our acute housing needs.
 - 5. He has been influential in developing more adequate health and welfare resources for our people.
 - 6. He has in fact been influential or responsible for so many programs and projects which will benefit us.
- THEREFORE BE IT RESOLVED, that the Eastern Band of Cherokee Indians in council assembled;

Hereby Regretfully sees him reassigned to other duties at Gallup, New Mexico, and

Hereby Respectfully Requests that if the Bureau of Indian Affairs should at any time deem it possible to permit him to return to Cherokee to finish the work he has started, that this be given positive action, and

Hereby Resolves to make Darrell Fleming an honorary member of the Eastern Band of Cherokee Indians inasmuch as membership has been denied him through the forced mobility of his great grandmother to Oklahoma in 1838 and to bestow upon him the name of: OSKI WAGESKI (Real Go Getter), and

Hereby Resolves that Oski Wageski shall be given the special privilege of a long term lease on property of the Cherokee Nation for the purposes of a retirement residence if he should deem it desirable to return to us at that time.
