RESOLUTION NO. 392 (2022)

WHEREAS, many speakers of the Snowbird Community have moved to Cherokee for employment, and,

WHEREAS, most of the members who have moved are fluent speakers and those speakers combined with the Snowbird Speakers represent almost 30% of the fluent speakers, and,

WHEREAS, all of those fluent speakers from the Snowbird Community attended the Snowbird Day School and all of those students were allowed to speak and use the language in the classroom, playground and lunchroom, and,

WHEREAS, Albert and Louise Lee impacted students from 1948-1963 and Albert and Louise Lee completely ignored the infamous words of Brigadier General Henry Pratt "Kill the Indian, save the man", and,

WHEREAS, Albert and Louise Lee were teachers who encouraged the use of Cherokee while encouraging students to learn English and they are two of the biggest factors for the high number of speakers from this small community

NOW THEREFORE BE IT RESOLVED, by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that Tribal Council recognize Albert and Louise Lee posthumously as honorary members of the Eastern Band of Cherokee Indians

BE IT FINALLY RESOLVED that Albert and Louise Lee be given the title of Tsunigeyu Dinadeyohvsgi (Beloved Teachers) and that this resolution shall become effective upon ratification of the Principal Chief
