WHEREAS: Mr. Sinback gives unselfishly of his valuable time, talents, and wisdom in his service to the tribe which greatly benefits the present and future generations of the Eastern Band of Cherokee Indians.

NOW THEREFORE BE IT RESOLVED BY The Eastern Band of Cherokee Indians in Annual Council assembled at which a quorum is present that: The Eastern Band of Cherokee Indians hereby express our deep appreciation to Mr. Sinback for his friendship, leadership, and distinguished service.

BE IT FURTHER RESOLVED THAT: Mr. Sinback is adopted this 4th day of August 1994, as an honorary member of the Eastern Band of Cherokee Indians and be given the name of: a da ge ti i di gv ne, which means "Image Builder".
