On October 10, 1986, the Tribal Council of the Eastern Band of Cherokee Indians passed Resolution No. 375 (1986), which has subsequently been properly ratified.

BE IT FURTHER RESOLVED THAT: Mr. Delmar Robinson be adopted as an honorary member of the Eastern Band of Cherokee Indians and be given the name di-go-tsv-gi a-li-nv-tlv-i which means Builder of Brotherhood.
