RESOLUTION NO. <u>598</u> (1989)

- WHEREAS, The enrolled members of the Eastern Band of Cherokee are concerned about preserving and maintaining the history, tradition and cultural heritage of the Tribe, and
- WHEREAS, Peter "Wolf" Toth an Artist has dedicated his life to creating sculptures of American Indians as a protest against their plight and betrayal, and
- WHEREAS, During the past three (3) months Peter "Wolf" Toth has been creating a sculpture of Sequoyah a renowned Cherokee inventor of a syllabary for writing the Cherokee Language.
- WHEREAS, Mr. Toth has traveled many miles for nearly 18 years to all fifty (50) states creating from stone and logs Indian likenesses; he refuses compensation for his creations considering them gifts to a people and posterity.
- NOW, THEREFORE BE IT RESOLVED by the Eastern Band of Cherokee Indians in Annual Council Assembled, at which a quorum is present, that the Tribal Council with great pride and appreciation does hereby proclaim Peter "Wolf" Toth to be an honorary member of the Eastern Band of Cherokee Indians.
- BE IT FINALLY RESOLVED, Peter "Wolf" Toth shall be given the name Peter "Wolf" Indian Giver, Pl. Gran-DBO DE Act, and the Principal Chief is hereby authorized to carry out the intent of this resolution.
