RESOLUTION NO. 603 (2019)

WHEREAS The Cherokee language has been recognized by all three federally recognizes Cherokee tribes as endangered: and

WHEREAS, whereas Dr. Hartwell Francis has been a great friend to all three federally recognized Cherokee tribes by recording meetings and presenting material for preservation; and,

WHEREAS, Dr. Hartwell Francis has shared all his developmental works with all tribes and any of the Eastern band of the Cherokee programs that have made a request; and,

WHEREAS The Eastern Band of the Cherokee Indians has put forth a great effort and promise to save the language; and

WHEREAS and, Dr. Hartwell Francis has focused specifically on saving the Eastern band of the Cherokee dialect with respect to all communities; and,

WHEREAS, recording our speakers in the community is crucial to the efforts to revitalize and save the integrity of Cherokee language for the Eastern band of Cherokees and Dr. Hartwell Francis has recorded more than 1000 hours of fluent speakers for more than 10 years; and

WHEREAS Dr. Hartwell Francis keeps all material that he has researched and assembled accessible to any EBCI program or member; and,

WHEREAS and, Dr. Hartwell Francis has shown great promise as a Cherokee Language learner; and,

WHEREAS, and, Dr. Francis has spent time respectfully learning the customs, traditions, and history of the Eastern band of the Cherokee, and has been a part of the community; and,

WHEREAS it was discussed and agreed upon by the Cherokee Speaker Council that Dr. Hartwell Francis has earned a special place next to the CSC for his efforts in helping all the EBCI save the language; and,

WHEREAS, The Cherokee Speakers Council has conferred and agreed unanimously with quorum present on May 27th, 2021 that Dr. Hartwell Francis shall be regarded as honorary member of the Eastern Band of the Cherokee.

BE IT FURTHER RESOLVED, Tribal Council of the EBCI shall recognize Dr. Hartwell Francis as an honorary member of the Eastern Band of the Cherokee Indians this day September 7th, 2021.


