The Office of Internal Audit and Ethics (OIAE) conducted a follow up review on the Transit audit report 23-006, dated March 20, 2023.

This follow-up review determines the status of the observations and recommendations. There were 3 issues reported with recommendations made. The status is reported by management with one of the following categories:

- **Implemented** adequately addressed by implementing corrective action that is in place and functioning
- Partially Implemented initiated with 50% or more progress
- Started initiated with less that 50% progress
- Not Implemented no action taken or started
- Withdrawn no longer exist because of changes in processes or the risk is accepted by management and approved by the Audit and Ethics Committee

Limited audit work was performed on select findings to verify management's assertion. If it could not be verified, the status was adjusted accordingly. A summary of the reported status of the 3 recommendations is as follows: **3 (100%) Implemented.** The details of this follow up review can be found in the attached audit report summary.

## Background and Scope:

EBCI Transit's purpose is to provide safe and dependable transportation at a reasonable cost to the residents and visitors of the Qualla Boundary and Snowbird. Public transit, which consists of two downtown routes, operates 18 hours per day, 5 days per week, with pickups scheduled every half an hour. Transit's Mobility service provides Non-Emergency Medical Transportation to area residents, including free transportation for the elderly and disabled who do not qualify for other assistance programs. This assists individuals with transportation to medical, health and human service appointments, and other essential activities in Cherokee and Snowbird. The overall objective of this audit was to obtain an understanding of key processes within the entity, to evaluate the adequacy of internal controls and to identify opportunities for process improvements.

## **Overall Conclusions:**

Transit's internal controls need improvement.
