RESOLUTION NO. 173 (2024)

A resolution to exclude Robert Earl Hutchinson from the lands of the Eastern Band of Cherokee Indians.

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band in order to protect the integrity, law and order of the lands, and the welfare of Tribal members; and WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and WHEREAS, ROBERT EARL HUTCHINSON (Date of Birth: 04/23/1965) is not a member of the EBCI or any other federally recognized Indian Tribe; and
- WHEREAS, on March 4, 2024, Cherokee Indian Police Department ("CIPD") officers were involved in a traffic stop at 6800 Wolftown Road, on the Qualla Boundary; and
- WHEREAS, during the investigation of the traffic stop on Wolftown Road, CIPD officers found alleged controlled substances on or near in proximity to ROBERT EARL HUTCHINSON, including 4.5 grams of fentanyl and 1.5 grams of methamphetamine; and
- WHEREAS, since 2021, ROBERT EARL HUTCHINSON has more than 22 involvements with the CIPD, most of which are citizens accusing HUTCHINSON of crimes; and
- WHEREAS, due to the nature of the alleged actions of ROBERT EARL HUTCHINSON,
 Tribal Council has good reason to believe that he is a threat to the integrity, law
 and order of EBCI lands, and the welfare of the members of the Tribe; and
- NOW THEREFORE, BE IT RESOLVED by Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, ROBERT EARL HUTCHINSON is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

BE IT FURTHER RESOLVED that this permanent exclusion prohibits ROBERT EARL

HUTCHINSON from entering or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.

- BE IT FURTHER RESOLVED that if ROBERT EARL HUTCHINSON is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
