We conducted a follow up review on the Cherokee Bottled Water audit report 24-005, dated April 5, 2024.

The purpose of this follow-up review is to determine the status of the findings and recommendations. There were 4 observations reported with recommendations made. The status is reported by management with one of the following categories:

- Implemented adequately addressed by implementing corrective action that is in place and functioning
- Partially Implemented initiated with 50% or more progress
- **Started** initiated with less than 50% progress
- Not Implemented no action taken or started
- **Withdrawn** no longer exist because of changes in processes or the risk is accepted by management and approved by the Audit and Ethics Committee

Limited audit work was performed on select findings to verify management's assertion. If it could not be verified, the status was adjusted accordingly. A summary of the reported status of the 4 recommendations is as follows: **2 (50%) Partially Implemented and 2 (50%) Started**. The details of this follow up review can be found in the attached audit report summary.

## **Background and Scope:**

Cherokee Bottled Water sells and delivers bottled water to Tribal programs, the community, and businesses. The program procures bottled water with the Cherokee Bottled Water label from a bottler. The water is then delivered to the program's warehouse for distribution or dropped shipped. Located in the Division of Commerce as part of Economic Development, the program has three employees. With two salespersons and one crew leader they provide services to more than 800 customers across the Qualla Boundary and eight western counties.

The scope of the audit included a review of the financial and operational information for the period of 10/1/22-1/31/24.

## **Overall Conclusions:**

There are opportunities for improvement in Cherokee Bottled Water's internal controls.
