RESOLUTION NO. 351 (2024)

A resolution to exclude Maximilian William Peterson from the lands of the Eastern Band of Cherokee Indians.

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band to protect the integrity, law and order of the lands, and the welfare of Tribal members; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and
- WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and
- WHEREAS, MAXIMILIAN WILLIAM PETERSON (Date of Birth: 09/19/2024) is not a member of the Eastern Band of Cherokee Indians, but is said to be residing in and around the Qualla Boundary; and
- WHEREAS, on September 19, 2024, CIPD officers responded to 145 Owle Drive on the Qualla Boundary, where MAXIMILIAN WILLIAM PETERSON assaulted Brian David Owle in his own home, by shooting Owle with rubber bullets; and
- WHEREAS, during the investigation, it was found that MAXIMILIAN WILLIAM PETERSON had also stolen property of others who were in the house with Owle; and
- WHEREAS, when CIPD executed a search warrant for the residence of MAXIMILIAN WILLIAM PETERSON they found the firearm used in the assault on Mr. Owle as well as 137 grams of methamphetamine; and
- WHEREAS, MAXIMILIAN WILLIAM PETERSON was charged in North Carolina state court for trafficking in methamphetamine. PETERSON also has an extensive criminal history and history from all over the United States; and
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, MAXIMILIAN WILLIAM PETERSON is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

- BE IT FURTHER RESOLVED that this permanent exclusion prohibits

 MAXIMILIAN WILLIAM PETERSON from entering or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if MAXIMILIAN WILLIAM PETERSON is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
