RESOLUTION NO. 352 (2024)

A resolution to exclude Anayeli Vargus-Duran from the lands of the Eastern Band of Cherokee Indians.

- WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band to protect the integrity, law and order of the lands, and the welfare of Tribal members; and
- WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and
- WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and
- WHEREAS, ANAYELI VARGUS-DURAN (Date of Birth: 07/11/1994) is not a member of the Eastern Band of Cherokee Indians, but is residing at 31 Enoch Sampson-Rd. within the Qualla Boundary, with, among others, minor child H.H. (DOB 10/23/2017); and
- WHEREAS, Cherokee Indian Police Detective Ashley Cromer had received numerous family safety reports concerning minor child H.H. and Detective Cromer began an investigation on 2/6/2024; and
- WHEREAS, after the investigation began, Detective Cromer discovered numerous alarming facts associated with how ANAYELI VARGUS-DURAN and other household members would maltreat H.H.; and
- WHEREAS, this maltreatment was corroborated by examinations and interviews by medical personnel; and
- WHEREAS, a more detailed recitation of the facts will be provided by testimony and supporting documentation; and
- NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, ANAYELI VARGUS-DURAN is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

- BE IT FURTHER RESOLVED that this permanent exclusion prohibits

 ANAYELI VARGUS-DURAN from entering or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
- BE IT FURTHER RESOLVED that if ANAYELI VARGUS-DURAN is found improperly on Tribal lands at any time after the effective date of this resolution, he shall be treated as a trespasser and appropriate legal action shall be taken against him.
- BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
