2 CHEROKEE COUNCIL HOUSE 3 CHEROKEE, QUALLA BOUNDARY, NC 4 DEC 0 5 2024 Date: 5 6 RESOLUTION NO. 367 (2024) 7 8 9 A resolution to exclude Donald Jesse Cogdill from the lands of the 10 Eastern Band of Cherokee Indians. 11 WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign 12 authority to exclude persons from lands of the Eastern Band to protect the 13 integrity, law and order of the lands, and the welfare of Tribal members; and 14 15 WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of 16 the Eastern Band at Chapter 2 of the Cherokee Code; and 17 18 WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is 19 indispensable to the Tribe's autonomy and self-governance; and 20 WHEREAS, DONALD JESSE COGDILL (Date of Birth: 01/09/1988) is not a member of the 21 Eastern Band of Cherokee Indians, but is said to be residing in and around the 22 23 Qualla Boundary; and On October 13,2024, officers of the Cherokee Indian Police Department were WHEREAS, 24 dispatched to 930 paint town road, where they found DONLAD COGDILL 25 unconscious and slumped over in the driver's seat of a car; and 26 WHEREAS, officers were able to roust COGDILL by knocking on the window of the car. 27 However, when he woke, COGDILL jumped and accelerated his car into a CIPD 28 29 patrol car; and WHEREAS, COGDILL admitted that his intoxication was due to "Fentanyl"; and 30 WHEREAS, COGDILL has a lengthy criminal history that includes multiple drug charges, 31 assault with a deadly weapon charge, multiple larceny charges, multiple breaking 32 and entering charges, and is a convicted habitual felon with gang affiliation with 33 34 Folk Nation. 35 NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled 36 with a quorum present, and with the number of votes required by Tribal law, 37 DONALD JESSE COGDILL is hereby PERMANENTLY EXCLUDED from all 38 Tribal lands and is hereby notified and ordered to vacate all tribal lands. 39 40

41	BE IT FURTHER RESOLVED that this permanent exclusion prohibits
42	DONALD JESSE COGDILL from entering or being present on Tribal
43	lands for any purpose except as required by Tribal Council or Tribal Court.

46	is found improperly on Tribal lands at any time after the effective date of this
47	resolution, he shall be treated as a trespasser and appropriate legal action shall be

51	and that this resolution shall become effective when ratified by the Principal
52	Chief.
