34	NOW THERE	FORE, BE IT RESOLVED by the Tribal Council, in Council assembled							
35		with a quorum present, and with the number of votes required by Tribal law,							
36		EXCLUDED from all Tribal lands and is hereby PERMANENTLY

44	BE IT FURTHER RESOLVED that if WILLIAM HOWARD SMALLWOOD is found				
45	improperly on Tribal lands at any time after the effective date of this resolution,				
46	he shall be treated as a trespasser and appropriate legal action shall be taken				
47	against him.

49	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,				
50	and that this resolution shall become effective when ratified by the Principal				
51	Chief.
