12 13 14 15	WHEREAS,	the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign authority to exclude persons from lands of the Eastern Band to protect the integrity, law and order of the lands, and the welfare of Tribal members; and			
16 17	WHEREAS,	the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and			
18 19 20	WHEREAS,	the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and			
21 22 23	WHEREAS,	ALAN NATHANIEL RHINEHART (Date of Birth: 08/03/1978) is not a member of the Eastern Band of Cherokee Indians, but is said to be residing in and around the Qualla Boundary; and			
24 25 26	WHEREAS,	RHINEHART has a lengthy criminal history that includes multiple drug charges, larceny charges, breaking and entering charges, assault charges, and is a convicted felon; and			
27 28 29 30	WHEREAS,	RHINEHART also has an extensive driving history record as well which includes, but not limited to driving while license revoked, fictitious information to officers, reckless driving, possession/display fictitious license plate, no operator's license, cancelled/revoked license plate, and speeding; and			
31 32 33 34	WHEREAS,	Cherokee Indian Police Department have encountered RHINEHART on numerous occasions, including observing RHINEHART frequenting known drug houses, and transporting enrolled members from known drug houses to other known drug houses; and			
35 36 37 38	WHEREAS,	RHINEHART has no business whatsoever in Cherokee and has no reason to constantly be on our Boundary contributing to the drug epidemic we are currently battling.			
39 40 41 42	NOW THERE	EFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, ALAN NATHANIEL RHINEHART is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.

44	BE IT FURTHER RESOLVED that this permanent exclusion prohibits
45	ALAN NATHANIEL RHINEHART from entering or being present on Tribal
46	lands for any purpose except as required by Tribal Council or Tribal Court.

48	BE IT FURTHER RESOLVED that if ALAN NATHANIEL RHINEHART is found improperly
49	on Tribal lands at any time after the effective date of this resolution, he shall be
50	treated as a trespasser and appropriate legal action shall be taken against him.

52	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,
53	and that this resolution shall become effective when ratified by the Principal
54	Chief.
