12 13 14 15	WHEREAS,	the Eastern Band of Cherokee Indians ("EBCI" or " _{Tribe} ") has the sovereign authority to exclude persons from lands of the Eastern Band to protect the integrity, law and order of the lands, and the welfare of Tribal members; and
16 17	WHEREAS,	the Tribal Council has codified its authority to exclude persons from the lands of the Eastern Band at Chapter 2 of the Cherokee Code; and
18 19 20	WHEREAS,	the power to exclude is an inherent and essential part of Tribal sovereignty that is indispensable to the Tribe's autonomy and self-governance; and
21 22 23	WHEREAS,	JERRY ODELL PERRY JR. (Date of Birth: 08/17/1969) is not a member of the Eastern Band of Cherokee Indians, but is said to be residing in and around the Qualla Boundary; and
24 25 26	WHEREAS,	on November 21, 2024, PERRY was arrested by Cherokee Indian Police department for Trafficking in fentanyl, Possession of Methamphetamine, Possession of Cocaine, and Possession of a firearm by convicted felon; and
27 28	WHEREAS,	PERRY has a lengthy criminal history that spans numerous states. He has been convicted of numerous felonies, including armed robbery; and
29 30 31 32 33	NOW THERI	EFORE, BE IT RESOLVED by the Tribal Council, in Council assembled with a quorum present, and with the number of votes required by Tribal law, JERRY ODELL PERRY JR is hereby PERMANENTLY EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all tribal lands.
34 35 36 37	BE IT FURT	HER RESOLVED that this permanent exclusion prohibits JERRY ODELL PERRY JR from entering or being present on Tribal lands for any purpose except as required by Tribal Council or Tribal Court.
