1 CHEROKEE COUNCIL HOUSE 2 CHEROKEE, QUALLA BOUNDARY, NC 3 4 SEP 0 4 2025 Date: 5 6 RESOLUTION NO. <u>578</u> (2025) 7 8 A resolution to exclude Christopher Dale Treadwell from the lands of the 9 Eastern Band of Cherokee Indians. 10 11 the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign 12 WHEREAS. authority to exclude persons from lands of the Eastern Band to protect the 13 integrity, law and order of the lands, and the welfare of Tribal members; and 14 15 the Tribal Council has codified its authority to exclude persons from the lands of WHEREAS, 16 the Eastern Band at Chapter 2 of the Cherokee Code; and 17 18 the power to exclude is an inherent and essential part of Tribal sovereignty that is 19 WHEREAS, indispensable to the Tribe's autonomy and self-governance; and 20 21 CHRISTOPHER TREADWELL (Date of Birth: 08/17/1988) is not a member of 22 WHEREAS, the Eastern Band of Cherokee Indians, but is said to be residing in and around the 23 Oualla Boundary; and 24 25 on July 7, 2025, CIPD officers responded to 777 Casino Drive on the Qualla 26 WHEREAS, Boundary, where CHRISTOPHER TREADWELL was seen with another known 27 drug trafficker; and 28 29 during the investigation, CIPD found that CHRISTOPHER TREADWELL was in WHEREAS, 30 possession of a trafficking amount of fentanyl (11.5 grams); and 31 32 WHEREAS, CHRISTOPHER TREADWELL was charged with Felony Possession of 33 Controlled Substance; Possession with the Intent to, Sell, or Deliver a Controlled 34 Substance: Trafficking in Fentanyl, and Transporting controlled substance into the 35 36 territory of the EBCI; and 37 WHEREAS, TREDWELL has previously been convicted of Distribution of Methamphetamine 38 as well as Trafficking in Ice/Crank/Crack. 39 40 NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled 41 with a quorum present, and with the number of votes required by Tribal law, 42 CHRISTOPHER DALE TREADWELL is hereby PERMANENTLY 43 EXCLUDED from all Tribal lands and is hereby notified and ordered to vacate all 44 tribal lands. 45 46

1	BE IT FURTHER RESOLVED that this permanent exclusion prohibits			
2	CHRISTOPHER DALE TREADWELL from entering or being present on Tribal			
3	lands for any purpose except as required by Tribal Council or Tribal Court.

5	BE IT FURTHER RESOLVED that if CHRISTOPHER DALE TREADWELL is found			
6	improperly on Tribal lands at any time after the effective date of this resolution,			
7	he shall be treated as a trespasser and appropriate legal action shall be taken			
8	against him.			
9				
10	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,			
11	and that this resolution shall become effective when ratified by the Principal			
12	Chief.
