9	A resolution to exclude Caleb Jage Eggen from the lands of the					
10 11	Eastern Band of Cherokee Indians.					
12	WHEREAS,	the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign				
13	WILLIED,	authority to exclude persons from lands of the Eastern Band to protect the				
14		integrity, law and order of the lands, and the welfare of Tribal members; and				
15		,				
16	WHEREAS,	the Tribal Council has codified its authority to exclude persons from the lands of				
17		the Eastern Band at Chapter 2 of the Cherokee Code; and				
18						
19	WHEREAS,	the power to exclude is an inherent and essential part of Tribal sovereignty that is				
20 21		indispensable to the Tribe's autonomy and self-governance; and				
22	WHEREAS,	CALEB EGGEN (Date of Birth: 07/02/2002) is not a member of the Eastern				
23	WILLIAM 10,	Band of Cherokee Indians, but is said to be residing in and around the Qualla				
24		Boundary; and

26	WHEREAS,	on July 3, 2025, CIPD officers responded to 777 Casino Drive on the Qualla				
27		Boundary, where CALEB EGGEN was seen with another known drug trafficker;				
28		and				
29 30	WHEREAS,	during the investigation, CIPD found that CALEB EGGEN was in possession of a				
31	WILKEAS,	trafficking amount of fentanyl (45.5 grams); and				
32		trafforming unlocate of formally? (15.5 grains), and				
33	WHEREAS,	CALEB EGGEN was charged in Cherokee Tribal Court with Possession of				
34	•	Controlled Substance; Possession with the Intent to Manufacture, Sell, or Deliver				
35		a Controlled Substance; and Drug Trafficking; and

37	WHEREAS,	EGGEN's Tribal criminal history includes: tampering with a witness, escape from				
38		custody/imprisonment, failure to obey a lawful order of the court, resist lawful				
39 40		arrest, interfering with emergency communications, Child abuse in the second degree, possession of drug paraphernalia and multiple probation revocations.				
41		degree, possession of drug paraphernana and muniple probation revocations.				
42	NOW THERE	EFORE, BE IT RESOLVED by the Tribal Council, in Council assembled				
43		with a quorum present, and with the number of votes required by Tribal law,				
44		CALEB JAGE EGGEN is hereby PERMANENTLY EXCLUDED from all Tribal				
45		lands and is hereby notified and ordered to vacate all tribal lands.

1	BE IT FURTHER RESOLVED that this permanent exclusion prohibits
2	CALEB JAGE EGGEN from entering or being present on Tribal lands for any
3	purpose except as required by Tribal Council or Tribal Court.
4	
5	BE IT FURTHER RESOLVED that if CALEB EGGEN is found improperly on Tribal lands at
6	any time after the effective date of this resolution, he shall be treated as a
7	trespasser and appropriate legal action shall be taken against him.
8	
9	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,
10	and that this resolution shall become effective when ratified by the Principal
11	Chief.
