41		with a quorum present, and with the number of votes required by Tribal law,			
42		GARY LEE MACMAHAN is hereby PERMANENTLY EXCLUDED from all			
43		Tribal lands and is hereby notified and ordered to vacate all tribal lands.			
44	BE IT FURTH	ER RESOLVED that this permanent exclusion prohibits			
45		GARY LEE MACMAHAN from entering or being present on Tribal lands for			
46		any purpose except as required by Tribal Council or Tribal Court.			
47		The symmetry of the Court.			

1	BE IT FURTHER RESOLVED that if GARY LEE MACMAHAN
2	is found improperly on Tribal lands at any time after the effective date of this
3	resolution, he shall be treated as a trespasser and appropriate legal action shall be
4	taken against him.
5	
6	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,
7	and that this resolution shall become effective when ratified by the Principal
8	Chief.
