7		with a quorum present, that subject to the outcome of the hearing IONATHAN

11	BE IT FURTH	HER RESOLVED that, subject to the outcome of the hearing, the permanent
12 13		exclusion shall prohibit JONATHAN ("JOHNNY") FREDERICK from entering
14		on or being present on Tribal lands for any purpose except as required by Tribal
15		Council or as allowed pursuant to Tribal Court order.
16	BE IT FURTE	HER RESOLVED that, subject to the outcome of the hearing, if JONATHAN
17		("JOHNNY") FREDERICK is found to be improperly on Tribal lands at any time
18		after the effective date of this resolution he shall be treated as a trespasser and
19		appropriate legal action shall be taken against him.

21	BE IT FINAL	LY RESOLVED that all resolutions inconsistent with this resolution are rescinded
2 2		and that this resolution shall become effective when ratified by the Principal
