19	WHEREAS,	to promote economic development, Tribal self-sufficiency and Tribal self-		
20	WILLIAM,	determination, the Tribal Council has previously authorized the establishment of		
21		two tribally-owned casinos offering Class III gaming activities as defined by the		
22		Indian Gaming Regulatory Act of 1988 ("IGRA")

24	WHEREAS,	the original casino gaming facility opened in November, 1977, is known as Harrah's		
25		Cherokee Casino Resort, and is located at 777 Casino Drive, Cherokee, North		
26		Carolina; the second facility opened in September, 2015, is known as Harrah's		
27		Cherokee Valley River Casino & Hotel, and is located at 777 Casino Parkway,		
28		Murphy, North Carolina; and

30	WHEREAS,	the Tribe conducts its casino gaming activities at both locations with the help of		
31		Harrah's NC Casino Company, LLC ("Harrah's"), a North Carolina limited liability		
32		company, which is an independent contractor to the Tribe and serves as manager of		
33		the Tribe's facilities. and		
34 35	WHEDEAS	the contractual relationship between the Tribe and Harrah's is currently governed		
36	WHEREAS,	by, and both entities are parties to, the Second Amended and Restated Management		
37		Agreement which is referred to herein as the "Existing Management Agreement";

40	WHEREAS,	on January 9, 2025, proposed changes to the Existing Management Agreement		
41	,	entitled "Third Amended and Restated Management Agreement" were presented to		
42		Tribal Council in Resolution No. 375 (2025), which was deemed read		
43		and tabled for a work session and a substantive discussion at a later date; and

1 2 3 4	WHEREAS,	the existing Management Agreement was set to expire on May 29, 2025 and the Third Amended and Restated Management Agreement had been submitted to the NIGC for approval, but the approval had not been received; and
5 6 7 8 9	WHEREAS,	to ensure compliance with the IGRA, the Tribe and the Manager executed a Second Amendment to the Second Amended and Restated Management Agreement extending the expiration date of the Second Amended and Restated Management Agreement until November 29, 2025 which extension was approved by the NIGC; and
11 12 13	WHEREAS,	as of this date the NIGC still has not approved the Third Amended and Restated Management Agreement
14 15 16 17	WHEREAS,	the Tribe and the Manager desire to extend the term of the Second Amended and Restated Management Agreement for an additional six months from November 29, 2025 until May 29, 2026 to allow for the granting of approval by the NIGC of the Third Amended and Restated Management Agreement; and
18 19 20 21 22 23 24	WHEREAS,	Tribal Council has reviewed the proposed extension expressed in the attached Third Amendment to the Second Amended and Restated Management Agreement and has determined that it is in the Tribe's best interest to approve the extension, for the Principal Chief to sign it on behalf of the Tribe, and that it be submitted to the NIGC for approval.

THIRD AMENDMENT TO SECOND AMENDED AND RESTATED MANAGEMENT AGREEMENT

BETWEEN THE EASTERN BAND OF CHEROKEE INDIANS AND HARRAH'S NC CASINO COMPANY, L.L.C.

This instrument shall be known as the "Third Amendment to the Second Amended and Restated Management Agreement" (this "Amendment") dated as of October ___, 2025. This Amendment amends the Second Amended and Restated Management Agreement entered into as of March 2018, as amended by the First Amendment to Second Amended and Restated Management Agreement, entered into as of February 9, 2024, and as further amended by the Second Amendment to Second Amended and Restated Management Agreement, entered into as of February 12, 2025 (as so amended, the "Management Agreement"), by and between the Eastern Band of Cherokee Indians, a federally recognized Indian Tribe (the "Tribe"), and HARRAH'S NC CASINO COMPANY, L.L.C., a North Carolina limited liability company (the "Manager").

WHEREAS, the Management Agreement is currently set to expire on November 29, 2025; and

WHEREAS, the Tribe and the Manager executed a Third Amended and Restated Management Agreement to replace the Management Agreement (the "Third A&R Management Agreement"), which was submitted to the Chair of the NIGC for approval thereof, but such approval is still pending; and

WHEREAS, the Tribe and the Manager desire to extend the term of the Management Agreement for up to six additional months in order to keep it in effect until the Third A&R Management Agreement is approved by the Chair of the NIGC.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby enter this Amendment as provided below. All terms used in this Amendment and not otherwise defined in this Amendment shall have the meanings set forth in the Management Agreement.

1. Amendments

- 1.1 Section 3.2 of the Management Agreement is amended in restated in its entirety as follows:
 - "3.2 <u>Term</u>. The term of this Agreement began on the Effective Date, which was March 29, 2018, and shall continue until the earlier of (a) May 29, 2026, or (b) the effective date of the approval of the Third A&R Management Agreement by the Chair of the NIGC (the "<u>Term</u>").
- 1.2 The parties acknowledge and agree that this Amendment shall not become effective until it has been approved by the Chair of the NIGC. Except as modified herein, all of the terms of the Management Agreement shall remain in full force and effect.
